1	WHEREAS, the 2017 Human Trafficking Task Force report noted that "[h]uman
2	trafficking is a complex global crime affecting nearly every developed and developing country in
3	the world. It involves the exploitation of people for monetary or personal profit, and occurs in a
4	range of both legal and illegal industries, including hospitality services, brothels, agriculture, street
5	prostitution, construction, strip clubs, domestic services, manufacturing, spas, and escort services.
6	At its core, human trafficking is about abuse and cruelty toward human beings, and is a gross
7	violation of human rights"; and

9	WHEREAS, the Human Trafficking Task Force further noted that that "[h]uman
10	trafficking crimes have devastating impacts on vulnerable individuals, families, and communities;
11	and Howard County is not immune"; and
12	
13	WHEREAS, while there have been significant arrests and prosecutions of offenders of
14	human trafficking laws, the County Executive contends that human trafficking remains a basic
15	human rights violation; and

On behalf of the Department of Community Resources and Services (DCRS), I am pleased to submit testimony regarding CB52-2019 An ACT to Establish a Human Trafficking Prevention Coordination Council.

In 2014 Howard County commissioned the first Howard County Human Trafficking Task Force. The members of that Task Force concluded that there was a strong basis to recommend the following: increased services to victims; human trafficking awareness education for everyone in our community; and additional coordination between and among our various partnering agencies and community-based organizations.

In 2017 the Office of Human Trafficking Prevention was created within the Department of Community Resources and Services (DCRS) and an Executive Order establishing the Howard County Human Trafficking Prevention Coordinating Council was implemented. The Executive Order required the Council to conduct the following activities: Review and prioritize the recommendations of the Human Trafficking Task Force Report of 2014, and advise the County Executive on effective methods and organizational structure to permanently coordinate and sustain human trafficking prevention efforts in the County. The Coordinating Council began meeting in FY18 (mid 2017) focused on these tasks.

The Council met eight times; and held a survivor-focused, County-wide Human Trafficking Awareness and Prevention Conference on October 26, 2018. Three focus groups were held with HTPCC Members and designees, on December 11, 18, and 19, 2018. A follow-up questionnaire was sent to this group on January 24, 2019. The information shared during all the Coordinating Committee's activities informed the recommendation to establish a permanent council as described in CB52-2019.

The proposed legislation before you: 1) maintains the current categories of membership from both the 2014 and 2017 Human Trafficking Prevention bodies; 2) expands membership to include the business community, the hospital, and the number of seats for survivors and community members; and 3) specifically defines the scope and duties of the council.

The creation of a permanent Human Trafficking Prevention Council will enhance our ability as a community to effectively combat the problem of human trafficking in Howard County. We ask for your support for this legislation. Thank you.

<u>Testimony in favor of Council Bill 52-2019: the creation of a permanent Human Trafficking Prevention</u> <u>Coordinating Council</u>

Esteemed Howard County Council Members,

I am Sara Cochran, one of the founders of Ho Co AGAST (Advocacy Group Against Slavery & Trafficking), an all-volunteer, citizen-led group, founded in 2011 when 3 faith communities presented Howard County's 1st public forum "Slavery Still Exists" to bring awareness to the crime of human trafficking.

<u>Definition</u>: Human trafficking is a form of modern-day slavery in which a trafficker uses force (violence), fraud (lies) or coercion (threats) to control a victim for the purpose of engaging him/her in commercial sex acts or labor services against his/her will. <u>Sex trafficking</u> is found in a variety of venues within the sex industry including residential brothels, escort services, fake massage businesses, nail salons, strip clubs, and street prostitution. <u>Labor trafficking</u> is found in diverse labor settings including domestic work, small businesses, restaurants, landscaping, construction, factories. To learn more about HT in the US, visit www.polarisproject.org, the organization that runs the National Human Trafficking Resource Center and Hotline.

AGAST's goals are to educate our community about human trafficking in the US, Maryland, and Howard County; to work for stronger laws to combat it; and to support victim and survivor providers. The attached "Ho Co AGAST in Action" info outlines some of our activities over the past 8 years.

A "Human Trafficking 101" presentation which AGAST gave to the County Council in December, 2013, resulted in the formation of Ho Co's first Human Trafficking Task Force. The Task Force met 12 times in 2014 and presented to the County Council in December, 2014, a thorough report with many recommendations to fulfill 4 main goals, all of which remain in Section 12.1902 of CB52-2019. Unfortunately, because 2014 was an election year (new administration, new appointees, etc.), between January, 2015 and March, 2017 (27 months), work on these excellent recommendations waned. To be fair, the former Task Force members were called together for a couple of meetings, a few awareness presentations were given in western Howard County and a program to recognize National HT Awareness Day was held at Miller Library during these 27 months.

Make no mistake. The sex traffickers do not take such a break in their illicit 24/7 recruitment and lucrative sale of victims. Ask the officers of the Human Trafficking Unit of HCPD. They need several more detectives to keep up with the traffickers who find Howard County a profitable place to do business because of the buyers' high demand for their "product."

Then, in March, 2017, County Executive Kittleman announced: "Human trafficking is a despicable crime which we have been working day and night to eradicate. So, earlier today, I signed an executive order creating a <u>Human Trafficking Prevention Coordinating Council</u>, a group which will help us to determine how to further fight this heinous crime. The council will review and prioritize the recommendations of a task force report, establish partnerships that will support victims of human trafficking and coordinate and sustain prevention and education efforts in the county. Last year, county police conducted 25 human trafficking investigations which resulted in 10 arrests and help for 25 victims. We are

making progress, but we have much more work to do. The work of this council will have my full attention as we continue the fight against human trafficking."

In addition, we learned that the Department of Community Resources and Services now included an Office of Human Trafficking Prevention (OHTP). From December, 2017 to December, 2018, The Human Trafficking Prevention Coordinating Council (HTPCC) met regularly under the superb leadership of Sidney Ford. Once again, for 12 months, as we had done in 2014, anti-trafficking advocates learned from one another and established new working relationships, all in the shared interest of combating this brutal crime that treats human beings as commodities to be used then tossed aside when no longer profitable.

Alas, with the 2018 election year (new administration, new appointees, etc.), the HTPCC has been dissolved, our collaborative momentum has been interrupted for 10 months, since December, 2018. As I am sure you will agree, this on-again, off-again approach, this lack of continuity impedes the effective long-term, forward-thinking planning of any program worthy of implementation. It is most grievous and unacceptable when we are discussing Howard County's fight against human trafficking, an egregious crime of exploitation that robs victims of their human dignity. I respectfully request that you establish a permanent Howard County Human Trafficking Prevention Coordinating Council.

As a member of the previous and now defunct Human Trafficking Prevention Coordination Council I write in support of CB52-2019 and urge its passage. I believe the County Council has already been provided the data showing just how important and necessary the actions of this group are for our community. In my three years of working on the issue of preventing and combatting human trafficking, I've come to understand that one of our biggest challenges is ignorance.
