### Joshua Kaufman

### Summary

A dynamic leader, innovative thinker and a proven consensus builder, Joshua Kaufman has over 20 years of experience supporting human rights, democracy and good governance around the world. Mr. Kaufman is currently a member of the United States Agency for International Development's (USAID) Senior Leadership Group and was one of the creators of the U.S. Global Development Lab (https://www.usaid.gov/GlobalDevLab/about) – USAID's hub for science, technology, innovation and private sector engagement. The Lab's portfolio includes several high-profile programs at the intersection of technology and human rights, such as the Alliance for Affordable Internet and the Making All Voices Count Grand Challenge for Development. Previously, Mr. Kaufman was the Director for Global and Regional Policy at USAID's Center for Democracy, Human Rights and Governance and led an Agencywide effort to create USAID's first global Democracy, Human Rights and Governance Strategy (https://www.usaid.gov/sites/default/files/documents/1866/USAID-DRG fina- 6-24-31.pdf), which was published in 2013. This strategy established human rights as an Agency-wide objective in the world's largest bilateral foreign assistance agency. Mr. Kaufman has a long track record of the creation of innovative policies, tools and approaches that have been adopted throughout USAID. He frequently represents the Agency with key high-level stakeholders in civil society, government and the private sector.

Lead an award-winning Office of highly skilled professionals that provide the evidence base to support the Agency's investments in technology, innovation and private sector engagement. Working to "hack the bureaucracy", by the development and Agency-wide application of new and innovative approaches to monitoring, evaluation, research and learning that utilize big data, machine learning, satellite imagery and other new tools. The Office is divided into three teams: Innovation, Learning, and Technical Assistance.

- Provided executive oversight for the creation of the Lab's first strategic plan and results framework for science, technology, innovation and private sector engagement.

Duties, Responsibilities and Accomplishments:

- One of two Agency representatives to the International Development Innovation Alliance, an

   including the World Bank, DFID, SIDA, Global Affairs Canada, UNDP, Rockefeller and the Gates'
   Foundation. I served as the co-chair of IDIA's Measuring Impact Working Group and was a
   drafter of the group's report that captures best practice across multiple donors and foundations.
- I am an active participant and contributor to professional and academic fora. I have lectured at a graduate-level program evaluation course at SAIS, lectured on development impact at the University of Michigan's Business School, served on the President of the American Evaluation Association's personal panel and have participated in other similar event representing USAID's evaluation expertise alongside senior counterparts from other aid agencies.
- Oversaw the creation and approval of the Lab's first five-year strategic plan and results framework. This framework includes dozens of indicators at the Objective, Intermediate Result and Sub-Intermediate Result level, each with a baseline and annual targets going out five years.
- I currently exercise technical and administrative supervision over both the Office of Evaluation and Impact Assessment and the Center for Agency Integration. These two units are currently made up of approximately 25 development professionals of diverse backgrounds, levels of seniority and technical expertise. I supervise supervisors and teams leads in this role. I manage the budget, including overseeing congressional budget justifications and reports, OMB requests, and the development and implementation of annual procurement plans.
- Worked closely with the Lab's Executive Director and Senior Leadership Team to establish an Evaluation, Research and Learning (ERL) Strategy designed to ensure that the Lab is developing and utilizing high-quality data and evidence. This strategy established new organization-wide processes to formally build in the use of evaluative data into Lab decision-making at the program and strategy level.
- The primary purpose of the Lab's ERL Strategy is the capture, reporting, and analysis of performance data and learning to improve the operational and programmatic effectiveness of the Lab and our Agency partners. The ERL Strategy includes a novel implementation plan revolving around semiannual Strategic Learning Reviews that are directly linked to existing Lab decision-points around strategy, operations, personnel, budget and programs. The ERL strategy examines the programs of each of the Lab's five centers and has an additional focus on five organization-wide priority questions looking issues such as sustainability, scale, cost effectiveness, adaptive programing and the support we provide to innovators, researchers and entrepreneurs.

## Deputy Director, Office of Innovation and Development Alliances 03/2012 – 02/2014

Served as the Deputy Director for Operations, for the Office of Innovation and Development Alliances (IDEA), USAID's first ever stand-alone innovation hub. IDEA was made up of teams of development

I supervised IDEA's division chiefs in this role, and therefore provided quality control and technical direction for the entire office.

Greeting Chairperson and Members of the Howard County Council. I want to thank you this evening for considering my nomination to be a member of the Howard County Human Rights Commission. I also want to thank County Executive Calvin Ball for his confidence in my ability to serve the citizens of Howard County.

My name is Josh Kaufman. I have been a resident of Howard County since 1995, having lived in Harpers Choice, Long Reach and since 2005, in Elkridge. From the day I moved here, it was clear that Howard County has a well-earned reputation as a community that values diversity and seeks to support the rights of every individual that lives, studies or works here. Rather than a fortunate accident, this has been the result of a deliberate effort on the part of the County Government and the wider community for decades. However, events here the County over the last few years have shown that there is more work to be done, and that we are far from immune from the disturbing human rights abuses that are occurring across the country.

I am very excited about this opportunity as it combines two of my great passions – advancing human rights and inclusion, and serving my community. I am currently a senior manager at the United States Agency for International Development. For most of my 23-year career, I served as a Democracy, Human Rights and Governance Officer. In that capacity, I was privileged to have served the American people by advancing human rights overseas, including by providing support to human rights commissions. I was also one of the principle authors of USAID's current Human Rights Strategy. As a senior manager in the Federal Government, I am also a strong champion for inclusive hiring and professional development, and I am very familiar with relevant federal regulations related to EEOC and similar issues, all of which have county equivalents.

I am also someone who cares deeply about my community and the idea of helping to make Howard County a better place for all, especially for those that are marginalized or otherwise at risk of not being allowed to live up to their full potential due to their gender, race, ethnicity, national origin, age, religion or sexual identity. I have ample experience serving on multiple Howard County Government boards and commissions, such as the Ethics Commission, the Recreation and Parks Advisory Board, the Spending Affordability Committee and the County Council's School Budget Committee. I am also a past Member and Chair of the Howard County Board of Education, where I was a leading voice for the rights of our students and staff. For example, I led a successful effort to make health insurance and other familial benefits available to same sex domestic partners of our employees years before the legalization of same sex marriage in Maryland. I was also helped lead an effort to reform the school system's policies on religious practice to protect the rights of religious minorities, both students and staff.
