Specifically, the **drastic reduction in the funding for construction of the new East Columbia 50+ Center.** While I recognize that these are difficult times requiring difficult solutions, it is unwise and unwarranted to cut the Center funding now for the following reasons:

- The construction on the East Columbia 50+ Center was set to begin this summer (2020). Reduced funding means that the Center cannot be built now causing a delay for the project of at least a year, perhaps longer. Delaying the project will increase the overall costs of construction. It has already been delayed resulting in a construction cost increase of \$4 million. In fact, seniors have been waiting over 6 years for that center to be built. Isn't that long enough?
- The planned 50+ Center is not "an unnecessary or un-vetted project." Dear Council,

I write to ask for your support for Amendment 14 to CR25-2020 which will separate the North Columbia Fire Station from the project for the fields at Harper's Choice Middle School. You may recall, this was my request when I testified at the budget hearing. The projects are about a half-mile apart and having been separated in location have little relationship to one another in scope.

After watching the work session, it is still unclear how much of the price increase in the fire station was due to the increased square footage, increases in construction costs, or the costs for the fields, parking areas, driveways, and intersection improvements at Cedar Lane and Rivendell Lane. It also remains unclear regarding the funding source for the fields, parking and intersection improvements; are the funds coming from the fire tax and the fire portion of the transfer tax or from other sources?

It also remains unclear on the need for the fields or whether Harper's Choice is the appropriate place for the fields. The fields unlike those proposed for the East Columbia Library, Troy Park, or Blandair Park are not in the Recreation and Parks master plan.

Separation will clarify the sources of funding and the steps in the development process. The middle school is in New Town while the Cedar Lane Park properties are not.

Community Outreach

The County's community outreach for the project is rather mixed. As I have stated previously, I serve on the Harper's Choice Village Board. County presentations to the Village Board last fall and winter were canceled without explanation or detail. On March 3, 2020, Kim Pruim was on the agenda to give an update. A presentation from the County Executive's staff was not unexpected. During the prior administration, Grace Fielhaur came to a Board meeting and discussed the status of the fire station project. However, rather than a low-key update, Ms. Pruim came with an entourage including, the Director of Public Works, the Acting Fire Chief, the Assistant Fire Chief, HCDFRS staff, the fire station consultant, the Director of Recreation and Parks, and Mark Stromdahl. Councilmember Jung also attended. Neither the Village Manager nor Board were given prior notice of the County officials that would be attending the meeting.

At this Board meeting, the community was first informed that the fire station was being moved to the East Area of Cedar Lane Park and that fields would be constructed at the middle school. The previous iteration of the plan had the fire station AND the fields at the middle school—as an offer of appeasement to the community for the loss of the open space. At that time, the fire station project also included the demolition of the Old Cedar Lane School. However, when Mark Stromdahl testified to the Planning Board for the capital project, he incorrectly stated that the fields had community support. This is just not true; the COMMUNITY, other than those attending the Village Board meeting, had never had an opportunity to comment on the latest plan with the fire station at Cedar Lane Park and only new fields at the middle school.

In addition, though the Harper's Choice Community Association and the Heritage Green Townhouse Association were involved in the planning and hosting of previous community meetings for the fire station, neither received notice of the Planning Board's Capital Project Hearings.

The March 19, 2020 Planning Board Capital Project Public Hearing

The newspaper notice for the first planned Planning Board hearing was fatally defective as it stated the date of the meeting was March 5 (the publication date) and not March 19, 2020.

Notice of Public Hearing

The Howard County Planning Board will hold a public hearing on new and substantially modified capital projects that have been requested by County agencies to be included in the County Executive's proposed FY2021 Capital Budget and the FY2022-FY2031 Ten-Year Capital Improvement Master Plan. The hearing is scheduled for March 5, 2020 at 7:00 PM in the Banneker Room of the George Howard Building, 3430 Courthouse Drive, Ellicott City, MD 21043. This notice is provided as required by Section 22.403(b)(3) (iii) of the Howard County Code. A brief description follows of the proposed new and substantially modified capital projects:

NEW CAPITAL PROJECTS

F5976 A new project to construct a 13,500 SF fire station on Route 108 to establish emergency services in a strategic position in the North Columbia area to relieve the demands associated with increased population density and call demands. 3/5, 3/12/2020 6622275

Though the newspaper stated that the project was on Route 108, the signs were posted in Harper's Choice. The project at the Harpers Choice Middle School no longer involved a fire station. It was a misstatement of material fact to refer to a "fire station" near Harper's Choice Middle School when it is now only planned to be athletic fields.



The sign placed at Rivendell and Cedar Lane was located 0.6 miles as the crow flies from the actual location of the fire station.



Section 22.403 of the Howard County Code requires that the sign be posted on the County property or on a public rightof-way. The sign in the photo was on Columbia Association property. The sign was not posted on either the right-of-way, on the Recreation and Park property, or on the DPW water tower property. Furthermore, the sign at the intersection of Rivendell and Harpers Farm Road was not the nearest public right-of-way to the property. It was 0.82 miles from the location of the fire station.

For the March 19, 2020 hearing, a sign was never observed posted at the actual location of the fire station in East Cedar Lane Park.

The April 9, 2020 Planning Board Capital Project Public Hearing

The March 19, 2020 Planning Board meeting having been canceled, the hearing was rescheduled for April 9, 2020. The sign placement for the Planning Board's hearing on April 9, 2020 were the reverse of those for the March 19 meeting. There were no signs for the capital project near the Harper's Choice Middle School. The sign below was at the East Area of Cedar Lane Park on or about March 26, 2020.



On April 9, 2020, I made formal motions and objections regarding the notice for the Planning Board. The Planning Board rejected the concerns and denied the motions.

At the next meeting of the Planning Board on April 23, 2020, Director of Planning and Zoning, Amy Gowan, though the motion had previously been denied, was given an opportunity to respond to the objections in the April 9 motions. During her presentation, Director Gowan deceptively told the Planning Board that the sign stated that the meeting would be held virtually and not at the George Howard Building. However, as can be seen the sign at East Area of Cedar Lane Park did not have the virtual location for the meeting. As some unknown time subsequent to March 26, the sign was amended to cross out the George Howard Building address lines and add the virtual information. It is unknown whether these changes were made prior to or after the April 9, 2020 hearing before the Planning Board.

Conclusion

For the reasons and issues discussed above, I urge the Council to adopt Amendment 14. The Amendment will separate the projects which will actually benefit the fire station project by not having it burdened by issues of the Harper's Choice Middle School fields. Furthermore, the amendment will assure that the community is involved and that the HCPSS grants its approval for the use of its school fields.

Dear Councilperson Rigby and Howard County Council Members:

I am the President of the Clark's Crossing Community in Columbia, Maryland, and I am writing to respectfully request your support for the budget cuts proposed by Councilpersons Walsh, Jung and Yungmann which will be voted on later today. I address Councilperson Rigby first because our community is within Council District 3, but as we are a small tight knit county, I also share our thoughts with the entire council. I am sorry that this entire process has moved so quickly right before a holiday weekend that we did not have an opportunity to address you prior to this time, and we understand that this request is contrary to the current position of our councilperson. Nevertheless we request that you keep an open mind and consider our opinions as a community as you move to a final vote.

Our community is a middle-class townhouse community in Columbia. We are neither a rich nor a poor community. Our median home sale price is approximately \$40,000 less than the median price for Howard County as a whole. And we are comprised of young families with children, retirees on fixed incomes, white collar workers, blue collar workers, government employees and private sector employees, and today, unemployed people as well. We are comprised of immigrant families from all parts of the world who immigrated at many different times over many generations. We are white and black, Christian, Jewish and Muslim. In short, we are a microcosm of this wonderful county.

Despite our great diversity, when we learned very recently about this upcoming vote and I reached out to my Board and our residents for their opinions, of everyone who responded, the response on this issue was uniform and without a single exception. During this time of great crisis and uncertainty, as many of us are facing loss of incomes and even jobs altogether, we are pulling our belts tighter and adjusting our spending to meet our in many cases reduced incomes. We do not have a switch we can pull and increase our incomes, so we are adjusting our spending. This is both at our individual household level, as well as at our community association level.

Respectfully, we request that Howard County government do the same thing. Many of us are making spending cuts in our homes of things that could be valuable and important. We are cutting more than just frivolous expenses. If we are making the hard choices in our homes, Howard County government should do the same thing. It is hard for us to understand how in operating and capex budgets of nearly \$2 Billion, prudent spending cuts cannot be found to make spending match revenue, rather than the reverse.

Many of our owners have expressed special concern that the county is pushing forward with the cultural center in the budget at a time of such great economic crisis. The concerns are not so much with the project itself as with the timing. We love the arts as much as any community, and understand that low and income median housing can be a valuable thing, not only in preventing concentrations of poverty, but also in making sure public servants such as teachers, fire fighters, police officers and nurses who protect us, especially in these difficult times, are not priced out of living in our great county. But the timing is not this year, and we do not have the right to mortgage our children's future by spending more money than we have. This is how we run our households. This is how we should run our county. And we should absolutely only spend within the constraints set by the Howard County spending affordability committee. Fiscal discipline and prudence requires this.

I know the hour is late and the vote is close at hand. But we respectfully request that our elected officials keep an open mind and consider our community's opinion, even received at this late hour. Many thanks to each of you for your dedication and service to this great county.

Dear Councilmembers,

I am writing to express my dismay and frustration regarding the budget cuts for FY21 Capital and Operating Budgets. I tuned in a few times to the work sessions in between working on the volunteer projects I continue to work on for the PTA and for my community and helping my kids with their online learning. Frankly, I'm disappointed by how sloppily this is being handled. The massive cuts being proposed clearly have not been carefully considered by some of you and I urge you to think about the long-term impacts of your decisions. Not knowing how many positions your budget cuts impact in each department is unacceptable.

I am writing as a private citizen, but to give a little background, I have served on the SAAC for two years in a row and I understand the big picture (at least slightly better than the average resident) when it comes to how complex the counties needs are and how much our wonderful amenities cost. I understand that the County already has a challenging time reigning in spending. The SAAC has suggested that the County examine multiple sources for increasing revenue and the County Council has acted on some of those suggestions in the past. The recordation tax increase is one of those suggestions that should be a no brainer. With the potential to bring in over \$20 million, I'm left wondering what any Councilmember is thinking in not supporting this. I hope you've already changed your mind on this, but if you haven't, please provide an explanation because I just don't understand.

I want to reiterate the importance of balancing fiscal responsibility with recognizing the need for economic growth. I shouldn't have to remind elected officials that a county budget is not the same as a household budget. The level of cuts proposed will lead to extreme negligence and will end up costing more in the long run.

As an education advocate, I'm disheartened that after so many years of advocacy from local communities and individual community members that you are considering taking away Complete Streets funding for safer walking paths to school for children (who would then no longer need bus transportation, i.e., savings in transportation costs). I am in disbelief that THREE of you are considering delaying ADA compliance across the county.

Looking through the proposed cuts, I'm frankly terrified at the downstream effects of cutting funding for long delayed improvements to infrastructure, like our roads and sidewalks, which as relayed to the SAAC and I'm sure to you, is already backlogged by over \$50 million.

It's unconscionable that some of you have proposed cuts that will eliminate vacancies and opportunities for jobs within the county. We should be providing as much opportunity for our residents to find employment within our county, especially when so many are already facing new or prolonged unemployment.

While a new cultural center may seem frivolous by name, surely you understand that you would be jeopardizing a potential increase in the much-needed stock in the affordable housing and that you would be leaving tens of millions of federal tax credits on the table. The fact that many teachers and first responders who work in the county can't even afford to live here without a supplemental income should tell you how badly needed affordable housing is for the more vulnerable residents.

Finally, having heard two years in a row, the budget proposal from the Department of Corrections, I cannot fathom what makes you think the detention center can handle any MORE deferred maintenance than it has already been suffering from for years. I was haunted the first time I heard the bare bones budget proposal last year and I continue to worry about the building that is literally falling apart.

In closing, I hope you vote keeping in mind the downstream and long-term effects of your decisions will on the county's growth and health. You will have to make tough decisions, but start with the easiest one and support the increase in the progressive recordation tax.

My name is Larry Corsa and I am president of the Heritage Green Townhouse Association. Our neighborhood is located directly across Cedar and Rivendell Lanes from Cedar Lane Park and the Harpers Choice MS grounds. I represent approximately 200 residents who have been following the North Columbia Fire Station project since we were made aware of it in 2017.

My community supports the need for a fire station serving northern Columbia, and agrees that a site on Route 108 offers the best access, despite traffic concerns. The proposed site for the fire station facility is located within the boundaries of Cedar Lane Park, and uses land from an existing turf field to save time and money; yet there is \$3M available in a contingency fund to build a replacement field and much more a half mile away on Harpers Choice MS grounds.

I am writing to support Amendment 14 to Council Bill CB25-2020 to require a "community outreach meeting including a public presentation and comment process on preliminary site plans". Friday's discussion of this amendment centered around the need for an open and transparent process that provides opportunity for community involvement. Councilman Jones indicated that he was not aware of any non-transparency in the process to date; Chief Anuszewski indicated that there was no intent to be non-transparent; Mr. Delerme stated that "we always have transparency on all our projects."; and Mr. Stromdahl said "I guess I don't necessarily agree that the process really hasn't been transparent" and later added that "we did push to get it into the planning board, so we could get it in this budget this year".

While I have lived in Howard County for twenty years, this fire station project has been my first exposure to the workings of Howard County Government. As an outside observer, the processes seem to be designed almost exclusively around the internal needs of the government participants, and are anything but transparent. I do not mean to imply any ill intent, but it has been a challenge the past three years to stay abreast of events to react in a timely manner, never mind to observe or affect the process in motion. I testified to the Planning Board on March 19th regarding the lack of proper notice and the need to take extraordinary measures in these extraordinary times, rather than as an excuse to do the minimum required.

I appreciate that the new site takes away a soccer field from the east area of Cedar Lane Park and I support the idea that replacement facilities and parking will be added to the west area by the Harpers Choice Middle School. However, the new fields bring along new roads and reconfigured intersections to the school grounds, and these impacts require much more information. I urge the Council to pass Amendment 14 to assure that these additional funds are spent in a manner that includes a large measure of community involvement.

Ms. Jung (<u>00:02</u>):

Oh, the North Columbia Fire Station. Okay, so... CD 25, number 12... just wanna go to that page. Oh.

Chairwoman Rigby (<u>00:21</u>):

I think next is your fire station one.

Ms. Jung (<u>00:37</u>):

14. Oh, right, okay. I thought we were still looking at the cultural center. Okay. 14, which is the fire station. This is really weird, I need people to help me label things. Well, I'll just talk about it without looking at it, 'cause I know what it's about. This is to put \$3 million in contingency for the, um, the field, uh, for the, um, the turf field that was attached to the new fire station. The fire station money remains in the fund but the \$3 million goes into contingency, and the contingency is to ensure that there is a transparent public process regarding the, uh, field, the addition of the field in the back of Harper's Choice Middle School, and that the, um, administration is also transparent in the process of its agreements with the Board of Education and in MOU.

Ms. Jung (<u>02:01</u>):

You're smiling, Ms. Rigby. You're like, "This woman is never gonna let this fire station go." I know Mr. Yungmann is thinking the same thing. I- I am happy to let the fire station move, but I wanna make sure that when it moves, it moves in a very open and transparent process. I have not seen that so far and I really would like to see that for the sake of the community. So, whatever happens, happens. But I would like to see it be open and transparent. That's it.

Dr. Jones (02:42):

Since, uh, we have dozens of people either on the line or waiting to speak, can someone speak to it? Um, the supposed non-transparency of this field? I know I've read about it, and I don't even live over there.

Ms. Jung (02:56):

Well, I know... I know that in order to get the agreement between the Board of Education and the county administration, um, we had to do an MPIA. So... that's not exactly what I call transparent.

Chairwoman Rigby (03:13):

Are we doing the time for questions? So, I- I just don't wanna... I wanna make sure that I'm only talking...

Ms. Jung (<u>03:18</u>):

Yes, we are. We're timing. Yes.

Chairwoman Rigby (03:20):

Okay. So who, whose turn is it? Who's on first?

Ms. Jung (<u>03:22</u>):

Um, well, uh, I didn't set up a who goes first, second, and third. But, um, you can feel free to ask a question.

Chairwoman Rigby (03:37):

Is Dr. Jones going... is it... is it Dr. Jones' turn, so that he can ask the questions [crosstalk 00:03:43].

Ms. Jung (03:42):

Okay. Dr. Jones, would you like to ask any other questions?

Dr. Jones (03:47):

No, I mean, I was just curious to see if anyone had anything to say about it. Um, you- you mentioned that it was not transparent. You mentioned, uh, an MPIA. There may be someone here to talk about that. If not, then okay, but I don't know. I just, I'm-I don't know of too many things, if anything at all, happening in a non-transparent way. So, that's just me, though. I mean, you have a different take, you're more invested on that side of the county, which I appreciate, 'cause I'm paying more attention to things on this side of the county. But maybe someone could say that it is or it isn't. I'm not sure.

Raul Delerme (04:23):

Do you want to start off? Or do you want me to start?

Chief William Anuszewski (04:29):

No, I- I was just- just leaning in trying to get a breath in, but uh, first let me say thank you to, uh, Chairman Jung, Chairwoman Jung, for the little acknowledgement in the beginning. I couldn't unmute myself to say thank you, so I say thank you now.

Ms. Jung (<u>04:42</u>):

Aw, well, we're really excited that you're the new chief, and we're very, very happy that you have secured this job. And I know that we already enjoy working with you, and I know.... I- I wanna say it to your... I was gonna say to your face, but to the screen, to your face on the screen, um, that, um, we're-we're really glad that, uh, you- you will be the new chief. So, yay.

Chief William Anuszewski (05:08):

Look forward to the- the continued partnership. Uh, first, let's- let's talk about... I'm not sure about the transparency either. I know that, um, you know, that- that my involvement in it with the community meeting. I know there was good to be more meetings going on with the public as far as the direction of the station, input as far as where it was going.

Chief William Anuszewski (05:26):

Um, unfortunately, COVID's kinda derailed us a little bit there. So, um, that is more into the DPW side of things. [inaudible 00:05:36] as far as meetings, but I don't think we are... there's no intent to be non-

transparent with this process at all. We know there needs to be a fire station there, um, to help protect the public. We know we have response time issues into that area. Uh, so we know it's needed.

Chief William Anuszewski (05:52):

Now, the... as far as the \$3 million transfer to the, um, uh, to the contingency plan, these are kinda protected funds as they are, because they are fire tax funds. So they- they can't really be spent in other areas of, uh, funding throughout the county, because... 'cause they're tied back to the fire tax. I'm not sure the- the need to put into the contingency line elsewhere.

Chief William Anuszewski (06:17):

Uh, I think once we have the Waterloo plan finalized, we will have a great, uh, consideration for what the cost of construction of a fire station will be, 'cause it's gonna be the same fire station minus a, uh, the police hub that we had built into this fire station at Waterloo. So we'll have a better idea of what the standard footprint fire station will look like once that's done.

Chief William Anuszewski (06:39):

As far as the- the planning meetings and everything else, I would have to ask, uh, Mr. [Stromdahl 00:06:44] to speak on that part.

Ms. Jung (<u>06:46</u>): Mis-... okay.

Raul Delerme (06:52):

I can go ahead and start until Mark is... and this is Raoul. Um, we always, uh, have transparency on all of our projects. Um, you know, one... when we were asked and talked to the, you know, fire department, Mark Stromdahl about this project, uh, to be placed on the Cedar Lane Park.

Raul Delerme (07:08):

Um, one of our goals was, you know, to get that field replaced, and- and we looked at the area behind the school, and- and it seemed to work out really well, so we did a conceptual plan of that layout, we we presented it to the village board there, and... as well as, um, you know, to the board, uh, to the Howard County Public School System. And, um, we haven't gone any further to date, you know, we're waiting through the... for this process, and, um, you know, I think it's been looked at by the- the chief there, and- and Mark, and it seemed to work out really well, where- where they're locating along Cedar Lane Road... I mean, not Cedar Lane Road, Route 108.

Raul Delerme (07:44):

So, um, our next step will be to take it to the public. So, for further transparency. So, Mark, I'll let you speak on that behalf.

Mark Stromdahl (07:52):

Okay, yeah. Um, appreciate that. So, um, I guess I don't necessarily agree that- that the process really hasn't been transparent. Um, with the original scheme, where the fire station was down, uh, off of Cedar Lane, I mean, we had, uh, we began with, you know, the sort of, um, required public meetings, starting the SDP process, and that led to a number of public meetings, to present the project and gather

input from the public, and, um, and as a result of those public meetings, we actually... I think that's when we came up with, uh, the relocation, you know, in Cedar Lane Park East, and, um, and just with the fields down by, uh, down off of Cedar Lane.

Mark Stromdahl (08:40):

So, I think, um, you know, as far as the school board goes, we never could get that project far enough along to where we could begin to really develop the agreement at that time with the school board, because we couldn't define what the property was gonna be. So there wasn't anything to share. Certainly that would be shared once we were able to get to some kind of an agreement, and in this situation, I know, um, I mean, we've been accused of, uh, or it's been suggested, that we, you know, haven't been transparent with the new direction that the project has taken.

Mark Stromdahl (09:17):

But I mean, we did push to get it into the planning board, so we could get it in this budget this year, but there's certainly no intention not to have, you know, all the public meetings required to discuss both the fire station, um, and the park. Um, and whatever it is... and, you know, be hoping about what we're... we would be talking to the school board about, though.

Ms. Jung (<u>09:37</u>): Good. Thank you.

Mark Stromdahl (<u>09:40</u>): Thank you so much.

Ms. Jung (<u>09:46</u>):

All right. And then, these other... uh, CR-60 is the resolution that goes along with CB-25, amendment 14. Um, so next is capital...

Chairwoman Rigby (<u>10:01</u>): Sorry, I did... I did have a question.

Ms. Jung (<u>10:03</u>): Oh, I'm sorry. Go ahead.

Chairwoman Rigby (<u>10:05</u>): Sorry, I was just waiting my turn.

Ms. Jung (<u>10:06</u>): Okay.

Chairwoman Rigby (10:06):

Um, so, my question is about the cost of the fire station, and the cost of delay. Um, so, Mr. Stromdahl, could you talk about what the delays have cost county taxpayers already? And then if this... if this

amendment doesn't cause any additional delay, then that's fine. I just wanna if there is a cost to- to this amendment or not.

Mark Stromdahl (10:31):

Um, well, I'd have to go back and look at some past budget years to see where we were with this project. But I would say, um, 'cause we've been working on this for a long time. So this is a rough number, I'd have to verify it, but I mean, we could be in the one to two million dollar range of additional costs, say from the time that we, you know, really first began working on this a few years ago.

Mark Stromdahl (10:55):

Um, going forward, I mean, typically, um, any time you delay a project, it always gets more expensive. Uh, construction costs typically go up, and a lot of times, there's changes in regulations, and, um, and then you have to go back and, um, you know, adjust the site plan or the building plan to comply with new regulations. You know, this is a case with what's going on in the economy now, it's- it's hard to predict. You know, we might catch a break, and things could be less. But, you know, you really can't count on that. So, um, and generally, you know, they- they do cost more, uh, each year that you delay it, so.

Chairwoman Rigby (<u>11:35</u>):

Well, I think just this year's delay was about \$2.6 million, if I'm looking in the capital budget correctly. Um, so...

Mark Stromdahl (<u>11:46</u>):

So I wasn't too far off with my guesstimate there, I think. So, yeah.

Chairwoman Rigby (11:50):

Yeah. Um, so, but would putting it... would taking a portion of the funds and putting it in contingency cause a delay or not cause a delay?

Mark Stromdahl (<u>12:00</u>):

Um, I'm not sure what the rules are, as far as our ability to spend, if... I mean, if we're able to- to spend them...

Chairwoman Rigby (<u>12:07</u>):

Okay. I can follow up later on that part. Um, just it was on the agenda, so I wanted to make sure I- I took the time to ask. So thank you.

Ms. Jung (<u>12:17</u>):

Mr. Yungmann has a question.

Mr. Yungmann (<u>12:20</u>):

Um, so the project has gone up two and a half million dollars, Mark? In a year?

Mark Stromdahl (12:29):

Um, I guess... I guess I'm going on Ms. Rigby's word on that, but I- I think it's gone up. I'd have to look back at the older versions of the capital budget.

Mr. Yungmann (<u>12:39</u>):

And is that just the passage of time? Or has the project itself changed? I mean, construction costs are not up that percentage.

Mark Stromdahl (12:50):

Well, we started the project, I forget what the year on it is. Um, we started it, um, a few years ago, and in those intervening years, construction costs in this region have risen, um, for a year or two, well above the typical sort of 3% that we factor in each year.

Mark Stromdahl (13:11):

Um, the project itself, um, it did change... well, and that is a good point, it did change scope, um, I guess the year before last. Um, you know, the fire chief at the time, uh, Chief Butler, had wanted to, um, add some additional space to the station, so that we could have a tow truck there in the future. And so the scope, the size of the building, did increase by, um, it was around 1500 square feet. And since it's not a real big building, I mean, that went from like 12.5 to 14, or 13.5 to 15, something in- in the... in that range, so.

Mr. Yungmann (<u>13:56</u>):

And then you also... is that two and a half, call it, also include this rec and parks piece of replacing these multipurpose fields?

Mark Stromdahl (14:06):

I don't think so. Um, that's, uh, um, that was why we wanted to add an additional \$3 million, um, to the project. Um...

Mr. Yungmann (<u>14:15</u>): Right.

Mark Stromdahl (<u>14:15</u>): On top of just building, yeah.

Mr. Yungmann (<u>14:17</u>):

How much is the project now, before the- the turf field addition?

Mark Stromdahl (<u>14:22</u>):

Um, bear with me a second here.

Mr. Yungmann (<u>14:27</u>):

It can be... it can be round numbers, Mark. I- I should know too. Look to the budget.

Mark Stromdahl (<u>14:32</u>):

I think without the turf fields, it's in the 10.5 range, something like that.

Mr. Yungmann (<u>14:38</u>):

So, just simple math, we're- we're suggesting that delays alone, inflation of construction costs, have added 25% to the cost of the project, except for the... this additional 1500 square feet, which may have contributed to it. And we might assume, you know, construction cost escalations in the next year similar to that?

Mark Stromdahl (15:08):

Well, I can, you know, um, I would say, though, probably...

Mr. Yungmann (<u>15:09</u>): I mean, I know you can't predict the future.

Mark Stromdahl (<u>15:14</u>): Yeah, yeah.

Mr. Yungmann (<u>15:14</u>): I know you can't predict the future.

Mark Stromdahl (<u>15:15</u>): Yeah.

Mr. Yungmann (<u>15:15</u>):

But let- let me dial that back. So you said that construction costs generally- generally outpace normal cost of living. So let's say CPI's been two, three, four percent.

Mark Stromdahl (<u>15:24</u>): Right.

Mr. Yungmann (<u>15:25</u>):

Maybe construction costs are five or six. So, you know, on a \$10 million project, the cost of this project could go up a half million bucks if we delay it. And that's assuming that- that the slowdown in the economy doesn't flatten construction costs.

Mark Stromdahl (15:40):

Correct, that's right.

Mr. Yungmann (<u>15:41</u>):

Okay. I gotcha. I just, that number jumped out at me, and I just wanted to dig a little deeper. Thank you.

Mark Stromdahl (15:46):

I mean, in very round terms, you know, I mean, um, yes, I wouldn't argue with what we're talking about here.

Ms. Jung (<u>16:03</u>):

Are there any other questions? No? Okay. Uh, let's see. We are onto CB-25, amendment 12, which is a very lengthy amendment to the capital budget.

The Therapeutic Recreation opportunities from HCRP are an absolute life line for her. There has been much disappointment in the past when the TR outings have filled and she has been wait-listed. This has happened far too many times. We register at 6:00 on the given day, and by 6:01 all the vacancies are filled. We have been put on a wait list, but openings never occur. When I inquire, I learn that the limiting factor is hiring good staff. Please don't make any cuts to TR staff. Incidentally, we pay for the Therapeutic Recreation programs, and they are worth it.

HCRP has built a wonderful Therapeutic Recreation program that does not currently meet the growing needs for socialization and community outings for people with disabilities. This is a growing population in Howard County. Please don't cut these services.

I fully realize the affect of Covid 19 on the County's budget, but cutting Therapeutic Recreation will have a terrible effect on a very vulnerable population.

Dear Howard County Council members,

Thank you for all your efforts working on the annual budget and all legislation. I appreciate your dedication and long hours. I realize this is an unprecedented time and the economic outcomes are unimaginable. The county will need to adjust the budget accordingly. However, I do not agree with some of the line items in Amendment 12 that are to be cut.

The state of Maryland has a law with a goal of reducing Greenhouse Gas (GHG) Emissions 40% below 2006 levels by 2030. Howard County has committed to reducing GHG emission 45% below 2010 levels by 2030 and to reach zero emissions by 2050.

The impact of zeroing out FY21 funding for C0329 "Energy Management Improvements" would mean nearly 2600 metric tons of GHG emissions that we could have eliminated will be released into our atmosphere each year until those projects are completed. In addition, while these projects have upfront costs, they will save the county money in the future with an average annual savings of \$550,000. See below for breakdown and details.

Additionally, I do not believe funding should be taken away from Environmental compliance (CO313), Watershed drainage and stormwater management projects D1180 and D1181, funding for complete streets projects like school route sidewalks, and funding to create pedestrian and bicycle plans that will lead to increased active transportation, again, reducing GHG emissions.

Kimco and the Village Board were allowed days to testify in conditions where all could hear what was going on and the reactions of those present. This request is simply in the same spirit of fairness. The only reason I can see why you would not delay the hearing is that you have already **PREDETERMINED YOUR VOTE** and your vote is **NOT** on the side of the opponents.

I have sat at most of the hearings and it seems as if Kimco has fed the information provided by various Howard County departments to the Board. It appears as if Kimco wants exceptions to everything including easements, the number of parking spaces allowed per square foot, and of course the zoning from single-family to over 230 apartments (which by the way the exact number of 1, 2, and 3 bedroom apartments has never been clarified). Kimco has also misinformed the board that people use Cedar Lane to get to Rts. 29 and 32. Obviously, we want to ensure affordable housing is available in Howard County. Why build more apartments when the ones already here are not at capacity even with projected county growth?

There has been a suggestion submitted to hold the hearings at Merriweather Post Pavilion or another open forum such as a high school stadium that would allow social distancing. I encourage you to consider this suggestion or postpone until such time that all parties can be heard under the same conditions. Also, why would you want the perception that you don't care about your constituents? Has Kimco given you money for your campaign war chest or tickets to events? Honestly, represent the people and let everyone's voices be heard – not in a live stream or where only limited people can hear what is going on. **BE FAIR – POSTPONE THE HEARINGS or PROVIDE** an alternative where all people who are interested can be present.

• Managed wisely and fairly, the senior tax base is a cash cow for the general fund contributing far more in local income and property taxes than it consumes in county services. Seniors are a critical asset to the County tax base; one entitled to claim a reasonable share of services.

• The County budget last year contained a significant tax increase to the property tax rate affecting the fire and rescue area as well as an increase to trash collection fees. Property tax rates for senior homeowners increased last year by hundreds of dollars. To follow up with a significant reduction in services is a double whammy.

• Since seniors, as a whole, under-consume County services they comprise a major financial asset to the County general fund. This is a demographic the County must retain to finance vital services including our schools. We are taxpayers who have every right to expect a reasonable level of services that address our needs even as we expect to support services vital to other County demographic groups.

Our family member is safely and securely served, with enjoyment and appropriate learning and appreciation of our beautiful county, as well as crucially necessary social engagement with appropriate peers and the safe and unfailingly kind HCRP staff.

For individuals with disabilities in Howard County, the services of the Recreation and Parks Department are not only recreation, they are a vital part of life, and often the only safe means of social interaction. Individuals with disabilities are vulnerable to predators and scammers, but the Recreation and Parks Department staff are impeccably well chosen and well trained. The HCRP staff uniformly take an interest in meeting the needs of individuals with disabilities, and have an intuitive awareness of how to interact with these individuals in supportive and respectful ways.

These interactions with HCRP staff enhance each individual's confidence in himself and actively power the individual's sense of identity as a community citizen. Additionally, a more self-confident individual with a disability has less vulnerability, and is more likely to function at a higher level in future life -- to hold a job, to pay taxes, and to contribute in future years to the community as a productive adult with a disability.

I believe that the basis of HCRP's excellence in designing and implementing programs for all individuals, including those with disabilities, is a highly supportive corporate culture in which every staff member is respected and valued. The HCRP staff all give 120% -- meaning that they already function at high efficiency, making the most of the resources that they have. To diminish the resources of the Recreation and Parks Department would be to diminish the vital services which this essential organization provides.

The last couple years there is a mad dash to register at exactly 6 pm and then keep your fingers crossed you don't end up on the list. "The Out and About" and "Slice of Summer" are awesome social programs and all the parents are thrilled to have their child participate. I am hearing rumor that two more staff people may be cut from therapeutic programs. Quite honestly, you should be adding two or three more staff. He has been on the waiting list for the last two sessions. If you saw how much fun they have in these programs - you would never consider cutting more staff from therapeutic programs. Dear Council Members,

I urge you to reconsider the budget cuts outlined in the budget amendment that you will vote on Wednesday, May 27, specifically the drastic reduction in the funding for construction of the new East Columbia 50+ Center. While I recognize that these are difficult times requiring difficult solutions, it is unwise and unwarranted to cut the Center funding now for the following reasons:

1. The construction on the East Columbia 50+ Center was set to begin this summer (2020). Reduced funding means that the Center cannot be built now causing a delay for the project of at least a year, perhaps longer. Delaying the project will increase the overall costs of construction. It has already been delayed resulting in a construction cost increase of \$4 million. In fact, seniors have been waiting over 6 years for that center to be built. Isn't that long enough?

2. The planned 50+ Center is not "an unnecessary or unvetted project." The East Columbia 50+ Center is a necessity which will provide much needed services to under-served seniors and the heavily populated community at large. Among other services, plans for the new center would include services for memory-challenged seniors in our community (there are currently no such services in this part of the County).

3. A 28% reduction in this project funding represented one of the most severe cuts compared to other projects. Why are seniors being targeted for disproportional sacrifice? We are the fastest growing segment of the population, we pay taxes yet we ask very little from our government. How is this equitable and fiscally fair?

Please reconsider this drastic reduction and restore full funding to the East Columbia 50+ Center. If Howard County is to remain a vibrant, wonderful place to live, it must provide for all its residents. Certainly we seniors are not getting any younger.
