

1	WHEREAS, the County Executive and County Council of Howard County recognize
2	that there is a significant need for reinvestment and revitalization of certain communities in
3	Howard County; and
4	
5	WHEREAS, by approval of Resolution No. 91-2001, Howard County designated the
6	area of the Route 1 Corridor as a Community Legacy Area and the designation was approved by
7	the State of Maryland; and
8	
9	WHEREAS, during Fiscal Year 2006, the State approved a modification to the Route 1
10	Corridor Community Legacy Area to include a portion of land north of Interstate 95 and a
11	diagram of the Route 1 Corridor Community Legacy Area is attached as Exhibit "A"; and
12	
13	WHEREAS, Howard County proposes to develop a Community Legacy Project in the
14	Route 1 Corridor Community Legacy Area (the "Area"), as further described in the Community
15	Legacy Application, the purpose of which will be to contribute to the reinvestment and
16	revitalization in the Area; and
17	
18	WHEREAS, the Maryland Department of Housing and Community Development (the
19	"Department"), either through the Community Legacy Program or through other programs of the
20	Department, or in cooperation with other state departments or agencies, may provide some or all
21	of the financing for the Project (the "Project Financing") in order to assist in making the Project
22	financially feasible; and

24	WHEREAS, the Area is located within a priority funding area under Section 5-7B-02 of
25	the Smart Growth Act, set forth in the State Finance and Procurement Article, and the Project
26	will conform to the Howard County Zoning Regulations; and

28	WHEREAS, the Project includes the construction of approximately twenty single family
29	homeownership units including related infrastructure improvements; and

1	WHEREAS, the applicable law, regulations and Departmental requirements necessitate
2	approval of the Project and the Project Financing by the County Executive and the County
3	Council.

5	NOW THEREFORE, BE IT RESOLVED by the County Council of Howard County,

7	and approves the application for Project Financing in the form of a grant or loan, up to the

APPROVAL OF AN APPLICATION TO THE MARYLAND DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT FOR THE FY 2012 COMMUNITY LEGACY PROGRAM

TESTIMONY

The Maryland Department of Housing and Community Development has announced the opening of its' FY 2012 Community Legacy Program funding cycle for eligible Units of Local Government, Groups of Local Governments and Community Development Organizations. The Howard County Department of Housing and Community Development will submit an FY2012 Community Legacy Application for Funding on October 26, 2011 to the Maryland Department of Housing and Community Development. The application is in support of the proposed affordable housing development known as "The Cottages at Greenwood II". The grant request will be in the amount of \$600,000. The funding will be used to pay for a portion of the construction costs associated with the development of approximately twenty (20) homeownership units which will benefit residents earning at or below 80% of median income for the Baltimore Metropolitan Statistical Area (MSA).

FISCAL IMPACT STATEMENT

The amount of the grant request is \$600,000. There are no matching requirements for this grant.

This project will assist the County in meeting its affordable housing goals and implementing specific strategies outlined in the FFY2011 - FFY2015 Consolidated Plan. Therefore, we strongly recommend the approval of this resolution.
