WHEREAS, Section 404 of the Howard County Charter and Section 6.300 of the Howard 1 County Code provide for the County Executive to appoint and for the County Council to confirm 2 nominees to Howard County Boards and Commissions created by law; and 3 WHEREAS, Title 13, Subtitle 13 of the Howard County Code provides for a Housing 4 Commission in Howard County; and 5 WHEREAS, the County Executive has proposed the appointment of Paul Casey as a 6 member of the Housing Commission; and 7 WHEREAS, the County Council ratifies the County Executive's special trust and 8 confidence in the abilities of the nominee. 9

Paul K. Casey is a retired partner of the law firm Ballard Spahr LLP. During his 23 years at Ballard, Mr. Casey concentrated his practice on real estate finance and public finance transactions, with an emphasis on affordable housing, public housing law, and federal housing programs. He also served for 10 years as the Co-Leader of the firm's Housing Practice Group.

A major portion of Mr. Casey's legal work included the representation of housing authorities in the financing and development of affordable multifamily and single-family housing, including mixed-finance developments and acquisition rehabilitation financing. Much of his practice was in the area of mixed-finance public housing development and he was actively involved in hundreds of such transactions across the country.

Mr. Casey's experience included leading the legal team that represented the New York City Housing Authority in the closing of the one of the largest public-private partnership tax credit bond deals in U.S. history. The transaction, funded in part by the American Recovery and Reinvestment Act of 2009, provided approximately \$400 million in initial public and private funding for the modernization of more than 20,000 public housing units and an additional \$65 million to \$75 million each year in federal subsidies for ongoing operations. In addition, Mr. Casey led the legal team that represented the Puerto Rico Public Housing Administration in closing the largest Low Income Housing Tax Credit project ever undertaken in the history of the tax credit program: \$235 million in tax credit equity, combined with \$485 million in tax-exempt bonds, to finance the modernization of 4,100 housing units.

Mr. Casey was appointed Assistant Attorney General of Maryland and served from 1983 to 1987, which included serving as Principal Counsel to the Maryland Department of Economic and Community Development.

Mr. Casey, and his wife, Kathleen, have been residents of Ellicott City in Howard County, Maryland, since 1985.

#### **Pro Bono Experience**

In 2012, at the request of Thomas Carbo, Executive Director of the Howard County Housing Commission, Mr. Casey agreed to take the lead on a pro bono project to organize and incorporate the Columbia Downtown Housing Corporation. When the Board of Directors of the CDHC was formed in November 2012 Mr.Casey was elected President and, along with the other board members, served in a pro bono capacity. The Board played a critical role over the next five years in working with the County, the Commission and the Columbia Downtown Developer in designing a multifaceted affordable housing plan for Downtown Columbia that was adopted by the Council and approved by all parties in 2017.

Mr. Casey was an active participant in Ballard Spahr's pro bono program. Two of the pro bono teams he helped to organize won Ballard's annual outstanding pro bono team award. One team represented the Franciscan Sisters of Baltimore in the conversion of

their 100-year-old motherhouse and orphanage into a mixed-use housing facility, including a convent, an affordable rental facility, and homes for families with foster children. The other team project involved more than 20 professionals providing emergency legal services to the Housing Authority of New Orleans in the aftermath of Hurricane Katrina.
