

Council Resolution No. 55-2020

Introduced: April 6, 2020

Fiscal Impact:

There is no expected fiscal impact of Council Resolution 55-2020.

The proposed meetings occur annually, and all costs associated with conducting these sessions are included in the Council's annual budget appropriation.

Purpose:

The intent of this resolution is to schedule two Howard County Council legislative sessions on May 27, 2020, at 10:00 a.m. and July 29, 2020, at 10:00 a.m.

Other Comments:

The purpose of the May 27 meeting is to approve the Budget. According to Section 606 of the County Charter, this approval shall be on or before the first day of the last month of the fiscal year.

The purpose for the July 29 meeting is to have a legislative session prior to August according to Section 208(b)(2) of the County Charter and Appendix A – Rules of Procedure for the County Council.
