A RESOLUTION pursuant to Section 4.201 of the Howard County Code declaring that land containing 0.188 acres owned by Howard County, Maryland is no longer needed by the County for public purposes; authorizing the County Executive to convey, at no cost, fee simple title to the Property to the State of Maryland; waiving the advertising and bidding requirements of Section 4.201 of the Howard County Code; and providing that the County Executive is not bound to convey the Property if he finds that the County may have a use for the Property.

WHEREAS, the County is the owner of the 0.188 acres of land shown as "Howard County, Maryland Parcels 1, 2 and 3, Item No. 114924") on the State of Maryland Department of Transportation State Highway Administration State Roads Commission's (the "State') Plat numbered 61705, a copy of which is attached hereto as Exhibit A (the "Property") which was acquired by the County by deed dated September 12, 2019 and recorded among the Land Records of Howard County, Maryland at Book: 18884, Page: 214 for the construction of high school 13 and the County's water tower; and

9 WHEREAS, as part of the construction for high school 13 and the County's water tower, 10 the County will need to convey a total of 0.188 acres along Route 1 to the State for the 11 construction of the intersection at Ridgely's Run Road and for a new southbound turn lane and 12 shared use path as follows:

- 13 1. Parcel 1, shown in purple in the attached Exhibit A, is needed for the new 14 intersection for Ridgely's Run Road including clearances for curb radii as well as the future 15 traffic signal equipment, and all will be part of the State-owned portion of the intersection;
- 16 2. Parcels 2 and 3, shown in green and orange, respectively, in the attached Exhibit 17 A, are required to fit the new southbound right turn lane (required by the traffic study) and 18 shared- use path as required by the State; and

WHEREAS, the conveyance is necessary as part of the State's Access Permit application process, for the construction of the roadway leading to high school 13 and County's water tower; and

WHEREAS, the County, has determined that the Property is no longer needed by the County for public purposes; and

WHEREAS, Section 4.201 "Disposition of real property" of the Howard County Code authorizes the County Council to declare that real property is no longer needed for public purposes and authorizes the County Council to waive advertising and bidding requirements for an individual conveyance of real property upon the request of the County Executive; and 1 WHEREAS, the County Council has received a request from the County Executive to 2 waive the advertising and bidding requirements in this instance for the conveyance of the 3 Property to the State.



Fiscal Impact:

The fiscal impact of this legislation cannot be determined at this time. *We have asked* Department of Public Works if they obtained a current appraisal for these parcels. They have not yet responded to our request.

According to the Department of Public Works (DPW), the 0.188 acres being conveyed to the State is comprised of three separate, County-owned parcels noted below:

Purpose:

This legislation will authorize the County Executive to convey, at no cost, 0.188 acres of County property to the State of Maryland in order to construct the roadway and intersection for access at two sites (the Guilford Elevated Water Storage Tank and High School #13).

According to the Administration, construction is required by the Maryland Department of Transportation (MDOT) State Highway Administration (SHA) for the County to receive the appropriate SHA Access Permits for these locations.

Other Comments:

The construction of the roadway and intersection will be completed by the County under Capital Project W8262. The parcels of land were acquired via Capital Project C0352.
