1	WHEREAS, the "Fight For \$15" Coalition successfully advocated for the passage and the
2	eventual enactment in 2019 of a phased-in \$15 per hour minimum wage for Marylanders;
3	and

5	WHEREAS, during the deliberation of the Fight For \$15 legislation (HB166/SB280), the
6	Maryland General Assembly added Section 3-413.1 to the Labor and Employment
7	Article of the Maryland Annotated Code, which grants the Board of Public Works the
8	discretion to delay a scheduled increase to the minimum wage if it determines that a
9	certain economic indicator warrants such a delay; this provision became known as the
10	"off ramp;" and
11	
12	WHEREAS, Board of Public Works Members Peter V.R. Franchot, Maryland Comptroller, and
13	Nancy K. Kopp, Maryland State Treasurer, constituting a majority of the Board, have
14	expressed support for the first phase-in of the wage increase to proceed as originally
15 -	intended, for which we express our gratitude (see e.g., June 23, 2020: Maryland's
16	Minimum Wage Increase Likely to Go Forward, Despite Opposition from Business
17	Groups, by Pamela Wood, Baltimore Sun); and
18	
19	WHEREAS, throughout the entirety of the COVID-19 pandemic, certain front-line workers
20	deemed essential—including health and elder care support workers, childcare workers,
21	grocery store employees, restaurant workers, commercial cleaning crews, landscape and
22	construction labor, and delivery and transit workers—have sacrificed and placed
23	themselves in harm's way as other Marylanders have adhered to the Governor's stay-at-
24	home order; we honor their service to our communities; and

26	WHEREAS, an increase to the minimum wage will benefit these essential workers and their
27	families, among all of Maryland's working families; and

29	WHEREAS, the first phase-in is scheduled to take effect January 1, 2021, increasing
30	Maryland's minimum wage from \$11.00 per hour to \$11.75 per hour; and

2	WHEREAS, while the present and near-future economic circumstances for Maryland generally
3	may be uncertain and rather bleak, for working families the financial strain resulting from
4	COVID-19 is certain to be much worse; and

6	WHEREAS, the Howard County Council accordingly believes that now is not the time to delay
7	the January 1, 2021-scheduled increase to Maryland's minimum wage, and that the Board
8	of Public Works should decline to exercise its discretion to do so; and

10	WHEREAS, along with many elected officials from across the State of Maryland, the Howard
11	County Council fully supports the goals of the Fight For \$15 Coalition to protect
12	Maryland's essential workers.

14	NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County,
15	Maryland, that we hereby declare our full support of the goals of the Fight For \$15
16	Coalition, and for maintaining the first scheduled increase to Maryland's minimum wage
17	enacted by the Maryland General Assembly in 2019, effective January 1, 2021; and

Testimony: Favorable Resolution CR-143-2020

Good evening Madam Chair, Vice-Chair and Members of the Howard County Council:

We cannot afford to live in a world, where others cannot even afford to live.

My name is Christopher Stevenson, and I serve as the Senior Policy Analyst with 1199SEIU- the largest healthcare workers union in the country. Our members are hospital and nursing home workers, but I'm here before you today to discuss all workers. Essential workers – including healthcare workers, sanitation workers, and grocery store workers, to name a few – are on the frontlines of the COVID19 pandemic, and most of them make under \$15/hour These workers are facing life and death situations every day due to current COVID-19 working conditions, so it is at the very least incumbent upon us to remain steadfast to ensure, workers receive a livable wage.

An increase in minimum wage offers the opportunity to sustain a life where the concerns of today are not the concerns of tomorrow. It allows businesses to receive more consumer spending, increases the circulation of overall spending, and as history has shown, it has helped the United States recover from economic turmoil like the one we're in now. But for the worker, it allows families to keep their homes, which in nature, is the very make up to every family's security and foundation. For this reason, we support Resolution CR-143-2020,.

We must keep in mind that a increase in minimum wage is not a pre-COVID or post-COVID issue, this is a human life issue. All too often we find ourselves in situations where we're able to purchase amenities or essentials, despite if we truly need them or not. Most workers do not have that luxury.
