


Introduced by: The Chairperson at the request of the County Executive

AN ACT making emergency appropriations pursuant to Section 610(b) of the Howard County Charter and amending the Annual Budget and Appropriation for Fiscal Year 2021 in order to receive additional grant funding from the State; and declaring that this Act is an Emergency Bill necessary to meet a public emergency affecting life, health or property.

1 **WHEREAS**, Council Bill No. 25-2020 (CB25) is known as the Annual Budget and
2 Appropriation Ordinance of Howard County, Fiscal Year 2021 and contains the capital and
3 operating budget for the fiscal year beginning July 1, 2020 and ending June 30, 2021; and
4

5 **WHEREAS**, because of the health emergency related to COVID-19, the State of
6 Maryland has awarded grant funds as part of an economic relief program to provide assistance to
7 restaurants and hotels, who have been severely impacted by the COVID-19 pandemic; and
8

9 **WHEREAS**, the County was initially awarded \$2,506,018 in grant funding from the
10 Maryland Department of Commerce as part of the Restaurant Relief Fund; and
11

12 **WHEREAS**, Supplemental Budget & Appropriation Ordinance No. 5 Fiscal Year 2021
13 (“SAO5 FY21”) transferred \$2,506,018 from the Grant Fund, Contingency Reserve to authorize
14 the distribution of the initial award of grant funding; and
15

16 **WHEREAS**, the County was recently notified that it will receive additional grant
17 funding in the amount of \$1,503,611 for restaurants from the Maryland Department of
18 Commerce as part of the Restaurant Relief Fund; and
19

20 **WHEREAS**, the County was also recently notified that it will receive \$1,625,891 in
21 grant funding from the Maryland Department of Commerce to provide direct assistance to hotels;
22 and

24 **WHEREAS**, following the passage of SAO5 FY21, there remains \$659,017 in the Grant
25 Fund Contingency Reserve which is not enough spending authority to accept the additional grant
26 funding recently awarded; and

28 **WHEREAS**, the Fiscal Year 2021 budget needs to be amended to receive and
29 appropriate the additional unexpected emergency grant funding; and

31 **WHEREAS**, pursuant to Section 610(b) of the Howard County Charter, this Emergency

1 Bill is necessary to meet a public emergency affecting life, health or property.

3 **NOW, THEREFORE,**

5 **Section 1. Be It Enacted** by the County Council of Howard County, Maryland, that the following
6 emergency appropriation of grant funds is authorized and approved for the fiscal year beginning
7 July 1, 2020 and ending June 30, 2021, as shown below:

17 year beginning July 1, 2020 and ending June 30, 2021, as shown below:

25 **Section 3. And Be It Further Enacted** that the Grant Fund total for Fiscal Year 2021 is
26 amended to be \$33,640,123 and all subtotals, totals, and other calculated figures in the current
27 expense budget may be adjusted, as needed, to accommodate this Act.

29 **Section 4. And Be It Further Enacted** by the County Council of Howard County, Maryland that
30 this Act is adopted as an emergency measure to address an immediate emergency affecting

- 1 *public health, safety, or welfare and having been passed by two-thirds of its members, this Act*
- 2 *shall be effective immediately upon its enactment.*

Governor Hogan has announced a new economic relief program to provide direct assistance to hotels across Maryland which have been severely impacted by the COVID-19 pandemic, as well as additional funds for restaurants out of the Restaurant Relief Fund. As such, Howard County has been notified that the Maryland Department of Commerce (Department) is granting State grant funds of \$1,625,891 for hotels in the County and an additional \$1,503,611 for restaurants. These funds must be disbursed to these businesses by no later than March 31, 2021, hence the reason for requesting emergency legislation. The grants can be used by the restaurants for working capital such as rent, payroll, and job training, purchase of equipment and services to expand outdoor dining such as tents, heaters, warmers, and carts, infrastructure improvements, such as HVAC system upgrades, technology to support carryout and delivery, purchase of PPE and disposable food containers or utensils, and sanitation services. The details regarding how the hotel funds may be used have not been received yet from the State.


Governor Hogan has announced a new economic relief program to provide direct assistance to hotels across Maryland which have been severely impacted by the COVID-19 pandemic, as well as additional funds for restaurants out of the Restaurant Relief Fund. The Howard County Economic Development Authority (HCEDA) understands that Howard County has been notified that the Maryland Department of Commerce (Department) is granting State grant funds of \$1,625,891 for hotels in the County and an additional \$1,503,611 for restaurants.

In the same manner as has been provided as part of the HoCo RISE Initiative for disbursing CARES funding for business assistance and the State's prior round of the Restaurant Relief Fund, the HCEDA will administer the intake and review of applications for these specified purposes and will deploy the application process quickly as these funds must be disbursed to these businesses by no later than March 31, 2021 for the purposes outlined in the grant and grant modification agreements.
