2 County Code provide for the County Executive to appoint and for the County Council to confirm  
3 nominees to Howard County Boards and Commissions created by law; and

4           **WHEREAS**, Section 6.335 and 12.1000 of the County Code as amended by Council Bill  
5 No. 13-2018 effective July 1, 2018, provide for a Local Behavioral Health Advisory Board in  
6 Howard County; and

7           **WHEREAS**, the County Executive has proposed the appointment of Ayesha Holmes as a  
8 member of the Local Behavioral Health Advisory Board; and

10          **WHEREAS**, pursuant to Section 12.1000(h)(6) of the Howard County Code, the Local  
11 Behavioral Health Advisory Board shall serve as Howard County's Local Drug and Alcohol Abuse  
12 Council, as provided by Section 8-1001 of the Health General Article of the Annotated Code of  
13 Maryland; and

15          **WHEREAS**, Section 8-1001(d) of the Health-General Article provides for 4-year terms  
16 for the members of the local drug and alcohol abuse councils; and

17          **WHEREAS**, the County Council ratifies the County Executive's special trust and  
18 confidence in the abilities of the nominee.
