**Section 1.306. - Executive exempt.**

(b) *Appointing Authorities.* Appointing authorities for Executive exempt employees are as provided in this subsection:

- (1) *County Executive.* The County Executive is the appointing authority for the:
  - Executive Assistant I, serving the Office of the County Executive;
  - Executive Assistant II, serving the Office of the County Executive;
  - Administrative Assistant, serving the Office of the County Executive;
  - Administrative Analyst II, serving the Office of the County Executive;
  - Chief Administrative Officer;
  - Chief of Staff;
  - DEPUTY CHIEF OF STAFF;
  - Director of Community Resources and Services;
  - Director of Corrections;
  - Director of Finance;
  - Chief of Fire and Rescue Services;
  - Director of Housing and Community Development;
  - Director of Inspections, Licenses and Permits;

1 Director of Planning and Zoning;  
2 Chief of Police;  
3 Director of Public Works;  
4 Director of Recreation and Parks; and  
5 Director of Technology and Communication Services.

10 **Section 1.406. Definitions.**

11 The following terms, as used herein, unless a different meaning is clearly implied by the  
12 context, shall have the following meanings:

13 (o) *Corrections employee* means a covered individual employed by the County in one of the  
14 following position classifications:

- 2229 Director of Corrections;
- 2227 Deputy Director of Corrections;
- 2225 [[Correctional Program Supervisor III]]CUSTODY AND SECURITY CHIEF;
- 2223 Correctional Captain;
- 2221 Corrections Program Supervisor II;
- 2219 Detention Center Nurse;
- 2217 Correctional Lieutenant;
- 2215 Correctional Specialist II;
- 2213 Correctional Specialist I;
- 2212 Correctional Technician;
- 2211 Correctional Sergeant;
- 2210 Correctional Sergeant- Dietary
- 2209 [[Correctional Supervisor I]]CORRECTIONAL DIETARY COORDINATOR;
- 2207 Correctional Corporal;
- 2205 Correctional Officer;
- 2203 Probationary Correctional Officer; or
- 2201 Correctional Dietary Officer.
