#### Dear Council,

As a member of the Bain 50+ Council and Howard County resident who is in her 50's, I \*really\* hope you \*fully\* fund the renovation of our sister center - the East Columbia 50+ Center. The two centers are both in the same umbrella and yet it somehow seems like East Colmbia is getting left in the rain while the powers that be had Bain covered. The Bain 50+ Center is looking brand spanking new while East Columbia has just been getting spanked, and through no fault of their own that I can tell. I care about the welfare of my little sister and would like to see her supported in growing up to be as big and beautiful as Bain.

In 2020, there was \$17,793 in funding for each student in the K-12 age range while only \$14,762 was actually spent on their education (and Howard County is usually higher in total revenue per pupil than most other MD counties, so I suspect their funding was higher than the average). Howard County in 2020 spent 64% of the total County General Fund on education, by which I believe they mean public schools for those K-12 and not seniors (please correct me if I am reading the below data incorrectly).

Children 5-18 make up about **18%** of the HC population (2019 stat) according to <u>https://www.census.gov/quickfacts/fact/table/howardcountymaryland/PST045219</u> and yet they are getting **64%** of the budget. And this while seniors make up 1/3 of the Howard County population. People chant that Black Lives Matter, and they do, but so do senior lives.

It is my view that seniors deserve a bigger piece of the pie than they are currently getting. A larger and better senior center in East Columbia would help there. And it seems there is more funding for public school education than is being used, so there is a pot to draw from toward this cause. From the census info, there are approximately 63,500 children who are public school aged in Howard County and there is a surplus of over \$3,031 per child toward their education, so that comes to \$192,468,500 total that could be directed elsewhere, which is way more than the center's renovation would take (if it isn't, someone needs to shop contractors better).

I know it was yesterday that was National Super Hero Day, but don't let that deter you from being a super hero for seniors on the day of the vote for this renovation. We voters will be paying attention to which cape you pull out of your closet that day. Try not to be Dr. Doom.

If the decision this year is to yet again not approve the renovations, I would appreciate knowing the thinking behind that choice.

Councilwoman Jung and all council members.

I urge you to read the information presented in this email.

In my professional opinion, the Department of Public Works, and the Administration, by not finding a replacement location for the Banneker Fire Station in downtown Columbia, are blatantly violating, and ignoring section 125.0.9.g.(6) of the zoning regulations, as quoted below. This is in addition to ignoring and violating other related subdivision and land development regulations, and zoning regulations and Plan Howard 2030 policies, that I quoted in my 4/19/2021 email to executive Ball with copies to you and all other council members.

The existing Banneker Fire Station is situated on Open Space lot 12 as depicted on the Final Development Plan (FDP) titled, "Columbia Town Center Section 1 Phase A 5".

Lot 12 is defined on page 3 of the FDP under section 125C-3-d. B as follows "Lot 12 shall be used for all open space uses including but not limited to use as a public service building and a community fire station".

Section 125.0.9.g.(6) of the zoning regulation states, "land designated as open space on a final development plan recorded prior to April 6,2010 on which a public facility such as library or fire station has been constructed, may be designated as downtown mixed use on an amended Final Development Plan, but may only be redeveloped after a replacement public facility is operating at an alternative location within downtown Columbia." Since open space 12 is designated as open space land on an FDP that was recorded on 2/11/2002 as plats 15235-15240, the criteria under section 125.0.9.g.(6) are applicable to it. Redeveloping the Banneker fire station will require that the county finds an alternative site <u>within downtown Columbia</u>. Cedar Lane Park East is not part of downtown Columbia, it is zoned R-20 and not New Town (NT), and therefore cannot be legally used as a replacement site for the Banneker Fire Station.

I viewed the work session on 4/21/2021, and was encouraged by your, as well as other council members, line of questions to Mark Stromdahl and Fire Chief William Anuszewski.

Being a professional Engineer in the field of Civil Engineering and providing land development engineering services in Howard County for 35 years, it became evident to me very quickly, that the county did not do their due diligence when selecting Cedar Lane Park East as a site for the fire station.

First, it is evident that no one at public works or the administration is attempting to pay any attention to the regulations that everyone else must adhere to.

Second, due process as it relates to proper public notice and public involvement in the process was completely ignored by both, the Department of public works and recreation and parks.

Third, no attempt by the Department of Public Works to find alternative sites that will not have irreparable deleterious impact on the quality of life and property values of the neighboring properties. In fact, there seems to be arrogant zero care about the negative impact to the neighbors.

Fourth, no preliminary investigation regarding traffic, access, stormwater, and noise.

I urge the Howard County Council to not approve any FT 22 capital or operating funds as they relate to the fire station and park "improvements" for Cedar Lane Park East (F5976 and N3108).

Dear Executive Ball,

1) My name is Zacharia Y. Fisch. I am a resident of Columbia for 35 years, and for the last 26 years my family and I live at 10863 Beech Creek Drive Columbia MD 21044. In addition, I am a professional licensed Civil Engineer based in Howard county; for the past 35 years I have been designing land development projects in Howard County and the surrounding counties.

2) In early March 2021 I received a notice in the mail, from Howard County, informing of a community outreach meeting scheduled for March 25, 2021 at 7pm, regarding the

North Columbia Fire Station F5976. I attended the meeting, in which <u>I heard for the first</u> <u>time</u>, that a fire station is proposed to be built at the Cedar Lane Park East on the front multipurpose field. I also learned about the planned intensification of use of the park with the addition of exercise equipment, Pickleball fields, artificial turf field, and lights that will be operating until 10:00 or 10:30 at night. In this outreach meeting, I also learned that the original proposed location for the fire station was in the village of Harpers Choice, near Harpers Choice Middle School.

3) In a letter that you sent to Chairman Jung on June 10, 2020 you wrote, and I Quote: " Contrary to characterizations by some, the North Columbia Fire Station project has been supported by a robust and extensive public outreach process. County representatives have publicly presented on this project on at least three occasions (February 12, 2019, October 30, 2019, and March 3, 2020), and different options for locating the Fire Station were discussed with you and your staff on four (4) separate occasions in 2019. Consideration of feedback from the public and your office led to the proposed location of the Fire Station being adjusted early this year. The new proposed location was presented to the Harpers Choice Community Association on March 3rd and received favorable feedback from board members."

4) The fact of the matter is that the Beech Creek community that consists of approximately 145 households, the Cedar Manor community that consists of 19 households as well as individual properties adjacent to the park on the east and along the north side of RT 108 are not represented by the Harpers Choice Community Association / village board. Therefore, any discussions and any agreements that were reached between the Harpers Choice Community Association and Howard county representatives are not representing or reflecting the voices or opinions of many households, that neither were invited to the meetings nor had a say in the reached solutions.

5) Since the meeting on March 25, 2021, I met residents who live in the Elliot's Oak neighborhood, some of which are backing the park, who were not aware of the proposed plan. In total, I estimate that there will be over 200 plus households that will be directly impacted by this proposal.

6) In my research of the Recreation and Parks Advisory Board meetings minutes and agenda, I saw several references to the proposed fire station location:

a) On January 15, 2020 minutes under the Old Business category, "Department of Public works is inquiring about building a fire station on existing field space at Cedar Lane Park".

b) On July 15,2020

c) On February 17, 2021 where under the Old Business category it says "met with Administration and Bureau of facilities regarding North Columbia Fire Station project....."

7) It is disturbing to see that for a whole year the Recreation and Parks Advisory Board as well as the Department of Public Works and the Administration knew of the intended project, yet there is no public outreach to Howard County residents, who live next door to the park.

## SUBDIVISION AND LAND DEVELOPMENT REGULATIONS:

## 16.101.(a) legislative intent

I. Assigning orderly, efficient, and integrated development of land

II. providing the most beneficial relationship between the uses of land and buildings and the circulation of traffic throughout the county.

III. Using the land and buildings in ways which avoid traffic congestion, and which provides for pedestrian movement.

## 16.119.14.b.(4) Combine Driveways.

Traffic movements in and out of commercial and industrial areas shall not interfere with external traffic nor shall the movement create hazards to adjacent residential areas.

## 16.119.(f). (3) Access Restrictions

For subdivisions and Site development plans with no other means of access except from a restricted access road, the Department of Planning and Zoning may approve a single use in common driveway that meets the minimum sight distance requirements of the Design Manual or the State Highway Administration access requirements.

## 16.120.(a). (2) Lot Layout. Lot access from Arterial Highways or Major Collectors

Nonresidential lots shall not derive direct access from Arterial Highways. Where nonresidential lots front on such roadway, access to the lots shall be in accordance with 16.119 of this title.

### ZONING REGULATIONS:

### 100.0.A Legislative intent:

I. To provide adequate light, air, and privacy. To secure safety from fire and other danger and to prevent overcrowding of the land and undue congestion of population.

II. To protect the character, the social and economic stability of all parts of the county. To guide the orderly growth and development of the county and to protect and conserve the value of land and structures, appropriate to the various land use classes established by the general plan for Howard County and by the comprehensive zoning regulations.

III. To provide the most beneficial relationship between the uses of land and structures and road system, which serves these uses. Having particular regard for the potential amount and intensity of such land and structure uses in relationship to the traffic capacity of the road system, so as to avoid congestion in the street and roadways,

and to promote the safe and convenient vehicular and pedestrian traffic movements appropriate to various uses of land and structures throughout the county.

IV. To provide a guide for public action in the orderly and efficient provision of public facilities and services.

## PLAN HOWARD 2030:

#### Policy 8.12, page 179.

"Expand the county park system and recreational facilities."

8) In my opinion, the county is falling short to meet its own subdivision and land development regulations, the Zoning Regulations and Plan Howard 2030 policies as outlined above. I believe that Howard County should be subject to all rules and regulations as everyone else who is engaged in developing land.

9) MD RT 108 is classified on the Howard county transportation map as a minor arterial road, and indeed it is a busy road. Over the past 26 years that I am living in the Beech Creek community, I can see the constant increase in traffic. During sports season, the traffic is congested, and it is backed up starting at Centennial Lane and continues to RT 108 west reaches next to Beech Creek drive and sometime further on. Every Friday and during holidays, the Howard county police has to direct traffic on RT 108 to enable ingress and egress traffic to the Dar Al-Taqwa Mosque. The Mosque is located across the street from the park. Adding more uses and facilities to the park and adding more traffic from the fire station will make things worse.

10) Being in the land development engineering business, I have not yet heard of a single case where adding a fire station near an established residential neighborhood enhances quality of life or property values. Per the Zoning regulations it is the county's

duty to protect the residents' quality of life and property values. By placing the station where proposed, the county will be abdicating their responsibility.

11) I truly believe that there are better, more appropriate alternative locations that will closer meet the legislative intent of the regulations for the proposed fire station. I reviewed options within about 1.5 miles radius from Cedar Lane Park East for the potential of placing a fire station. Both alternatives are zoned R-20 same as Cedar Lane Park and both are owned by Howard County:

a. The Board of Education owns 28.67 acres at 10910 RT 108. The site is 0.4 miles west of Cedar Lane Park East. I carefully examined the existing site development plan, and forest conservation plat that are on record, and I conclude that there is enough space to accommodate the proposed fire station on the property.

The advantages of utilizing the Board of Education property are primarily based in the fact that the infrastructure is in place, the character of the site is non-residential, and that there will be minimization of adverse impact to residential properties and there will be no loss of Park land.

b. A 7.05-acre property owned by Howard county department of Recreation and Parks located at 9944 Rt 108. This property is located approximately 1.5 miles east of Cedar Lane Park East. This is an undeveloped parcel with an existing single home on it. In my opinion, there is plenty of space to install the station and derive access through Centennial Park or directly onto RT 108.

There is 1 residential private property to the west of this parcel and to the east there are parcels of land that have structures on them, and they are all owned by Howard county.

12) To conclude, in my professional opinion, the proposal to install a fire station on the multipurpose field and intensifying the use of Cedar Lane Park East by adding facilities and lights that will intensify the use and increase the hours of operations into the night violates the regulatory intent of the subdivision and zoning regulations. An

alternative site that will be in full compliance with the regulations stated in this letter should be sought out.

#### SECAC Budget Testimony to County Council

Good evening, my name is Mai Hall and I am speaking on behalf of The Howard County Special Education Citizens Advisory Committee (SECAC) who advises the school system on the needs of students with disabilities. Our focus is on the special education priorities within our public school system. More importantly, I am the parent of two children with disabilities and an advocate for our community of over 8,700 students with disabilities<sup>1</sup> in the public school system.

According to the Howard County Proposed Operating Budget Priority Areas, you state the need for "Ready and Successful Students" to "Prepare our children and support teachers, close the achievement gap, promote college and career readiness. Support learners of all ages."

According to a press release by Dr. Martirano, "Special education is a priority of the budget proposal. A \$15.1 million investment for special education includes 216.8 new staff positions." Special education has been historically underfunded. HCPSS heard testimony from several special education teachers last school year about the large number of students with disabilities in their classrooms. They are short staffed. The population of our students with disabilities grows every year, in fact it grew by 10% last year<sup>2</sup>. An accurate, growing budget to accommodate those increase in numbers must be achieved if our county is to "close the achievement gap" as your Priorities state.

You say you want to "prepare our children" and "support all learners of all ages" yet data shows a different story of our students with disabilities who are not prepared and not supported. The Howard County 2018-2019 Report Card illustrates the math and English language arts achievements of students with disabilities as the lowest amongst diverse populations, English Language Learners, and Economically Disadvantaged<sup>3</sup>. The graduation rate for students with disabilities stands at 67%. Howard County is not preparing our students with disabilities for contribution to larger society once they leave our four walls.

Valuing special education is not just the right thing to do, it is a long-term cost savings mechanism. If you look at special education programs through a return-on-investment lens, students and taxpayer's benefit. We know that every \$1 invested into early intervention services, that is special education for birth through age 2, yields a 13.58% return per year over that child's lifetime<sup>4</sup>. An "Academic return on investment (ROI) seeks to maximize achievement for the greatest number of students, given available resources."<sup>5</sup> Invest in special education

Current needs are not being met; related services are not being done to their fullest extent. Which means, our students will fall further and further behind. Now is the time to fully fund special education so HCPSS can do its due diligence to educate and support our most vulnerable population.

I was shocked to read in the Howard Sun article on the 2022 operating budget (\$1.88 budget proposed by Ball") that the proposed body cam program for the police and sheriff's departments will require 10 new positions in the police department and 13 new positions in the State's Attorneys office. According to the article, the 13 state's attorney positions will be for reviewing the footage. It is hard for me to believe this kind of staffing is necessary; surely footage will only be reviewed if there is some question or controversy, not every time an officer has the camera running.

If a body cam program requires this kind of overhead, I would have to question whether this is a cost-effective way to use my tax money. The instances in which the evidence is needed are certainly significant ones, but they are rare, and I would suggest that mental health support or better psychological screening for law enforcement recruits might be better, if less exciting alternatives.

I tried to look at the budget document and confirmed the positions are there, but I could not determine what they will be used for. Perhaps the article is not accurate. I hope you will find out, and if it is accurate I hope you will urge your fellow council members not to support the program but to ask Dr. Ball to find better alternatives. We need programs that work and spend our money wisely, not just whatever program happens to be popular in the media.

Last but not least, Savage has many low income people residing in town. The First Baptist church has a food pantry that helps to feed people in town. But If some of the recently acquired park land near the Savage Mill could be used to provide a community garden, then the community could grow vegetables to feed some of the low income residents. Our small community cares about the less fortunate and we try to help those in need. Having some land in which to grow vegetables would help immensely to feed our needy neighbors. Dr Ball and Council Members -

Now that we are aware of the specific \$4.5 million proposed cut to the East Columbia 50-Plus Center budget, we would like to expand a bit on our comments sent on 19 May 2020, as follows:

- No one will deny that situations such as the Ellicott City flooding and the current COVID-19 pandemic are critical issues, but it is now appearing that "emergency" needs will always trump those of Senior Citizens in Howard County. As long-time residents and taxpayers in East Columbia (since 1975), it is demoralizing to be the only part of the county without an adequate 50-Plus Center. This year funds were made available for AGAIN renovating the Bain Center as patrons of both centers, we found this unnecessary and inexplicable, especially since those funds could have been applied to the East Columbia Center.
- In the recent past the East Columbia Library (which houses the 50-Plus Center) was "renovated," not to increase library storage, books, or functions, but to increase child-care facilities there. While acknowledging the interest in providing Howard County children with the finest facilities and services that money can buy, it seems unfair to do so at the expense of Seniors no improvements were made to the tiny 50-Plus Center.
- We strongly believe that it is in the best interest of Columbia and Howard County to attract and accommodate those of us who have spent our adult lives and careers living (and, as noted above, paying taxes) in Howard County and chose to retire here. We contribute fiscally, socially, and culturally, and having a vibrant and welcoming 50-Plus Center would add immeasurably to our lives.
- Senior citizens should be on an equal footing with other demographic groups. It is difficult enough to deal with the aging process, but to feel that as a political group we are "throw-aways" is disheartening. This is doubly true for residents of East Columbia, which often does not receive the same attention as other parts of the city.
- No tax increase is popular, but the proposed recordation and transfer tax increases seem eminently reasonable in that they likely will not affect the most financially vulnerable portion of the population. If Howard County REALLY wanted to be fair to its citizens (and improve its tax base), the Council would be looking at increasing developers' fees across the board: not only are Howard County's real estate developers' fees ridiculously low, but they are incredibly unfair to the County, which ultimately uses tax-payer money to remediate or provide what developers in other Maryland counties pay for up-front.

Please support full funding for the East Columbia 50-Plus Center in the upcoming Fiscal year. It is the right thing to do, in all respects.




# East Columbia 50+ Center Located In A Senior "Hot Spot"



Also objectionable is changing the grass field to artificial turf. From everything i've been reading it seems to be unhealthy for the environment. Putting down sand instead of using soil puts more CO2 in the air instead of keeping it in the ground. There are chemicals released from the plastic and recyclable tires which are harmful to every living being in the area. Plastic grass heats up more easily creating an environment hazard to our health. – its life isn't that long. Turf gets trampled on and quite soon looks poor. 



Good evening Chair Walsh and members of the Howard County Council,

Thank you for this opportunity to speak to you tonight regarding the Capital Budget for the Howard County Public School System. My name is Samuel Hahn a resident in Columbia and I am the Executive Director of Oakland Mills United and speaking on behalf of this organization.

Tonight, I am focusing on the HCPSS Capital Budget and addressing an alarming problem: Building Maintenance.

I first want to thank this county council for your commitment to funding the construction of Talbott Springs Elementary. This has been a project that has been pushed and deferred year after year. This is a projected that was needed years ago when I was a student at Talbott Springs and I have now graduated from the school system. I urge the council to continue your support and commitment by voting to approve all needed funds for Talbott Springs Elementary.

The Howard County Public School System has time and time again continued to defer building maintenance for the schools in the Oakland Mills cluster. Out of the school systems \$804 million in deferred capital maintenance, there is \$230 million, 28.5% of all deferred maintenance, impacting the students and staff of Oakland Mills cluster schools. Why is 28.5% of all HCPSS deferred maintenance in five Oakland Mills Cluster schools: Cradlerock and Jeffers Hill Elementary, Lake Elkhorn and Oakland Mills Middle, and Oakland Mills High School. The Oakland Mills Cluster has been deferred year after year and also consists of the oldest schools both in this school system and on the list for deferred maintenance.

Especially today, there are many concerns that a significant amount of that deferred maintenance is for HVAC system renovations and replacements. According to the Office of Building Maintenance's Deferred Maintenance List for FY2020, which is attached in my written testimony: Jeffers Hill Elementary was scheduled for a

"renovation and HVAC replacement" which was deferred back in 2014. Cradlerock Elementary and Lake Elkhorn, which share one building, was scheduled for a HVAC replacement, which was deferred back in 2015.

Out of these five OM cluster schools why is 20% of the entire HCPSS deferred maintenance in two schools? Oakland Mills Middle has about \$51 million in deferred maintenance, which includes replacing the HVAC system and other projects listed by this school system, indicating numerous other items that need to be replaced and renovated for student safety, which I have attached in my testimony.

Oakland Mills High School has over \$110 million in deferred maintenance with \$38 million set for a "major HVAC renovation". From the HCPSS deferred maintenance list: "When originally deferred, this was a major HVAC renovation project; however, it has been nine years since the project was deferred. Current conditions at the school now require a full renovation. It's not practical and cost effective to maintain the system any longer. Due to the fact that the system is old, obsolete and continues to be problematic we are unable to provide a conducive- learning environment to both the students and staff." (Full report is attached below).

Oakland Mills High School is in desperate need of a systematic renovation to ensure a safe and healthy learning environment for all students along with staff members.

In perspective, the total budget of HS 13 costs about \$135 million, and of that \$135 million, almost \$108 million is for the base construction (Source: HCPSS Construction Document Presentation for HS 13).

In perspective, the cost of a full systematic renovation of Oakland Mills High School costs \$110 million. According to this comparison, it is cheaper to knock down Oakland Mills High School and rebuild it because of the systematic problems and neglections this school has faced due to years of deferred maintenance. Only Oakland Mills Middle is on the Capital Improvement Plan while other schools in the cluster have not reached the Capital Improvement Plan or even the Long-Range CIP. This is outrageous and the

students, staff members, parents, and community members have constantly voiced their concerns and pleaded for our schools to be on the Capital Improvement Plan.

Why is this the case and why is this the trend for Oakland Mills cluster schools? Why are newer schools receiving building renovations and additions while the county's oldest schools continue to be neglected and are degrading despite pleas from school staff, students, parents, community members, and even alumni.

I understand that funding requests for these major projects were not requested, but I hope that the county council keeps these major concerns in mind. I urge the County Council to press the Board of Education on why this is the case and work with the Board of Education to fund the long needed systematic building renovations for Oakland Mills schools.

Thank you for serving Howard County during these challenging and unprecedented times. I hope that you will remember and act on the issues impacting the Oakland Mills cluster schools and treat Oakland Mills schools equitably.

The Columbia Downtown Housing Corporation (CDHC) supports FY 2022 Capital Budget Project F5976 - No. Columbia Fire Station. The requested \$1.7M together with prior appropriations will advance construction at the new location resulting in the new Fire Station becoming operational in FY 2023. This timetable will:

- address existing shortcomings in fire service to the North Columbia area;
- proactively address the future fire safety needs of the planned new residential, commercial and job growth in Downtown Columbia over the next 10 years; and
- enable the timely redevelopment of the aging and out-dated Banneker Fire Station along with 100 units of affordable senior housing.

FY 2022 funding for the North Columbia Fire Station is critical to improving the County's fire response and preparedness and meeting its commitments under the Downtown Columbia affordable housing plan as outlined in the Development Rights and Responsibilities Agreement (DRRA). For these critically needed senior units to be built and occupied, the current firefighters at Banneker must relocate and operate from the new North Columbia Fire Station. Any delay in the completion of the North Columbia Station impacts planning and construction for the new Banneker facility and stresses both the county's fire safety efforts and its support for low-income and vulnerable seniors.

The North Columbia Fire Station project proposal has been adjusted to address community concerns. Initially, the fire station was proposed to be constructed at the site of the old Cedar Lane School. Due to concerns about proximity to school-aged children, the site was moved to Cedar Lane Park East with the addition of replacement fields at Harper's Choice Middle School to offset the loss of a field at Cedar Lane Park East. Concerns about the environmental benefits of the land proposed for the replacement fields resulted in further changes. The current plan maintains the station at Cedar Lane Park East off Route 108, and upgrades existing park facilities.

The North Columbia Fire Station is not expected to have an impact on County debt service obligations because the proposed funding source is County Fire Tax Revenue.

Please vote YES for funding for F5976 – The North Columbia Fire Station, which will proactively improve the County's fire safety and responsiveness and ensure timely development of 100 new affordable housing opportunities for our ever-increasing numbers of seniors.

#### Esteemed members of the Howard County Council

Why are you treating your constituents with such contempt? Are you not meant to represent all the beautifully diverse members of our community? When I first heard of your plans to develop a fire station on route 108, tearing up perfectly good and wellbeloved park land in the meantime, I thought that a council which values community and the environment would surely not permit the destruction of forest and public space. But the more I hear of the proposed plans, the more foolish and downright mean spirited these plans seem to become.

This fire station will go directly across the street from a very well attended Mosque, one of only three in the whole of the county by the way. What do have against the Muslim community that you feel the need to have sirens interrupting their services? Instead of listening to the beautiful calls to prayers, they will potentially get to hear wailing alarms. Not to mention, possibly preventing them leaving and entering their worship space as that road is already so narrow that they often have local police help with the traffic flow during their services.

Furthermore, what is this about using Astroturf on the fields? Do we live in a desert? Have we not had record rainfalls in the last few years, to the point that the county has had to invest millions of dollars into water diversion development? Development which we probablyWhere is all the water run off going to go when that field gets flooded? Plastic, as far as I am aware, cannot absorb water. Not to mention, all the micro plastics from the Astroturf will pollute our local creeks that inevitably flow into the bay. We do, after all, live within the Chesapeake watershed. Has there been an environmental impact study done? Will this undo the millions spent on the water diverting that has had to be implemented because previous representatives rushed forward on real estate development?

But the proposed measure that really makes me the most upset is what is planned for the future Banneker fire station. This plan has the audacity to place low-income housing on top of a fire station. Just because the people who will inhabit that building are impoverished you really believe that they do not have the right to a peaceful life. They are impoverished, not deaf! This plan feels like it can subject the future inhabitants to noise at all hours of the day and night because they are low income. I know it can be argued that the emergency vehicles can wait to clear the area. However, I have stayed in the apartments across from it and know that is simply not how it is done. Also, I have worked in low-income communities and know firsthand how difficult the system can make it for them to succeed, yet this plan places them in housing that no one would want unless they were desperate. This plan is just downright despicable and those who came up with it ought to feel ashamed.

Indeed, the only positive outcome that I can think of for this proposed plan is having an emergency response vehicle on hand for the traffic accidents that are bound to occur right outside its driveway as a result of a fire station being placed at Cedar Lane East.

Now, I understand that there is a sense of urgency as the previous location was determined inadequate. However, I must urge you to not rush this process as the long term consequences could cost the county and your constituents so much more. I had always loved that our community was both economically and culturally diverse, one that is sensitive to our environmental impact. However, this proposed plan is an affront to the minorities, low income and the environment of our neighborhood. How can a government which is meant to represent the people, not uphold those values?


There has to be a better solution/locale for this project. Please do everything you can to prevent its becoming a reality.

#### Testimony to the County Executive Budget

On the East Columbia Senior Center – April 20, 2021

Good Evening.

I am Pearl Atkinson-Stewart 7190 Lasting Light Way, Columbia 21045

I am a 48-year resident of Owen Brown, and I am "Ageing in Place" as a widow. One uplifting thing for me is to be able to socialize and exercise at the Senior Center.

For 10 years, I have been an advocate for replacement of the outdated, insufficient, Senior Center in East Columbia. It is overdue!

Last year, I was devasted when the Council did not fund this Center. I am really urging you to fund this Center. There is now \$1 million dollars from the State Delegation to help offset the cost. They Care, and I know you do too. Yes, you have many projects to consider, but consider that this project is different. It is 95% ready to go, it is "Shovel Ready". This alone makes it a priority to complete. The second reason is that County Executive Ball has emphasized that this is a "Priority" project. What on earth could prevent anyone of you to not vote to fund this project?

Councilpersons, please listen to me, every other community has in place updated or new senior centers. All we ask is equity. Do not leave us as the "forgotten" group. Seniors are volunteers, I have volunteered for 44 years, and I believe that we are the backbone of our County that made it great place to live. Is it not time to give back!! Good evening County council members and citizens,

My name is C.C. Speight. I am here to testify in favor of the Capital Budget for FY 22, and the construction of the North Columbia Fire Station. As the President of St. Florian's Brigade, and a Battalion Chief with Howard County Fire and Rescue, I can whole-heartedly attest to the fact that service is at the heart of all we do. The plan for construction of the North Columbia Fire Station reflects our commitment to serving you, the citizens of Howard County, by positioning ourselves better to quickly deliver life-saving fire, rescue and emergency medical services to an area of the county that has been underserved for far too long.

It is not my intention to belabor you with statistics. I am not an expert in data analysis. My expertise is in delivering emergency services alongside the dedicated women and men who have also sworn an oath to answer your calls. Above all else, what that expertise has taught me is that minutes *matter*. Minutes are the difference between extinguishing a trash can on fire in a house and extinguishing a house that is on fire. Minutes are the difference between weeks of recovery from a stroke and years of rehabilitation. Minutes are the difference between walking out of the hospital following a heart attack and being rolled into the morgue. Not *once*, in my 15 years in the emergency services have I ever had a citizen complain that we arrived at the scene of their emergency too quickly.

With that said, I'd like to share one of my favorite interactions during my time here in Howard County: A teacher who called the fire station because she was organizing a reunion at her elementary school down the street. She told me that when her classmates asked her to make the evening a compilation of their most beloved memories from their time at the school, she combed her house for inspiration. She found, on her mantle, an old photo of her elementary class with their neighborhood fire engine. At that moment, she knew just who she would invite to the party.

I relate this story to say, that this discussion isn't just about response times, feasibility studies, and traffic patterns. It is about community. A fire station is a pillar of the community that is available 24/7/365. It is woven into the tapestry of the neighborhood as a place to learn about health and wellness, and a place to stop in and get a blood pressure check, or a home safety inspection, or a smoke alarm installed. As a department, we have been to countless block parties, birthdays celebrations, and other milestones.

We take pride in our ability to engage with the community and collaborate to make your neighborhood the most enjoyable place it can be. We will seek your input to address your concerns and determine how we can check our apparatus and operate our equipment without being a disturbance. We utilize the latest technology to contain sources of hazardous materials and toxins to keep the community, ourselves, and our families at home safe from illness. It is against, literally, everything we stand for as an organization to do anything less than work with you to be a positive presence in the North Columbia area and to offer you the safety and security you deserve at minimal additional expense.


## Community Noise Level Data?
