I have two comments/questions so far regarding the redevelopment of the Village Center.

- I noticed that the StoneHouse and the Art Center are labeled as "future development area" in one of the drawings of the center. Regardless of the possibility of these buildings being demolished in a future phase, will there be meeting rooms available in the redeveloped village center available for rent? We hold our Association meetings in the Jeffers Room and sometimes Tamar Room of the StoneHouse, but find the facilities to be run down and extremely dated with absolutely no technology and barely acceptable climate control. The availability of modern furnished meeting spaces equipped with audio-visual equipment would be a huge benefit to the Village Center and the surrounding area.
- I read the info regarding the micro-grid of electrical production and the possible interconnection to the nearby Long Reach High School. I would be interested in hearing if there would be a possibility for our Association to join this grid in some capacity to power our common areas, or, at a minimum purchase some electricity from that grid. I would also be open to entertaining the idea of mounting solar panels on our 10 large buildings to connect in as well (maybe with a partnership with the county or whomever ends up owning the grid).
