Dear Chair Walsh and Council Members,

Local elected officials, candidates, and even private citizens *and their families*, are routinely targeted with personal attacks, "doxxing," weaponized MPIA requests, and outright lies about their views and actions. (Again, I speak from personal experience.) This toxic local climate has become so ugly, it has already begun deterring people from running for office or seeking to serve the community in other ways, for fear of being targeted. If these tactics are perceived to be successful, they will only increase. How much harder will it become to find qualified people willing to serve on Boards and Commissions? (As you know, the County Charter was recently amended to shorten the terms of most Boards and Commissions - precisely because it's *already* difficult to find qualified people who are willing and able to serve.)
