Dear Councilmembers,

I am the Executive Director of the Indian Cultural Association of Howard County (ICA) and a longtime resident of Howard County. My thoughts below are echoed by members of our community. I was asked to write to you by an overwhelming number of people in our community, out of an outpouring, from a feeling of helplessness and a tremendous sense of vulnerability, and fear for the future of our children and the community we live in. People are fearful of raising an objection. In speaking out, they are branded Islamophobic, misogynist, racist or other.

I am compelled to write you and urge you to reject Ms. Sabina Taj's nomination to the Howard County Library System's (HCLS) Board of Trustees. Taj's appointment to the HCLS Board will adversely impact Howard County residents and will undermine the County's goals of diversity and inclusion.

Ms. Taj's tenure at the Board of Education was riddled with controversy and questionable conduct. She lacks the support of the community and is not suitable for this position. Many in the community are alarmed by her involvement with the Rouse project and are dismayed that Ms. Taj is being considered for a position that would significantly impact all Howard County residents.

Ms. Taj held public office. She has a record. She is answerable for her actions and cannot scream Islamophobia or misogyny, or racism or whatever, every time she is called out for her actions. These cannot be the alternates to thoughtful debate and inquiry. Questions related to ethics violations have been raised by members of our community. I believe Ms. Taj should address these publicly instead of having her political allies, including organizations such as CAIR (Council on American Islamic Relations), a group known to have terror ties, proclaim victimhood on her behalf.

Even more troubling is Ms. Sabina Taj's HINDUPHOBIA which was on full display when she wanted the Howard County Muslim Council to pick <u>HALF</u> of the movies the Indian Cultural Association was showing during movie night(s) at the Clarksville Commons. Her demands were preposterous and completely inappropriate. It does however give us a window into her thought processes and her inclinations.

ICA chose movies without consideration of race or religion. Taj, a public official, attempted to exercise undue influence on a public charity to advance her personal, 'religious activist' agenda.

We are seeing these seeds of extremism play out in the world today. Her outlook stokes racial division and promotes religious intolerance. It disqualifies her from any public office in this or any County in the United States. Ms. Sabina Taj's nomination must be withdrawn.

I am alarmed that Sabina Taj runs to the Muslim Council before watching a BOLLYWOOD MOVIE. If we are to consult or seek the approval of the Muslim Council for something as inane as movies, I suspect that every action/decision of *Ms. Taj will be a proxy vote for the Muslim Council*. Additionally, if this is the standard we are to follow, we must ensure that all faiths are represented on the HCLS Board of Trustees. We must make sure that we are treating ALL religions equally and are INCLUSIVE. If the County is to proceed with this candidate, I would recommend making room (additional seats) for representatives of the Christian, Jew, Hindu, Sikh, Jain, Buddhist, Parsi, Baha'i faiths, as well as atheists & agnostics, to be representative of the people you serve.

I strongly recommend that in light of Ms. Sabina Taj's religious activism, her ties to the Howard County Muslim Council be examined thoroughly. Taj's prior votes, while she was a Member of the Board of Education at the Howard County Public Schools, must also be scrutinized. Ms. Taj's email and phone records will reveal this information. As a Board of Education member, Ms. Taj had the duty to watch for the interest of every child, not just that of one single, religious group.

Regarding the claims made by Ms. Taj's supporters that she was just trying to be inclusive, let me put it in plain words. Ms. Taj did not care for the inclusion of the other religious communities — Hindus, Christians, Jews, Sikhs, Buddhists, Jains, Baha'is, Parsis, etc. from this exercise in inclusivity. Apparently, Ms. Sabina Taj's inclusivity doctrine begins and ends with Muslims. Taj wants half the proverbial "pie" for the Muslims, at the expense of all others. She seeks to disproportionately advance the Muslim cause. Ms. Taj is divisive and Muslim-centric, to the detriment of all other religious groups in Howard County.

Taj's affiliations, prior actions, and comments are divisive; Her Muslim-centric outlook **DISQUALIFIES** her from serving on this sacred institution. It is apparent that she cannot fulfill her duties impartially, without prejudice. If Ms. Taj is appointed, it will be disastrous for Howard County. Her appointment runs the risk of undermining the entire library system and its efforts to be inclusive.

Indian Americans are the largest immigrant minority in Howard County, and we reject this polarizing, Hinduphobic candidate. **Howard County** must reject divisions along religious lines or risk its slide toward **becoming a theocracy.** As a public servant, championing only one religion (her own), at the expense of all others, is grossly unethical, extremist, and **fundamentally un-American**. Sabina Taj is free to advocate for the Muslim Council as a private citizen, but such people should never be entrusted with public office.

I strongly urge you to REJECT this candidate and nominate someone who will be INCLUSIVE and consider the wellbeing of the ALL Howard County residents.

A few years ago, a member of the Columbia Democratic Club, Mr. Bob Ford was appointed to the Human Rights Commission. He went on to serve as the Chair of this Commission in 2020. During his tenure as Chair, Mr. Ford declined to stand for undocumented immigrants who were detained by Immigration and Customs Enforcement (ICE) at the County's detention center. Instead of standing with the immigration advocates, he covered for the County Executive's incomprehensible resistance to cancel the contract. Even though Mr. Ford finally voted to cancel the contract, it was too late. The fate of the contract was sealed after a state-level bill was passed to cancel all contracts in Maryland.

Why is this important?

The County Council is currently considering four political appointments put forward by the County Executive and Councilmember Rigby. These political appointments are either a reward for creating the toxic political culture in the County, for participating in the disruption of the Columbia Democratic Club's meetings when it actively engaged in calling out the County Executive's terrible misdeeds, or simply a plan to put in place the right people in the right positions to help advance a developer interest.

I urge the county council to vote no on these appointments as I am not confident it is in the public interest. Much like the unfortunate events at the Human Rights Commission, vulnerable members of the public will take a back seat in the interests of advancing party of political goals.

CR111-2021: I oppose the appointment of Reverend Regina M. Clay to the Howard County Local Children's Board.

The Board states that "[r]ecently, The Board identified priorities and designed strategies to help ensure Howard County is a place where all children can thrive."

The Board goes on to identify the priorities as follows:

- Affordable and Quality Education and Training
- Increase Inclusiveness, Awareness and Coordination of Resources to Meet the Needs of Each Community
- Access to Affordable and Quality Behavioral Health Care

I fail to see how Reverend Clay can successfully discharge the priorities identified by the Board. Reverend Clay is a founding member of The Rouse Project, a dark-money developer-funded group, which was established to take over the Columbia Association by replacing existing CA Board of Directors with candidates who would support Howard Hughes Corporation's quest to "control cities." This group cynically used the benevolent goals of diversity and equity to rile up the residents of Columbia, even though it had a very transparent agenda of using public

property and tax dollars for private gain thereby creating inequity and affecting the very goals of the Local Children's Board.

Someone who works with such a group should not be in such an important position. I urge you to vote no on this appointment.

CR117-2021: I oppose the appointment of Ms. Sabina Taj to the Howard County Library System Board of Trustees.

Ms. Taj's appointment will benefit Howard Hughes Corporation in its quest to "control cities." Since her election to the Board of Education, Ms. Taj has openly collaborated with developers to advance their interests.

As BOE member, Ms. Taj used her platform to advance the development industry's agenda. One such event was hosted by an entity called Center Maryland, a developer-funded lobbying and PR group that works closely with the Democratic establishment.

The development industry in Howard County has played a major role for the inequities and lack of affordable housing in Howard County. Instead of standing with community members and condemning their actions, Ms. Taj used her platform to advance their interests by appearing as a featured speaker at an event hosted by Center Maryland and the Maryland Building Industry Association in a "conference" on educational equity and housing affordability. A clear misalignment of interests and dereliction of responsibility.

More recently, she was the founding member of The Rouse Project, a dark-money group, established for the express purpose of controlling the Columbia Association Board. At the time, community leaders such as former County Executive Liz Bobo shared their concerns and raised alarms by calling out the not-so-benevolent goals of The Rouse Project and urging the public to reject them.

It is no secret that TRP was funded by Howard Hughes Corporation. However, the entity has yet to come clean about its sources of funds.

Given that Ms. Taj chose to participate and lend her platform to an entity that has shown clear disdain to transparency, I am troubled that she is under consideration for a public position where transparency and a track-record of advancing the public interest are a prerequisite.

This appointment is a choice made by Howard Hughes Corporation to advance the interests of Howard Hughes Corporation.

Please vote no on this appointment.

CR118-2021: I oppose the appointments of Mr. Michael Butera and Ms. Ainy Haider-Shah to the Compensation Review Commission.

As stated, Mr. Butera's appointment appears to be some sort of a reward for playing a major and consequential role in the disruption of the Columbia Democratic Club meetings. While Mr. Butera appeared conciliatory and spoke about fiduciary responsibility at the Club meetings he did not appear interested to learn more about the Club Treasurer's lack of fiduciary responsibility.

There did not appear to be any impartiality in his behavior and he succeeded along with Reverend Clay in shutting down the Club's attempt to get to the bottom of the inconsistencies observed by some of the Club officers in the Club's finances. I am concerned that an appointment put forward to reward such behavior does not serve the public interest.

In a recent statement, Councilmember Rigby stated that she nominated Ms. Ainy Haider-Shah because she is a "strong advocate for pay equity in the workplace, she has experience working in multiple governmental agencies, and she has experience in human resources and staffing." She goes on to say, "[m]y goal was to nominate someone who would approach the Commission with a lens of pay equity and someone who has work experience in both HR and in government."

While I appreciate all the "hot-button" keywords that rile people up in Councilmember Rigby's statement, such as "equity", Ms. Haider-Shah has played a key role in the toxic rhetoric that often grips the county. She often engages in smears and participates in appalling levels of cyber-bullying in order to silence critics of the Democratic Establishment.

Many know that I am a vocal critic of the developer influence in the county's politics and the impact on equity. I am okay being the target of any criticisms including the vicious ones lodged by Ms. Shah. However, I am not okay with any attempts to silence me by putting my family in danger by disclosing my address.

Ms. Haider-Shah along with other members of the Howard County Democratic Party were part of such an effort after I published a report that raised concerns about The Rouse Project's plans to siphon taxpayer dollars on behalf of Howard Hughes Corporation. Reverend Regina Clay and Ms. Taj, who are nominated to the Local Children's Board and the Library System Board of Trustees, Respectively are members of The Rouse Project.

It is unfortunate that Councilmember Rigby thought someone who engages in cyber-bullying and intimidation tactics is appropriate for this appointment. I hope the rest of the county council does not agree.
