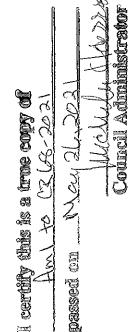

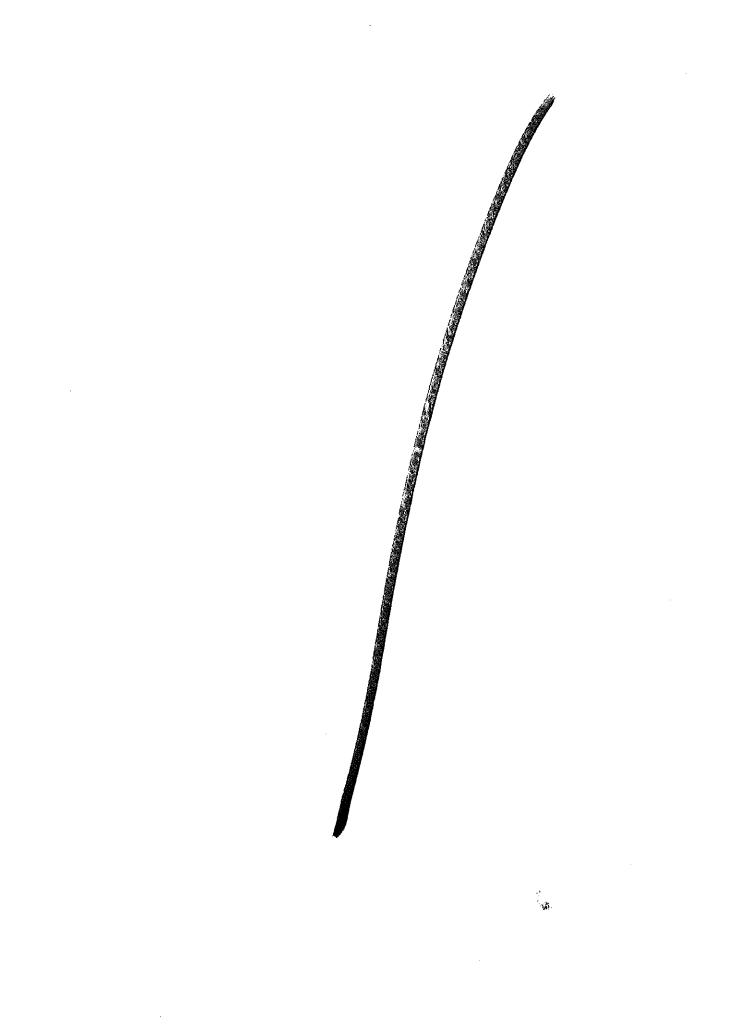

The high home prices and the lack of middle-income affordable housing in this community are threatening the dream. That shining city on a hill that I hope to raise my own children in. I was very worried to see projects that have mixed middle-income and low income housing referred to as concentrations of poverty (since when is the middle class a poor!) despite being right next to a large areas of market-rate housing and also that there will be amendments that will prevent these places for even being built. Perhaps in other parts of the county it might be fine to make it accessible only to people who can afford \$700,000 homes but in Columbia it is not.

Please ensure that these projects can continue I understand that the pandemic has constrained our budget (though with the crazy home sales it looks like that Recordation Tax would have really helped us) but the amendments to not be structured in a way or done in such a way as to prevent these buildings from happening

I know a lot of people are saying 'but the school system' but how can we have a school system that attracts great teachers if young teachers starting out cannot live anywhere near where they work? Especially with how teachers were treated during the pandemic the County Council must do its part (housing, county services) to attract them.

Dear County Council,

I was interested to hear council members Mercer-Rigby and Yungmann discussing the need for business plans for new Capital projects. This sounds like a great idea for determining the anticipated cost to fully fund a project in perpetuity. Please consider requesting that plans for capital projects include associated costs such as leasing office space, moving/storage costs, operational and facilities costs, and additional staffing required.

Below please find the calculation shared with you in Budget Work Session by Dr. Wu to explain the costs of enrollment growth to the school system. I found this a very clear and valuable explanation of education costs for a layperson. As you make decisions about capital and operating budgets, it would be helpful for similar calculations for other services/departments in order to determine the cost of proposed services in the county per housing unit or resident and explore how the county will address funding needs.

Growth in the school system is about 1,000 students annually above the previous year. This rate of growth is among the highest in the state of Maryland. Because funding is based on student calculations using the previous year's student numbers, \$10-12M of the budget request each year is to pay for this growth. In order to maintain services (no COLAs, no additional programming, etc.), HCPSS would require at least this funding annually beyond MOE.

There is some question this year about whether the student projections will be accurate due to the effects of the pandemic. Howard County has the lowest number of students in non-public among peer counties, making it likely that many students will return (MSDE Enrollment Projections). Additionally, it is likely that a good deal of enrollment loss last year was due to deferred kindergarten enrollment. It is likely that in the early grades will return to pre-pandemic levels when schools resume normal operations.

Calculations shared by Dr. Wu:

FUNDING NEEDS BECAUSE OF STUDENT ENROLLMENT GROWTH

- 1. We have been seeing an average of 1000 new students per year for HCPSS in the past 10 years. Assuming 10% of the growth are students with special needs.
- 2. The increased cost is : 900*10,000 per student for general education from county funding +100*30000 per student for special education from county funding =12 million dollars
- 3. Another calculation using average (16k per student) 16k * 1000=16 million dollars. County funds 2/3 of those, which is equivalent 10.6 million dollars.
- 4. So in general, we need more than 10 million extra dollars each year to accommodate student growth in order not to increase class size or cut service.

Does housing development pay the cost?

1. Assuming a house has two students over 30 years staying at HCPSS, ignoring inflation.

2. The property tax for a 400k house is 4k*30=120 K dollars in total.

3. The cost for 2 new students for HCPSS: 50k (per student per seat in capital budget)*2 + 10000*13 (years)*2 = 360 K dollars

4. The gap of funding is 240 K per house.

- 5. If the house keeps generating students continuously (the family moves in only when students attending HCPSS, assuming 20 years for two students), the tax will be 4k*20=80k. The gap will be **280k**. Every forty year, the funding gap will be **560K**, more than **half million dollars**.

Dear Chair Wu and Members of the Board of Education (BOE):

I want to acknowledge the concerns that you have raised regarding our proposed FY2022 operating budget and express my appreciation for the collaborative spirit in which you have engaged with us over the past few weeks. As we are collectively working to resolve challenging issues and ensure the safe return to a full five-day instructional model this fall, I am thankful for the open dialogue and your availability as we strive for a shared solution to provide additional funding for the Howard County Public School System (HCPSS).

Following our discussions and upon further examination, I am pleased to inform you that we plan to work with our County Council to amend our proposed FY2022 operating budget to add \$4 million for HCPSS. If supported by the County Council, this funding will be shifted in anticipation of adjustments to the Maintenance of Effort (MOE) calculation by the Maryland State Department of Education (MSDE), which we expect will increase the MOE level from \$602.7 million to \$620.3 million in the coming days. Providing this additional funding to HCPSS will not come without sacrifice, as we will be adjusting the implementation timeline of our Body Worn Camera program, defunding critical vacant positions within County government, and restructuring costs associated with the opening of the new courthouse to offset the proposed increase to the HCPSS operating budget.

Additionally, we will be working with our County Council to amend the currently proposed categorical allocation and fully fund your requests for the Instruction and Special Education categories. Our educators have continued to provide excellent service to our students during this challenging time, adjusting to new learning models and performing their jobs in both virtual and in-person settings. While final categorical allocation decisions are subject to your approval, this proposed amendment will meet your current request for salary and benefit increases and provide over 70 new positions to meet the needs of our special education students based on your proposed budget.

With this \$4 million in additional County funding for the HCPSS operating budget, the proposed amended operating budget will now place HCPSS funding levels at \$6.5 million above the anticipated revised MOE level. This level of funding would exceed both the 10-year and 5-year averages for County funding above MOE and fully fund your requests for education and special education, while allowing the opportunity for you to provide additional support from your fund balance for the HCPSS operating budget as part of our shared solution. This County funding will be provided in addition to the \$10 million in one-time funding currently proposed by the County to contribute to the resolution of the HCPSS health fund deficit.

In furtherance of our dialogue and collective efforts to increase the amount of funding for HCPSS, I would ask that you consider using your existing fund balance in the FY2022 operating budget to further support our educators during this difficult time.

HCPSS budgeted between \$6-12 million of its fund balance in each of its past three (3) operating budgets but reduces its fund balance usage to \$0 in the currently proposed FY2022 operating budget.

Further, HCPSS has an unassigned fund balance of \$13.1 million at the end of FY2020 and expects to accrue significant additional fund balance in FY2021, with year-to-date spending levels both well below budget and below spending levels at this point in FY2020. School systems across the region are utilizing a significant amount of fund balance in their proposed school budgets. We are asking that you consider taking similar action and use your fund balance to support our educators and children in the currently proposed budget as has been done in previous budgets.

Moreover, HCPSS has or will receive over \$82 million in federal funding to account for unanticipated expenditures moving into the new fiscal year, including over \$43 million in funds yet to be received from the Elementary and Secondary School Emergency Relief Fund (ESSER).

Last, I would request that you act regarding the use of fund balance in the FY2022 operating budget prior our County Council's vote on May 26th. It is our hope that the County Council will be able to consider the totality of our shared contributions to increase funding for HCPSS as it considers this important issue. Your action to indicate the amount of fund balance available for use in the FY2022 operating budget prior to May 26th will allow the County Council and the public a full understanding of our shared solution as the Council votes to approve our proposed budget.

I appreciate the challenges that our educators have endured over the past year and am hopeful that our shared efforts to increase the HCPSS operating budget will be used to foster a positive teaching and learning environment for both our children and educators. Thank you for your attention to this matter.

My name is Heather Urner, I am a County Resident and Public School Parent. My address is 10332 Hickory Ridge Rd Apt 738 Columbia MD 21044. I am writing testimony for the morning work session occurring on Monday May 10th at approximately 9:30 am. By this day the County Executive, Mr. Calvin Ball, will have given you all the outlined budget. I urge you all to make changes. In this stage of the budget it is the County Council whom all have the power to vote to increase the budget that was presented to them, and I say do so. I say relocate all monies planning for any SRO body camera program to go into the HCPSS Operating budget. As it stands now our public school will be dealing with a negative 28.9 million difference in Operating Expenditures. In that, I also encourage you all to look to fund HCPSS beyond the MOE. We need to not think of any soundbite headlines but we need to know that the locals in Howard County know what the math actual looks like with what gets approved.

The old MOE looks like so much was done to fund schools at 20.1M above MOE, but when you adjust figures the math only shows 2.5M. Howard County parents know and have the data where, since FY 2015 (5.23%) the gigantic slide in the percentage of County Funding per Pupil caused a massive gap, from its lowest dip in FY 2018 of 0.26% to its hardly worth bragging about climb to 0.41% in FY 21 from 1.20% in FY 20. We are a county that brags about the achievement of its students and yet we don't listen to the parents that seek answers to cuts from BOE that knowingly happen because the County Council doesn't take the action to say NO to MOE. Howard County parents are well aware that our children need a School budget beyond the MOE. We can not continue to cut our school budget and think that parents' can't see the timeline of how the budget works. BOE can not add to the budget once they've received it, they can only cut. This isn't any excuse, this is the action they have available to make to given budget work.

We need the County in all of its levels to say and show that MOE is not enough. How can we continue to rest on something that maintenance, when our education system is not maintaining. Is overcrowding maintaining, is uneven opportunity in programs throughout each of the schools maintaining, is sharing a school nurse maintaining, are outdated APFO equations maintaining? HCPSS parents know our schools NEED and DESERVE MORE. In the steps of the budget it is now in YOUR HANDS to adjust what you see in front of you and SAY HCPSS NEEDS AND DESERVES MORE. Show the Howard County Families that you know we are watching, we are analyzing, and that we are remembering who voted on or refused to take a stance on fully funding OUR SCHOOL SYSTEM.

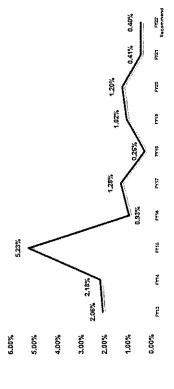

Understanding Maintenance of Effort

- Maintenance of Effort (MOE)
 - State law requires local governments to maintain the per pupil funding at least at the same amount as the prior year
 - The MOE must be funded by the local government
- Calculation of Required MOE for the Budget (two step process)
 - First, determine the per pupil funding amount that must be maintained by taking the current year county funding (excluding any one-time) divided by the prior school year official enrollment (the year prior to the funding year)
 - Second, multiply the per pupil funding amount by the greater of the prior year <u>official enrollment</u> or the 3-year average official enrollment, excluding Sept 2020 enrollment

On April 9, 2021, HB 1372, the Kirwan "Fix Bill" changed the official enrollment calculation for MOE. Before the change, prior year enrollment was used.

The BOE Requested Budget was based on the old calculation and assumed a holdharmless action by Legislature.

Good Morning Council Chair Walsh and Council Members,

My name is Benjamin Schmitt and I'm the Vice President of the Howard County Education Association. This morning I'm speaking on behalf of over 6,000 educators in the Howard County Public School System.

This year, our members have redesigned teaching, engaging students we only know as avatars on screens, and supporting them through this pandemic. Employees are working 10-14 hour days, weekends, holidays, enduring sleepless nights, stress, fatigue, and trying to take care of their own families too. Nationally, teaching has always been an undervalued and under supported profession. However, Howard County prides itself on its public schools. People move here for children to attend our schools, and elected officials always tout how much they care. We're repeatedly told that education is a priority, but year after year not given the funds to meet the rising demands our students bring to school each day.

And, now, we pivoted once again, teaching concurrently, which is terribly difficult. Imagine, splitting your attention between 10-20 students on a separate monitor in a Google Meet, while another ten are in front of you in the classroom. You don't have the ability, nor all equipment, to use an LCD projector, document camera, laptop, and an additional monitor for the Meet, all at the same time. So, you make due, and the students in front of you are still glued to their own screens in order to access the lesson and interact with peers. Imagine having to split reading groups in a way that decreases screen time, while going against best practices. Or having to modify curricula on a daily basis, as it wasn't already sufficiently prepared for this situation, trying not to shortchange students at home or in-person. And in between your own classes, you have to sub for educators because there aren't enough substitutes. These are just some examples of what our educators experience every day in our new normal.

Now, after perhaps the hardest year for educators and students over the last three decades, we've been shown once again, just how little we are appreciated, and how little our work is valued by our Board of Education and our County Executive. This past year, in the doom and gloom presented about the budget, County employees received step and two percent, but our agreement was broken. We were told, yet again, there wasn't enough money in the County budget to support the negotiated contract. Alas, revenues still increased by tens of millions. Currently, houses are selling at record prices, yet, all the county could see fit to give the school system was an additional \$2.5M in reoccurring funds.

Last year, in addition to underfunding our contract, we needed 300 educators to adequately cover our special education students, but could only hire 107 with the funds allocated. The amount we owe in compensable services keeps growing because of this continued underfunding. Additionally, we were unable to add new counselors, school psychologists, and social workers to assist the growing mental health needs of our students.

This is unacceptable, just as it is unacceptable that as the County's revenues increase, the percentage the school system receives decreases. We're tired of seeing historic fund balances

from ultra conservative projections. In 2019, we were allocated 53% of the budget. This coming year we are slated to receive 50% (the lowest since 2012 when we received 56%). The additional 3% would allow HCPSS to have \$35M more than allocated. And, you only have until July of 2024 to raise educator salary scales by 10% under the new Blueprint Legislation. Unlike Howard, surrounding counties are making historic investments in schools right now!

I've taught in the county for 23 years, and can't think of a time that we haven't fought for crumbs from the budget, especially over the last 10-12 years. Going through this process yearly, to feel so unappreciated, to listen to so much doublespeak, is sorrowful, stress-inducing, and demoralizing for all of our educators. It doesn't help motivate others to go into the profession, or attract and retain current employees.

The County is not alone in their disrespect to education and educators. Our own Board of Education refuses to settle negotiations. Instead, they want to get more money from you and the ability to spend it as they see fit. We're repeatedly asked by the school system to take on a larger portion of our health care costs which would leave educators actually having less disposable income due to zero to minimal salary increases.

Educators have sacrificed year after year for our students and families. The County and the BoE have a duty to fight for the resources that our children need. Instead, we see childish finger pointing. This leaves educators underpaid, our schools short staffed, and leaves students without the services and resources they so desperately need. Actions speak more loudly than words. Do the hard work. Do what is necessary. Fund the school system. Fund our contracts. Fund special education and the wrap around services our students need. Make Howard County and its school system the example to follow, rather than leaving it falling further behind.

Executive Ball and County Council members,

As a Howard County resident and part-time teacher at Saint Louis School in Clarksville, I was disappointed to hear that the budget recently approved by the Howard County School Board would eliminate funding for bus transportation to parochial schools within Howard County in the coming academic year. Since September, Saint Louis has managed to remain open for in-person instruction with a virtual option. Doing so safely presented a number of logistical hurdles at the beginning of the academic year, and I am pleased to report that we have overcome these hurdles through the implementation of a range of measures, including dividing students into "cohorts" (with minimal interaction between cohorts), social distancing within classrooms, enforcement of mask-wearing, frequent hand-washing/sanitization, aggressive cleaning of school facilities, and set policies for the isolation of potentially ill members of the school community.

While we look forward to the eventual end of these safety measures, we remain concerned about another logistical challenge which we have faced this year - transportation. Hundreds of students in our school means hundreds of cars traveling to and from Saint Louis twice each day. While we have done our best to establish staggered arrival times and our faculty members have taken on the added burden of standing out in the parking lot under all weather conditions to direct traffic, we have still seen days when the line of cars stretches out to State Route 108. Bus service would greatly reduce the number of vehicles needed to transport students, reducing traffic congestion in the Route 108 corridor and diminishing environmental impacts through an overall lowering of carbon emissions. In addition, the provision of bus service would allow us to better serve underprivileged minority communities in the Columbia area, as bussing would give equal access to students whose parents lack the flexible working hours necessary to personally drop off and pick up their children each day.

As a public school graduate, I value the impact which a quality public education system can have both on individuals and society as a whole. At the same time, I also recognize the benefit in empowering parents to make decisions concerning the education of their children which will be in the best interests of their particular families. This means that an array of options should be available to parents, rather than just a one-size-fits-all model. When we work together, we can ensure that all students have access to the form of education which is best for them, and that society as a whole benefits from a well-educated populace.

With these things in mind, I respectfully ask you, as the elected executive leadership of Howard County, to exercise your authority to encourage the School Board to reevaluate the elimination of bus transportation to parochial schools. Thank you for your time and for all that you do on behalf of the residents of Howard County.

Dear Dr. Martirano and Board of Education Members,

I am requesting that you please follow the science and implement 5 days of full in person school for the fall and announce that intention now. By fall, all adults who want to be vaccinated will be vaccinated. Our students will have been out of in-person school for a year, while private school students with parents who could pay have been educated largely in-person for the past year. We attempted to get into a private school for access to a more likely in-person education and were unsuccessful in obtaining slots in our school of choice - demand is very high right now. There are those who would say it is just the buildings that were closed this year, that education was still delivered. For some students, including my first grade son, that is simply untrue due to age, behavioral or parental employment limitations.

I will have an incoming kindergartener and second grader; my son has been homeschooled for the past year due to his reticence to sit at the computer for virtual coupled with my need to attend meetings for my employment during the virtual window. We tried it for a month, and frankly during that window I determined it was not a good use of either of our time. He effectively could not access a public education unless I quit my job for the bulk of this school year. I am not re-enrolling him for the spring because I do not believe it would be helpful for all involved for him to come back midschool year, but I have already enrolled both children for the fall. We will participate in whatever the school system comes up with, but I beg of you to make it meaningful, worthwhile, non-screen based and follow the science.

The science on COVID-19 thus far tells us that fomite transfer is not a method of transmission, that masks and ventilation are important, plexiglass is not useful, and that the distance between 6 and 3 feet has no impact on transmission. Please do not focus on things like excessive cleaning, materials sharing, and other data points that do not impact transmission. Please, through leadership and science get our students back in the buildings for in-person education with their teachers, not classroom monitors. Please get our students back in the classroom with educational materials, not laptop computers causing eye strain, delivering excessive screen time to our already-screen entrenched students. This is really something you should be striving to achieve right now rather than in the Fall, but at this point, I'd take some progress on the Fall as a positive.

I am not a "Reopen" person who favors reopening business, restaurants, and other things when it is not safe. I am not someone who has advocated eliminating the student board member vote. I am just a regular, sometimes reasonable, mom who has followed a number of qualified epidemiologists on twitter, and from my armchair epidemiologist seat (I guess that is a lot of us these days) our county has had a failure of leadership in following the science and providing students an in-person education. But do not listen to me or any other stakeholder that is not a medical professional who specializes in public health- I am not qualified to make this determination and neither are they or you. I want you to listen to:

It is my hope that you will signal clearly that your intention is to get students back to school using science as a guide and by following through on that intention with an efficient meeting that doesn't involve the board navigating the scientific nuances in detail, but instead delegating those to appropriate qualified professionals. This board spends meeting time on details that, while important, should be delegated to appropriate school leadership and science-based advisors with subsequent approval by the board if needed.

As a taxpayer and county resident, I am deeply frustrated with the pace of planning and decision making and I suggest that part of that issue is that the board is not delegating decision making enough to the appropriate roles and is weighing in on too many issues and details. If an external public health professional could establish appropriate constraints needed for the district to implement in-person education and the board could delegate the implementation following those constraints to Dr. Martirano and his staff entirely, I suggest that might be a much more efficient path forward. Then the board could confidently approve any proposed plan knowing 1) the current public health guidance was interpreted by a qualified medical professional 2) the educational implementation of that guidance was implemented by a qualified education professional. Instead, it appears to me that the board is involved too deeply in the establishment of factors embedded in items 1 and 2, and then are not able to confidently approve plans. For example at a recent meeting, time was spent addressing board member concerns related to how students were moving within a hallway and finding a bathroom when new to the school as part of the transition to back to in building. School leadership was able to confirm this was already on their radar and this was already addressed. This is an example of the board getting too in the weeds on the small details and not leading on the larger strategy, mission and execution needed to get students back to school. The board should be providing mission and vision on a broader scale than some of the detailed view it takes and the board is not functioning as an oversight body at times, but sometimes as a management body. If more detail was delegated to qualified stakeholders, the decision-making could be more efficient, functioning more as an oversight rather than management role, and board members could be confident that it was based on the latest science and educational guidance.

Thank you for taking the time to read my email. I am including the county council and Dr. Ball as I know there is continued coordination between the county and the school system.

I am writing in support of county bus service for nonpublic schools in Howard County.

Bussing a child to school in this county should be considered a basic human service. We talk a lot these days about issues of human rights or discrimination or privileges, but I have to ask why it is so hard to see that dynamic in play in this situation of educating our youth without double burdening them to pay for bus service— they and their supporters are already double paying for the education itself. It is not an undue burden to offer that child a seat on the bus. Civil rights started in 1955 with debates about riding buses, and here we are over 60 years later still playing around with people's rights to sit on a publicly funded bus. Shame on you in 2021 if you cannot see helping a wee child get to school as a basic human decency that we can afford. If the issue is balancing the budget, look for frivolous spending, not necessary spending. If the issue is not balancing the budget, then I have to ask Why in heaven's name are you doing this? As a punishment to families who don't further burden the public school system? For heaven's sake, help them help the county. If it costs you 50 cents a day for them to save you 50 dollars a day, spend the 50 cents. We should be nothing if not practical, pragmatic, and sensible.

The cost per student to bus children is less than to educate them. I am paying my property tax for both, and if a family can reduce the cost burden on the county by keeping a child in private school, it helps keep costs down for the county. They deserve bus service. Otherwise it is tantamount to being charged for a public bus that you are discriminated against riding. That is worse than being told you cannot buy a bus ticket.

Each family supporting a parochial school still pays their Howard County tax bill. They have an honest need for an equal right for access to that bus, especially important if they cannot afford to pay twice for transporting their child to school, once in the taxes and once again if you cancel their right to bus their child to school,, a school in which a lot of families cannot afford the full tuition. The Howard County Public School System's Operating Budget is close to a billion dollars – funded from our tax dollars. Citizens have a right to know how that money is being allocated and the Board of Education's budget work sessions are an important way for us to gain this information. Therefore, we strongly request that Board members are not limited in the number of questions, nor a 5-minute time limit, for questions they can ask during work sessions.

Keep in mind that HCPSS has had a multi-million-dollar deficit since 2016, which has had a significant impact on our children's education. HCPSS increased class sizes twice since 2016, cut reading and math support teachers, reduced teacher's materials of instruction by \$7.2M, reduced the special education budget request that the Superintendent called "debilitating", and much more.
