1	WHEREAS, Section 4.304 of the Howard County Code provides that unclaimed

6	to dispose of forfeited motor vehicles to the owner of the vehicle under certain circumstances

26	WHEREAS, pursuant to Section 4-206 of the General Provisions Article of the
27	Annotated Code of Maryland, the official custodian may charge a reasonable fee for the search,
28	preparation and reproduction of public records and the Police Department charges reasonable
29	fees for certain types of records provided to the public including, without limitation, 911 tape
30	reproduction, photograph development, police report reproduction, and specific crime analysis
31	reports that require statistical analysis and research; and

WHEREAS, Section 17.905 of the County Code provides that application fees and permit fees for special events and concerts shall be set by Resolution of the County Council; and

WHEREAS, by passage of Council Bill No. 1-2021 and Council Resolution No. 11-2021, the County adopted a fee schedule for the Private Animal Shelter license and those fees are waived until a year after the Council Bill No. 1-2021 is effective; and

WHEREAS, the County Executive has proposed the adoption of the attached fee schedules for functions of the Department of Police and there are no changes for Fiscal Year 2022.

NOW, THEREFORE, BE IT RESOLVED, by the County Council of Howard County, Maryland this 24 day of May, 2021 that it adopts the attached schedule of fees.

AND BE IT FURTHER RESOLVED, that the fee schedule shall be effective July 1, 2021 and shall continue in effect until changed or repealed by subsequent Resolution of the County Council.

This fee is set pursuant to Section 4.304 of the Howard County Code that provides that unclaimed property may be turned over to the finder upon the finder's payment of the cost of advertising.

CHARGE ON TELEPHONE BILLS FOR SUPPORT OF 911 SYSTEM

This fee is set pursuant to Section 1-311 of the Public Safety Article of the Annotated Code of Maryland that authorizes the counties of Maryland to impose charges of up to 75¢ per month on each telephone bill to pay for operation and maintenance of the County's 911 emergency telephone system.

Section 1-313 of the Public Safety Article of the Annotated Code of Maryland establishes a prepaid wireless 9-1-1 fee of \$0.60 per transaction to be collected by the State.

Electronic copies

Unless otherwise provided by the Maryland Public Information Act:

- 1. Electronic copies shall be provided when the record is routinely kept by the Department in an electronic format unless the requestor specifies paper copies;
- 2. The Department may, but need not, convert paper records to electronic records; and
- 3. Where an electronic response, or portion thereof, is too large to send electronically, the Department shall convert the response, or portion thereof, to paper, cd, DVD, or flash drive, as the requestor specifies.
