3	Fire and Rescue Services, the County seeks to collect a reimbursement from an individual's
4	insurance company for costs generated by emergency medical services; and

7	adopt by Resolution a Reimbursement Schedule that shall be based on the cost of providing
8	emergency medical services; and

11	wishes to adopt the attached Reimbursement Schedule related to the provision of emergency
12	mediçal services in Howard County.
