#### No. 2 - Fiscal Year 2022

AN ACT transferring \$1,646,159 from C0214, the Category Contingency Fund, to capital project D1176, Watershed Management Construction, in order to receive and appropriate the Chesapeake and Atlantic Coastal Bays Trust Fund grant to perform stream restoration and ecological enhancement along a portion of the Plumtree Branch stream near Dunloggin Middle School in the capital budget for Fiscal Year 2022.

1           **WHEREAS**, Section 609 of the Howard County Charter authorizes and empowers  
2 the Howard County Council to make interproject transfers of appropriations between  
3 capital projects in the capital budget and such transfers may be authorized by legislative  
4 act of the Council upon request of the Executive; and

5  
6           **WHEREAS**, on May 26, 2021, the County Council passed Council Bill No. 34-  
7 2021 that adopted the Annual Budget and Appropriation Ordinance for Fiscal Year 2022;  
8 and

9           **WHEREAS**, the Office of Community Sustainability was awarded \$1,646,159 of  
10 Chesapeake and Atlantic Coastal Bays Trust Fund Grant, which was not included in Fiscal  
11 Year 2022 capital budget appropriation, to perform a stream restoration and ecological  
12 enhancement along a portion of the Plumtree Branch Stream near Dunloggin Middle  
13 School in D1176; and

15           **WHEREAS**, the proposed project was designed in collaboration with Dunloggin  
16 Middle School students and will restore approximately 3,548 linear feet of Plumtree  
17 Branch and its unnamed tributary located on approximately 13.22 acres of Howard County  
18 Department of Recreation and Parks property; and

20           **WHEREAS**, C0214, the Category Contingency Fund, contains spending authority  
21 that can be used to cover the grant appropriation needed in the capital budget for the Office  
22 of Community Sustainability; and

24           **WHEREAS**, the Director of Finance has indicated that the funds are available for  
25 transfer from the respective projects.

27       ***Section 1. Be It Enacted by the County Council of Howard County, Maryland, that,***  
28 *subject to the provisions of Maryland law, the Howard County Charter, and the Howard*  
29 *County Code relating to budgetary and fiscal procedures, the amount hereafter specified*  
30 *is hereby approved, appropriated, and authorized to be disbursed for the general County*

1 *purposes specified and in sums itemized for the fiscal year beginning July 1, 2021 and*  
2 *ending June 30, 2022, as hereinafter indicated:*
