12 (b) *Appointing Authorities.* Appointing authorities for Executive exempt employees are as  
13 provided in this subsection:

- 14 (3) *Chief Administrative Officer.* The Chief Administrative Officer, with the approval of  
15 the County Executive, is the appointing authority for the following positions:  
16 Administrative Assistant, serving the Office of the Chief Administrative Officer;  
17 Administrative Analyst II, serving the Office of the Chief Administrative Officer;  
18 Administrator of the Office of Community Sustainability;  
19 Administrator of the Office of Transportation;  
20 Executive Assistant I, serving the Office of the Chief Administrative Officer;  
21 Executive Assistant II, serving the Office of the Chief Administrative Officer;  
22 Budget Administrator;  
23 Deputy Chief Administrative Officer;  
24 Human Services Manager ~~[[I]]II~~, serving as the Workforce Development  
25 Administrator;  
26 Human Resources Administrator;  
27 Human Services Manager II, serving as the Administrator of the Office of Human  
28 Rights and Equity;  
29 Labor relations coordinator; and  
30 Public Information Administrator.

32 **Section 2. And Be It Further Enacted** by the County Council of Howard County, Maryland that  
33 *this Act shall become effective 61 days after its enactment.*
