Resolution No. 104 -2021

Introduced by: The Chairperson at the request of the County Executive

A RESOLUTION pursuant to Section 4.201 of the Howard County Code declaring that a portion of land containing a total of 1.120 acres owned by Howard County, Maryland located at Maryland Route 103 at Old Stockbridge Road and Wesley Lane is no longer needed by the County for public purposes; authorizing the County Executive to convey fee simple title to the property to the State of Maryland; waiving the advertising and bidding requirements of Section 4.201 of the Howard County Code; and providing that the County Executive is not bound to convey the property if he finds that the County may have a use for the property.

WHEREAS, the County is the owner of approximately 1.120 acres of land shown as 1 "Howard County, Maryland Items #109604 and #109605" and described and shown as "Fee 2 Simple Area" on the plat entitled "State of Maryland Department of Transportation State 3 Highway Administration State Roads Commission," Plat No. 60215, attached hereto as Exhibit 4 A, which was acquired by the County from: i) Trafalgar House Property, Inc. by a Deed dated 5 April 5, 1994 and recorded among the Land Records of Howard County, Maryland at Liber 6 3218, folio 519; and ii) Meadowland Joint Venture by a Deed dated November 27, 1992 and 7 recorded among the Land Records of Howard County, Maryland at Liber 2748, folio 156 8 9 (collectively the "Property"); and

WHEREAS the Property known as a part of Maryland Route 103, Meadowridge Road,
is shown on the subdivision plats entitled: i) "Willowood, Section One, Lots 1 thru 91" recorded
as plat numbers 7729 thru 7733; and ii)"Woodland Village Lots 139 thru 209, & Parcels "C" &
"D", Section 2, Area 1" recorded as plat numbers 8580 thru 8582; and

WHEREAS, the Property was mistakenly transferred to the County with the acceptance
and acquisition by the County of the adjacent County roads including Wesley Lane, Manchester
Way, Sutton Court, Old Stockbridge Drive, and Chatfield Lane; and

WHEREAS, as part of the construction of a traffic signal on Maryland Route 103 at Old
Stockbridge Road and Wesley Lane, the State of Maryland, Department of Transportation, State
Highway Administration has asked for fee simple ownership of the Property to ensure that the
traffic signal improvements are within a State-owned right-of-way; and

WHEREAS, the Department of Public Works has reviewed and approved the proposed
 conveyance of fee simple title in the Property; and



WHEREAS, Section 4.201, "Disposition of Real Property", of the Howard County Code authorizes the County Council to declare that property is no longer needed for public purposes and also authorizes the County Council to waive advertising and bidding requirements for an individual conveyance of real property upon the request of the County Executive; and

1 WHEREAS, the County Council has received a request from the County Executive to 2 waive the advertising and bidding requirements in this instance for the conveyance of the 3 Property to the State of Maryland, Department of Transportation, State Highway Administration. 4 5 NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County, 6 Maryland, this 6 day of July, 2021, that the Property as shown in the attached 7 Exhibit A as the "Fee Simple Area" containing approximately 1.120 acres of land in total is no 8 longer needed by the County for public purposes. 9 10 AND BE IT FURTHER RESOLVED, that County Executive may convey fee simple 11 title in the Property to the State of Maryland, Department of Transportation, State Highway 12 13 Administration. 14 AND BE IT FURTHER RESOLVED that, having received a request from the County 15 Executive and having held a public hearing, the County Council declares that the best interest of 16 the County will be served by authorizing the County Executive to waive the usual advertising 17 and bidding requirements of Section 4.201 of the Howard County Code for the conveyance of 18 the Property in fee simple to the State of Maryland, Department of Transportation, State 19 Highway Administration. 20 21 AND BE IT FURTHER RESOLVED that if the County Executive finds that all or a 22 portion of the Property may have a further County public use then he is not bound to convey the 23

24 fee simple property interest in accordance with this Resolution.

### Fiscal Impact:

There is no fiscal impact associated with this legislation.

The property to be conveyed to the State has no market value, as confirmed by two appraisals which we reviewed, and the County is not receiving any compensation from the State.

Furthermore, the State has been and will continue to maintain this right-of-way at the intersection of Wesley Lane, which includes recently constructed traffic signal improvements.

#### Purpose:

The purpose of this legislation is to transfer 1.120 acres of road right-of-way along Maryland Route 103 to the State. This right-of-way had been erroneously transferred to the County with the acceptance of other County roads (Wesley Lane, Manchester Way, Sutton Court, Old Stockbridge Drive, and Chatfield Lane).

### Other Comments:

The portions of the right-of-way that were erroneously transferred were conveyed with the Woodland Subdivision and Willowood Subdivision in 1992 and 1994, respectively. The County's practice during that time period was for developers to prepare the road deeds, and the State portions were included in the deeds to the County.
