A RESOLUTION pursuant to the Maryland Public Ethics Law, Sections 5-852 through 5-854 of the General Provisions Article of the Annotated Code of Maryland, approving the forms for the Affidavit as to Contributions to Candidates and Business Engagements with Elected Officials and the Disclosure of Contribution; and generally providing for the approval by the County Council of the forms for the affidavit and the disclosure required under the Maryland Public Ethics Law.

1 WHEREAS, the Maryland Public Ethics Law, Sections 5-852 through 5-854 of the 2 General Provisions Article of the Annotated Code of Maryland, requires that certain applicants for 3 a zoning map amendment, a zoning regulation amendment, or participation in the adoption and 4 approval of a comprehensive zoning plan file an Affidavit as to Contributions to Candidates and 5 Business Engagements with Elected Officials and a Disclosure of Contribution form;

WHEREAS, Section 5-853(e)(1) of the Maryland Public Ethics Law requires that the
affidavit and the disclosure be in a form established by the Howard County Solicitor and approved
by the County Council.

10 NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County, 11 Maryland, this <u>2</u>, day of <u>5</u>, 2021 that the attached form for the Affidavit as to 12 Contributions to Candidates and Business Engagements with Elected Officials and the attached 13 form for the Disclosure of Contribution, are hereby approved as the affidavit and the disclosure to 14 be used as required by the Maryland Public Ethics Law, Sections 5-852 through 5-854 of the 15 General Provisions Article of the Annotated Code of Maryland.

made, the amount, and the date of the **Contribution**; and that a **Contribution** made between the filing and the disposition of the **Application** will be disclosed within 5 business days after the **Contribution**.

3. I, the  $\Box$  Applicant, acknowledge and affirm that, if I begin Engaging in Business with an Elected Official between the filing and the disposition of the Application, I will file this Affidavit at the time of Engaging in Business with the Elected Official.

If the **Applicant** or a **Party of Record** or their **Family Member** has made a **Contribution** or contributions having a cumulative value of \$500 or more during the 48-month period before the **Application** is filed or during the pendency of the **Application**, the **Applicant** or the **Party of Record** must file this disclosure providing the name of the **Candidate** or **Elected Official** to whose treasurer or **Political Committee** the **Contribution** was made, the amount, and the date of the **Contribution**.

For a **Contribution** made during the 48-month period before the **Application** is filed, the **Applicant** must file this disclosure when they file their **Application**, and a **Party of Record** must file this disclosure within 2 weeks after entering the above zoning matter.

A Contribution made between the filing and the disposition of the Application must be disclosed within 5 business days after the Contribution.

Any person who knowingly and willfully violates Sections 5-852 through 5-854 of the General Provisions Article of the Annotated Code of Maryland is subject to a fine of not more than \$5,000. If the person is not an individual, each officer and partner who knowingly authorized or participated in the violation is subject to the same penalty.

### Fiscal Impact:

Our office has determined that there is no fiscal impact, as the legislation requires County Council approval of certain forms as required by the Maryland Public Ethics Law.

### Purpose:

The purpose of this legislation is to provide for County Council's approval of the Affidavit as to Contributions to Candidates and Business Engagements with Elected Officials and the Disclosure of Contribution. The County Council is required to approve the Affidavit and Disclosure forms pursuant to the Maryland Public Ethics Law.

#### Other Comments:

Currently, there are three separate forms that need to be filed by certain applicants for zoning changes. The revised forms combine two of the affidavits into one affidavit and keep the disclosure form as a separate form. The forms have also been updated to be more user friendly to facilitate compliance with State law requirements.
