We, the undersigned, support the budget amendments proposed by Council Members to place legal guardrails on the so-called housing trust fund proposed by the County Executive. The existing structure of the trust fund is ripe for misappropriation and abuse as a Slush Fund for Howard Hughes Corporation and other wealthy corporations.

We urge all Council Members to support any one of the following proposed amendments in the alternative as ways to safeguard the County's funds against misappropriation:

In summary, the amendments would; a) move the funds to a contingency reserve; or b) move some of the money to contingency reserve while shifting the rest to the school system; or c) shift the entire amount to the school system.

- Amendment 5 to CB34-2021: (This Amendment moves \$5 million from Housing and Community Renewal – Housing Opportunity Trust Fund to \$2.5 million Contingency Reserve and \$2.5 million HCPSS Fixed Charges for the Health Fund.)
- Amendment 6 to CB34-2021: (This Amendment transfers \$5,000,000 from the Community Renewal Program Fund to the General Fund Contingency Reserve.)
- Amendment 7 to CB34-2021: (This amendment moves \$4,060,000 from Community Renewal Fund to General Fund Contingency Reserve.)
- Amendment 8 to CB34-2021: (This Amendment moves \$5 million from Housing and Community Development, Housing Opportunity Fund, to Project E1044 School System, PAYGO Funding.)

At the time when Howard County's affordable housing needs are at an historic peak and at a time when eviction rates are expected to skyrocket, we are appalled that the County contemplates diverting much needed funds into a potential Slush Fund for developers.

The Director of the Department of Housing and Community Development demonstrated these guardrails do not exist when, at a recent County Council work session, she was asked to describe how the County plans to use this fund and she was not able to provide any details except to point to the recently completed Housing Opportunities Task Force, which does not address the spending plan of this Slush Fund.

We are concerned the County will use this fund to facilitate further developer giveaways rather than address the true needs of our residents. For instance, proposed allowed uses by the Housing Opportunities Task Force include payment of MIHU fees-in-lieu and direct funding of specific developments.

Other counties have used tools such as land trusts to create permanent supply of affordable housing integrated into its communities. Land trusts enable the County to purchase land and spread out affordable housing at regional levels to support various income levels. Other strategies include structured voucher programs and foreclosure assistance to assist tenants and homeowners in the looming deluge of evictions and foreclosures.

Howard County should commit its funds to strategies which, like land trusts, directly address the County's need, rather than increase the profit margins of private developers. To date, the County or Housing Commission have not shared any meaningful plans that ensure that affordable housing is developed in areas that do not further segregate communities, with reliable mass transit and safe walking paths.

In the meantime, the contingency reserves proposed by the amendments will ensure that County Administration returns to the County Council with an appropriate spending plan.

We, the 13 undersigned organizations and 50 individuals, strongly encourage you to approve the green initiative items for a clean and sustainable environment in the 2022 proposed operating budget. We were thrilled to see that a Clean and Sustainable Environment was a priority area in the proposed budget. These items will help in the fight against climate change by promoting green infrastructure and decreasing emissions.

We urge you to fund the following in the final 2022 operating budget:

- \$90,000 in PAYGO to enhance the <u>County Climate Action Plan</u>, providing a comprehensive greenhouse gas inventory to measure the success of mitigation and community adaptation strategies compared to the prior plan.
- \$52,000 to modernize the <u>Green Infrastructure Network</u>, evaluating and updating the existing map. In addition, an acre or more of forest would be planted to build on the existing green infrastructure network, especially in communities that lack access to the current network.

Previously, we urged the county executive to include funding in the fiscal 2022 budget to update Howard County's Climate Action Plan, which was last updated in 2015. In light of the most recent IPCC report and alarming data, it is evident that the 2015 county plan is outdated and inadequate. HoCo Climate Action developed and circulated a letter calling for this critical funding to update the Climate Action Plan. In less than a week, 15 local organizations and faith communities as well as 29 individuals signed on to the group letter.

The state recently released a <u>new climate plan</u>. Montgomery and Frederick counties have passed Climate Emergency bills. Additionally, <u>Montgomery</u>, <u>Frederick</u> and <u>Prince George's</u> counties are developing new county level county actions plans that include avenues for community involvement. Howard County needs to take on this challenge, too.

In addition, we support funding for the Green Infrastructure Network, which sup-ports native plant and ani-mal species while help-ing to clean the air and water, main-tain nat-ural eco-log-i-cal processes, and con-tribute to quality of life. Modernizing the Green Infrastructure Network is crucial to improving our air and water along with identifying communities that lack access to these ecological benefits.

Both of these items are included in the <u>Howard County Racial Equity Task Force's draft</u> <u>recommendations</u> from the Public Health and Environmental Policy subgroup, page 22. Funding these critical projects will help ensure that Howard County develops policies to address environmental racism.

Finally, we support a capital budget item that was proposed but not funded last year: **C0329 - Energy Management/Improvements - \$300,000**. This project supports the county's commitment to energy savings and energy efficiency, thereby reducing greenhouse gas emissions.

While we are pleased with the county executive's new Green Fleet Policy to reduce petroleum fuel consumption in county vehicles by 20% by 2024, we also support a more rapid transition to electric vehicles.

We have delayed big steps for too long. We see evidence around the world and in our backyard of the danger of inaction. The 2016 and 2018 Ellicott City floods tragically demonstrated the county's need to address the cumulative threat from a changing climate. Funding these priority projects will help make all Howard County communities more resilient to the threats from climate change. We need these critical tools to advance climate mitigation while also focusing on vulnerable and marginalized communities.

On behalf of the Police Accountability Task Force - Howard County (PATF-HoCo) steering committee and our coalition supporters, we are urgently contacting you to ask for your support.

Based on a report we read in the Baltimore Sun on Monday, Dr. Calvin Ball sent an unexpected letter to the Board of Education proposing re-allocation of money in his proposed fiscal 2022 budget to give an additional \$4 million to the Howard County Public School System. As a result of giving more money to the school system, we were disappointed to learn that Dr. Ball will not be keeping his March 24th commitment to the community for \$3.2M to fully fund a final and comprehensive implementation of a Body Worn Camera (BWC) program by the end of 2021. Based on this proposed re-allocation of funding, there may be as much as a yearlong delay in the implementation of this important and long-overdue program.

Honestly, we don't have an issue with additional funding for the Board of Education (BOE). HoCo's \$1.9 Billion budget is inclusive of hundreds of programs and it should not be an insurmountable task to find \$3.2 Million without reducing funds intended for education. The proposed funding for the BWC program is less than 0.2% of the entire budget. Reapportioning this amount relative to the entire budget (\$1.9 Billion) shouldn't have a detrimental impact on the entirety of the elements included in the budget.

This is a time-sensitive issue. It is our understanding that there is a Budget Amendment Prefile requirement today, Wednesday, May 19th, at 2pm and there is a final budget confirmation process next week.

In the wake of George Floyd's murder and, more recently, the fatal police shooting of Andrew Brown, Jr. in North Carolina, a well-implemented BWC program is a fundamental **"first step"** towards ensuring accountability and transparency in community policing. Jurisdictions in Maryland, many far less prosperous than Howard County, have mustered the ability to fund their BWC programs including Montgomery County, Harford County, Baltimore County, Queen Anne's County, Wicomico County and the cities of Baltimore, Frederick and Salisbury. Even small communities like Berlin and Fruitland have funded BWC programs for their police departments. We believe Howard County should be leading the movement for increased accountability, not lagging behind.

We contacted Dr. Ball yesterday to urge him to reconsider his decision and we hope we can count on your support to do so as well. Also, if Dr. Ball does reconsider his decision, we request that **all Council** members fully support his decision to reinstate \$3.2M funding for the BWC program to ensure there is no delay in implementation. The time to install this critical program is now... not next year. The community is watching and we depend on all our representatives to do the right thing!

Maryland Inclusive Housing Corporation (MIH) was established to help people with intellectual and other developmental disabilities (IDD) successfully access and maintain inclusive, affordable, and accessible housing of their choice. To this end, MIH has established Housing Committees around the state, including one in Howard County to work at these issues.

On behalf of MIH and our Howard County Committee, whose members are listed at the end of this letter, we urge you to establish the Howard County Housing Opportunities Trust Fund and include the proposed \$5 million to get it started.

We understand that the purpose of this fund is to promote and support affordable housing broadly within Howard County. We are also aware that in 2019, 21,801 individuals with at least one disability lived in the county and 1,655 of those were 18-64 years old living in poverty. In January 2021, 140 County residents were on the Weinberg Apartments waitlist, and there is a significant lack of accessible housing in the County with much of the newer accessible units having rents unaffordable to those who need the accessibility.

The people who we support desperately need the availability of additional affordable housing and the establishment and the funding of the Housing Trust Fund would be a step in the right direction.

Dear Chair Wu and Members of the Board of Education (BOE):

I want to acknowledge the concerns that you have raised regarding our proposed FY2022 operating budget and express my appreciation for the collaborative spirit in which you have engaged with us over the past few weeks. As we are collectively working to resolve challenging issues and ensure the safe return to a full fiveday instructional model this fall, I am thankful for the open dialogue and your availability as we strive for a shared solution to provide additional funding for the Howard County Public School System (HCPSS).

Following our discussions and upon further examination, I am pleased to inform you that we plan to work with our County Council to amend our proposed FY2022 operating budget to add \$4 million for HCPSS. If supported by the County Council, this funding will be shifted in anticipation of adjustments to the Maintenance of Effort (MOE) calculation by the Maryland State Department of Education (MSDE), which we expect will increase the MOE level from \$602.7 million to \$620.3 million in the coming days. Providing this additional funding to HCPSS will not come without sacrifice, as we will be adjusting the implementation timeline of our Body Worn Camera program, defunding critical vacant positions within County government, and restructuring costs associated with the opening of the new courthouse to offset the proposed increase to the HCPSS operating budget.

Additionally, we will be working with our County Council to amend the currently proposed categorical allocation and fully fund your requests for the Instruction and Special Education categories. Our educators have continued to provide excellent service to our students during this challenging time, adjusting to new learning models and performing their jobs in both virtual and in-person settings. While final categorical allocation decisions are subject to your approval, this proposed amendment will meet your current request for salary and benefit increases and provide over 70 new positions to meet the needs of our special education students based on your proposed budget.

With this \$4 million in additional County funding for the HCPSS operating budget, the proposed amended operating budget will now place HCPSS funding levels at \$6.5 million above the anticipated revised MOE level. This level of funding would exceed both the 10-year and 5-year averages for County funding above MOE and fully fund your requests for education and special education, while allowing the opportunity for you to provide additional support from your fund balance for the HCPSS operating budget as part of our shared solution. This County funding will be provided in addition to the \$10 million in one-time funding currently proposed by the County to contribute to the resolution of the HCPSS health fund deficit.

In furtherance of our dialogue and collective efforts to increase the amount of funding for HCPSS, I would ask that you consider using your existing fund balance in the FY2022 operating budget to further support our educators during this difficult time.

HCPSS budgeted between \$6-12 million of its fund balance in each of its past three (3) operating budgets but reduces its fund balance usage to \$0 in the currently proposed FY2022 operating budget.

Further, HCPSS has an unassigned fund balance of \$13.1 million at the end of FY2020 and expects to accrue significant additional fund balance in FY2021, with year-to-date spending levels both well below budget and below spending levels at this point in FY2020. School systems across the region are utilizing a significant amount of fund balance in their proposed school budgets. We are asking that you consider taking similar action and use your fund balance to support our educators and children in the currently proposed budget as has been done in previous budgets.

Moreover, HCPSS has or will receive over \$82 million in federal funding to account for unanticipated expenditures moving into the new fiscal year, including over \$43 million in funds yet to be received from the Elementary and Secondary School Emergency Relief Fund (ESSER).

Last, I would request that you act regarding the use of fund balance in the FY2022 operating budget prior our County Council's vote on May 26th. It is our hope that the County Council will be able to consider the totality of our shared contributions to increase funding for HCPSS as it considers this important issue. Your action to indicate the amount of fund balance available for use in the FY2022 operating budget prior to May 26th will allow the County Council and the public a full understanding of our shared solution as the Council votes to approve our proposed budget.

I appreciate the challenges that our educators have endured over the past year and am hopeful that our shared efforts to increase the HCPSS operating budget will be used to foster a positive teaching and learning environment for both our children and educators. Thank you for your attention to this matter.
