1	WHEREAS, the Plat titled "Nordau Subdivision" was recorded among the Land Records
2	of Howard County at Plat Book 3, page 51 and included a note that "all roads shown on this plat
3	are intended for dedication to public use"; and

5	WHEREAS, Rose Lane was platted as a part of the development of the Nordau
6	Subdivision located in Jessup, Howard County, and the County has not formally acted to accept
7	the dedication of Rose Lane as noted on the plat by the developer; and

9	WHEREAS, the Plat shows a 40-foot wide Right of Way for Rose Lane, which is
10	1,682.55 feet in length; and

12	WHEREAS, Rose Lane has been used as a Right of Way and the County has installed
13	and maintained paving and public utilities in Rose Lane; and

15	WHEREAS, the County wishes to accept the dedication of a Right of Way for Rose
16	Lane for the entire 1,682.55 feet in length so that the County can continue to maintain currently
17	existing utilities and install additional utilities as needed.
