

1	WHEREAS, in accordance with Section 18.204 of the Howard County Code, the Wilde
2	Lake Business Trust ("petitioner") has petitioned the Howard County Council to close Lynx
3	Lane; and
4	WHEREAS, Section 18.204 of the Howard County Code provides for the closure of an
5	existing county road by adoption of a County Council resolution; and
6	WHEREAS, the road to be closed, Lynx Lane, is shown on the attached plat identified as
7	Exhibit A and more particularly described in Exhibit B; and
8	WHEREAS, Lynx Lane was conveyed to Howard County in a deed dated January 21,
9	1969, recorded among the land records of Howard County, Maryland (the "Land Records") on
10	January 23, 1969, at Liber 503, Folio 213 and is depicted on the plat recorded among the Land
11	Records in plat book 12, folio 43; and
12	WHEREAS, petitioner intends to request the County to convey to the fee simple interest
13	in the road bed of Lynx Lane after it is closed, reconstruct Lynx Lane as part of the
14	redevelopment of the Wilde Lake Village Center, and provide a private road, Lynx Lane, open to
15	the public; and
16	WHEREAS, petitioner intends to provide full public access to the reconstructed Lynx
17	Lane; and
18	WHEREAS, there are no connecting streets along Lynx Lane and access from Lynx
19	Lane to the roads where Lynx Lane terminates, Twin Rivers Road and Cross Fox Lane, will be
20	retained by the petitioner in the redeveloped Wilde Lake Village Center; and
21	WHEREAS, the Departments of Public Works, Planning and Zoning, Police, and Fire
22	and Rescue Services have each reviewed the proposal to close Lynx Lane and each has
23	determined the closure will not affect public safety, the traffic network, or public convenience;

2	WHEREAS, the petitioner will ensure that traffic flow and pedestrian access to the
3	Wilde Lake Village Center will not be harmed by the closure of Lynx Lane; and
4	WHEREAS, the petitioner has paid a fee in accordance with Section 18.204 to cover the
5	costs of advertising the proposed closing, notifying adjoining property owners, and posting Lynx
6	Lane; and
7	WHEREAS, notice of the proposed closing of Lynx Lane has been posted and advertised
8	and the adjoining property owners have been notified in accordance with Section 18.204; and
9	WHEREAS, the petitioner, at its cost and expense, will cause the closure of Lynx Lane,
10	as described and shown in Exhibits A and B, in accordance with all applicable Howard County
11	standards and specifications.
12	NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County,
13	Maryland this day of, 2012 that, in accordance with Section 18.204 of
14	the Howard County Code, the closure of Lynx Lane as shown on Exhibits A and B will not
15	adversely affect public safety, the traffic network, or public convenience.
16	BE IT FURTHER RESOLVED, that Lynx Lane, described and shown in Exhibits A
17	and B, is no longer need as a public road and shall be closed.
18	BE IT FURTHER RESOLVED, that the petitioner shall bear all of the costs and

expenses associated with closure of Lynx Lane.

- 1. NORTH 89 DEGREES 48 MINUTES 02 SECONDS WEST, 35.31 FEET, THENCE;
- 2. CONTINUING, SOUTH 45 DEGREES 11 MINUTES 58 SECONDS WEST, 344.12 FEET, THENCE;
- 3. CONTINUING, 41.30 FEET ALONG THE ARC OF A CURVE TO THE LEFT, HAVING A RADIUS OF 75.00 FEET, A CENTRAL ANGEL OF 31 DEGREES 33 MINUTES 03 SECONDS, AND A CHORD BEARING AND DISTANCE OF SOUTH 29 DEGREES 25 MINUTES 30 SECONDS WEST, 40.78 FEET, THENCE;
- 4. CONTINUING, SOUTH 13 DEGREES 39 MINUTES 02 SECONDS WEST, 322.52 FEET, THENCE;
- 5. CONTINUING, SOUTH 31 DEGREES 20 MINUTES 58 SECONDS EAST, 35.36 FEET TO A POINT ON THE NORTHERLY RIGHT-OF-WAY LIMITS OF CROSS FOX LANE (VARIABLE WIDTH RIGHT-OF-WAY), THENCE WITH SAID NORTHERLY RIGHT-OF-WAY LIMITS;
- 6. NORTH 76 DEGREES 22 MINUTES- 47 SECONDS WEST, 99.98 FEET, THENCE DEPARTING SAID NORTHERLY RIGHT-OF-WAY LIMITS AND WITH THE WESTERLY RIGHT-OF-WAY LIMITS OF SAID LYNX LANE, THE FOLLOWING FIVE COURSES AND DISTANCES;
- 7. NORTH 58 DEGREES 39 MINUTES 02 SECONDS EAST, 35.36 FEET, THENCE;
- 8. CONTINUING, NORTH 13 DEGREES 39 MINUTES 02 SECONDS EAST, 322.52 FEET, THENCE;
- 9. CONTINUING, 68.83 FEET ALONG THE ARC OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 125.00 FEET, A CENTRAL ANGLE OF 31 DEGREES 32 MINUTES 51 SECONDS, AND A CHORD BEARING AND DISTANCE OF NORTH 29 DEGREES 25 MINUTES 30 SECONDS EAST, 67.96 FEET, THENCE;
- 10. CONTINUING, NORTH 45 DEGREES 11 MINUTES 58 SECONDS EAST, 344.12 FEET, THENCE;
- 11. CONTINUING, NORTH 00 DEGREES 11 MINUTES 58 SECONDS EAST, 35.36 FEET TO A POINT ON SAID SOUTHERLY RIGHT-OF-WAY LIMITS OF TWIN RIVERS ROAD, THENCE WITH SAID SOUTHERLY RIGHT-OF-WAY LIMITS:
- 12. SOUTH 44 DEGREES 48 MINUTES 03 SECONDS EAST, 99.92 FEET TO THE PLACE OF BEGINNING.
