CB63-2021 by its terms allows an open meeting to be conducted in person by telephone, video conferencing, or other electronic means, or **any combination thereof.** One possible combination would be where the body meets in person and the public has to participate remotely. While apparently this is authorized by the Open Meetings Act, I believe that if a quorum of a body is meeting in person, then the public should be invited to that location. I worry that some of the County boards and commissions might interpret the provision to allow such bifurcated hybrid meetings. This would be particularly problematic in contested cases where some of the parties are allowed to attend in person while others are not given the same opportunity.

In addition, related to the concerns expressed by Councilmember Jung during the public hearing, any hybrid meeting should be clearly posted with the physical location. I note the recent September 9, 2021 meeting of the Zoning Board. It

was not clear at the time or even when now reviewing the postings that this was a hybrid meeting. The agenda does not state the physical location for the meeting:

Improvingly, the September 29, 2021 Zoning Board calendar page does say "Banneker Room and WebEx."

Furthermore, "other electronic means" could be read to include texting, instant messaging, posting on Facebook, or by email. See 14 OMCB 33 (2020) (email exchanges of the HCPSS Board).

Lastly, because the bill only applies to open meetings, it is unclear what means are permissible for closed meetings.

I hope that the bill can be amended to clarify these issues.
