<u>Carpe Diem</u>. We have reached a pivotal moment in Howard County for the cause of police accountability. We must together seize this moment, at the culmination of an outpouring of public demand for increased accountability in policing across our county, our state and our country. This follows the brutal murder of George Floyd in 2020, as well as so many other similar, unjustified and senseless law enforcement killings of black and brown citizens across America before and since his death. This is why we act. This is why we fight.

The Police Accountability Task Force of Howard County (PATF-HoCo) believes passionately in the cause of police accountability. And we are confident that our HoCo law enforcement leadership shares our view that effective law enforcement requires, indeed demands, full police accountability.

It is for these reasons that PATF-HoCo, coordinating with its Coalition Partners, places great importance on ensuring that the new Police Accountability Board ("PAB"), mandated by the Maryland Police Accountability Act of 2021, is established in a manner that enhances police accountability and that places Howard County at the forefront of our country in embracing police accountability as a key component of effective policing and public safety.

Sadly, Bill 83-2021 falls far short in meeting these goals. As we have recently noted:

- Under Amendment 3 to 83-2021, each PAB member would be required to sign the "necessary confidentiality or nondisclosure agreements." This is totally unacceptable as it would severely hamper the PAB's communications with the public on matters of police misconduct. This is blatantly inconsistent with the PAB's role of driving greater transparency and accountability into policing in Howard County.
- The original Bill 83-2021 is lacking any provisions that would give the PAB access to relevant law enforcement records or police body-worn camera recordings. Without such a right of access, the PAB is essentially powerless to provide any timely review of serious incidents of police misconduct or the necessary oversight over officer misconduct and police accountability for the Howard County community.
- The PAB's timely access to review law enforcement records and police-body worn camera recordings will be particularly important if a Critical Incident (an officer-involved shooting or other officer use-of-

force) occurs within our county. Yet the proposed Bill and amendments are silent on this vital subject, thus effectively sidelining the PAB at a time when consideration of police accountability would be of utmost importance.

• The original Bill 83-2021 would prejudice the selection of PAB members towards those who are former career law enforcement or county administration employees. This must be rejected. It is critically important that PAB membership reflect the Howard County community it serves, not potentially partisan agencies.

Following the tabling of Bill 83-2021 by the County Council on January 4, there is now a real opportunity to address these flaws. We call upon the County Executive to support Deb Yung's important amendments to the Bill. We call upon the County Executive to support adjustments we are seeking to Councilmember Rigby's Amendment 2 to Amendment 3 dealing with confidentiality. We also call upon the County Executive to support a new amendment providing the PAB with the authority to review law enforcement records and body-worn camera recordings expeditiously after any Critical Incident.

Without these changes, it is our view that Bill 83-2021 will actually do damage to the cause of police accountability in our county. We are striving to change this outcome.

We stand ready to work with the Administration to address the concerns we have raised over Bill 83-2021. We share Dr. Ball's view that the Police Accountability Board "*is an important tool to engage our residents in matters of policing and adds another layer of accountability.*" In this vein, we urgently request a meeting with Dr. Ball and his team to discuss <u>our recommendations</u>, so that we can move forward together with the creation of a Police Accountability Board that increases police accountability, promotes effective law enforcement, and enhances public safety in our community.

We will adjust our schedules to be able to meet with you at your convenience. Please advise.
