As an organization dedicated to a prosperous community and growing tax base, the Chamber works to drive economic development, foster a pro-business climate, and support our members. It is in the purpose of economic development that I come to you now.

As consumers use their mobile devices more than ever to connect to the world around them, we must find new and innovative ways to enhance mobile networks. Not only do these networks need to be prepared to meet the increasing demand for mobile data, they must be prepared for the next generation of technologies— such as 5G, Smart Cities and the Internet of Things (IoT). For these reasons, we please to support CR 15 which references the fees communication firms must pay for above ground facilities.

Small cells are a low profile, compact and unobtrusive technology that can be installed in high-traffic areas to increase network capacity and provide enhanced voice and data services for our members. This broadband infrastructure is necessary for providing a better wireless experience for our members in Howard County who rely on their smartphones and mobile devices to start or grow a business; stay in touch with customers; and promote their products and services.

We believe that if we are to ensure our wireless infrastructure keeps up with the demand for mobile technology, we need legislation that will assist with the investment in small cell infrastructure.

As such, we encourage the passage of CR 15 that will assist in the permitting process for the deployment of small cells and encourage wireless providers to invest in our Maryland networks.
