A RESOLUTION declaring that approximately .914 acres of real property owned by Howard County and identified as a portion of the road bed of Lynx Lane is no longer needed for a public purpose and authorizing the County Executive to waive the advertising and bidding requirements of Section 4.201 of the Howard County Code in order to convey the property to the owner of the adjacent property, Wilde Lake Business Trust; and providing that the County Executive is not bound to convey the property if he finds that the land may have a further public use and submits his finding to the County Council for its consideration.

1	WHEREAS , Howard County is the owner of certain real property known as a portion of
2	Lynx Lane containing approximately .914 acres of land (the "County Property"), as shown in the
3	attached Exhibit A located between Cross Fox Lane and Twin Rivers Road, and as acquired by
4	Deed dated January 21, 1969 and recorded among the Land Records of Howard County,
5	Maryland in Liber 503, Folio 213; and
6	
7	WHEREAS, by passage of Council Resolution No.143-2012, the County Council closed
8	the above referenced portion of Lynx Lane and that portion of Lynx Lane can now be disposed
9	of in accordance with County law; and
10	
11	WHEREAS, the property owner adjacent to the County Property is Wilde Lake Business
12	Trust; and
13	
14	WHEREAS, the Wilde Lake Business Trust asked that the County Property be disposed
15	of in accordance with Section 4.201 of the Howard County Code; and
16	
17	WHEREAS, the Department of Public Works has reviewed and approved the proposed
18	disposal of the County Property; and
19	
20	WHEREAS, Section 4.201, "Disposition of Real Property", of the Howard County Code
21	authorizes the County Council to declare that property is no longer needed for public purposes
22	and also authorizes the County Council to waive advertising and bidding requirements for an
23	individual conveyance of real property upon the request of the County Executive; and

25	WHEREAS, the County Council has received a request from the County Executive to
26	waive the advertising and bidding requirements in this instance for the conveyance of the County
27	Property to the Wilde Lake Business Trust.

29	NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County,
30	Maryland, this day of, 2012, that the County Property is no longer

needed for a public purpose and that the County Property, comprising approximately .914 acres, may be conveyed to the Wilde Lake Business Trust, as shown in the attached Exhibit A.

AND BE IT FURTHER RESOLVED that, having received a request from the County Executive and having held a public hearing, the County Council declares that the best interest of the County will be served by authorizing the County Executive to waive the usual advertising and bidding requirements of Section 4.201 of the Howard County Code for the conveyance of the County Property to Wilde Lake Business Trust.

AND BE IT FURTHER RESOLVED that, if the County Executive finds that the County Property may have a further public use and that the County Property should not be conveyed, he may submit his findings and recommendations to the County Council for its consideration without being bound to convey the County Property in accordance with this Resolution.
