14	submitted to the Department with applications for all development not exempt under section
15	16.1202 of this subtitle.
16	(b) <i>Professionally Prepared</i> . The forest conservation plan shall be prepared by a licensed
17	forester, licensed landscape architect, or certified arborist.
18	(c) Forest Stand Delineation. The forest conservation plan shall include a forest stand
19	delineation for the property to be subdivided, developed, or graded. An approved forest stand
20	delineation is valid for five years. The forest stand delineation shall:

22	relationship to environmentally sensitive areas on-site and to forest resources on adjacent
23	properties.
