


Answer: Many trees, birds, animals, plants, and kids. All of which are important to our community and our environment. Once their home is gone, it is gone for good!


Brownie Girl Scout Troop 1890 completed their <u>Outdoor Journey</u> by flying into action to learn about the wildlife and habitat of the Girl Scouts of Central Maryland's Camp Ilchester (Ellicott City, MD) and to raise awareness of what would be lost if the land is developed.

To complete their project, the 3rd grade Brownies:

- Learned about statistical sampling methods and used these methods to estimate the number of trees which will be lost if the 19-acre camp is developed (over 20,000 tree would be lost);
- Surveyed the plants and insects that live in the camp using the Seek (iNaturalise) and Picture This apps (the camp is home to milkweed and a large pollinator garden in addition to many others);
- Researched the birds and animals that depend upon the open space of Camp Ilchester (bats, bees, owls, fox, and many others), and;
- Created posters to share this information with the community to raise awareness of the habitat which will be lost if the area is developed and to call attention to the plants and animals which will be negatively impacted.










I was pleased to hear the possibility of Girl Scouts continuing to meet at the camp and hold activities. I'm hoping this includes GS Howard County Day Camp (GSHCDC), which provides camp experience and leadership skills for so many girls in Howard County. We serve about 500 campers aged 5-13 (including some boys) and over 150 teens, ages 14-18. My name is Justin Mullins and I've lived in Maryland my whole life and in Columbia for the last 7 years where I am now starting a family. I live in the Owen Brown community off of Snowden River Pkwy near Lake Elkhorn and I just wanted to provide first hand insight into projects I believe would greatly benefit the community, Columbia, and Maryland as a whole.

I would love to see sidewalk on the westbound side of Snowden River Pkwy from the local shops (starting from existing pathway at Rustling Leaf) down to the intersection of Snowden River Pkwy and Broken Land Pkwy. This would provide walking access from everyone in Owen Brown and Lake Elkhorn to these local shops and restaurants which would be amazing for both the community and shop/restaurant owners.

Additionally, it would be nice for the Owen Brown community off of Carved Stone to have official paths near the Burger King and Ken's Auto Center as currently many have to cut through the woods and use unofficial paths. I know this would take working/coordinating with the property owner/BGE but I believe it would provide a good pay off for the community and store owners.

A crosswalk is currently underway from Carved Stone to Berger Rd. I would love to see sidewalk installed down Berger Rd to just past Gerwig Ln. This would provide easy and safe walking access to the stores off of Berger Rd to include a highly popular Columbia Brewery, Hysteria Brewing, as well as a Columbia Distillery, Lost Ark Distilling Company. It would have been over \$750/month in savings if we had had car payments! The Howard County Council can't necessarily control rising gas prices or skyrocketing housing prices, but providing a viable option for people to travel without owning a personal vehicle can take an enormous pinch out of the household budgets of those struggling most.

Even though my family is now doing much better financially, we still use bikes and ebikes to travel to work and errands wherever possible so we can save for our kids' college funds and share one car instead of having two. We still benefit from the financial savings, but also enjoy the enormous mental health benefits of having exercise naturally built into our daily routines. In other words, this is an investment that benefits people from all income brackets.

As an employee in Howard County, I frequently attempt to commute into the county, but unfortunately, instead of the 7 mile direct route, I must take a safer and LONGER 11 mile route. This may not sound like much if you drive a car, but it's a serious problem that includes extra hills and doubling the time of my commute. Even so, the route available to me is on roads, sometimes shared with aggressive intersections (such as horrible-for-cyclists traffic circles along MD-216 and Johns Hopkins Rd) and 2-3 lanes of traffic with dedicated bike lanes.

Even before the pandemic, all these lanes are never filled (even in rush hour time frames) and it would be appropriate to begin road diets (re-appropriating a lane dedicated and protected for people using bicycles) on the many roads serving the areas south of Columbia such as Cedar Ln, Johns Hopkins Rd., and MD-216, to start. Worse, the zone around Reservoir High school is seriously inappropriately designed on steroids with extra turn lanes, multiple thru lanes and a tiny 4-5 ft "painted" bike lane (which we all know is the bottom of the barrel for safety) and you want children to safely cross this MD-216?

All this needs to be fixed and at a minimum \$8 million needs to be balanced against fixing this poor infrastructure -- and I would hope that on the state maintained roads you will be able to get funds from the state to fix those issues.

My name is Brandyn Geist, I live in Laurel, MD, and am providing testimony in support of the Community Ecology Institute (CEI) for robust inclusion in the county's operating budget. My relationship with CEI is as an intern from Towson University's Doctorate of Occupational Therapy program. As you know, CEI is a unique local success story and making rapid strides towards fulfilling its mission to cultivate communities where people and nature thrive together by working towards tangible, community-level change at the many intersections of environment, education, equity and health.

I have been fortunate enough to have extensive experience and connections with CEI, Freetown Farm, and Howard County as a whole. Within the first page, I will emphasize the most pertinent details of my positive outcomes due to my experience with CEI and Freetown Farm. I will further detail the tremendous family history and connection to this community, paralleling the mission and quality of life numerous generations of my family have pursued.

As a clinical occupational therapy student who seeks out nature in all capacities (growing herbs and vegetables, barefoot hiking, camping, swimming, etc.), I have aspired to integrate nature into rehabilitation programs for individuals facing diverse and unique disabilities from the beginning of my graduate education. Assigned to CEI in Spring of 2020, I had the opportunity to work with Chiara D'Amore and students in the Howard County Public School system to cultivate sustainable and nature-based engagement opportunities that develop job skill training and life skill programs within the county to increase performance capacities and autonomy in daily living for the neurodiverse students. Freetown Farm served as a space for not only job skill training for neurodiverse students, but for myself as well.

Since Spring of 2020, I have completed my capstone research analyzing the impact nature has on individual elements of health, well-being, and quality of life as well as holistic support to engagement, performance capacities, and sense of purpose. As increasing research evidences the positive correlation between exposure to nature and health, wellbeing, and quality of life, I am now interning with CEI and Freetown Farm and focused on developing an evidence-based proposal to expand the ADA compliant and accessible nature-based spaces within the community. In conjunction with a grant application to AARP supporting Aging Friendly Community Howard County, the ADA compliant pathway and planting patio I have proposed provides opportunities for sensory exploration,

community engagement, social space, leisure activity, intergenerational teamwork, and nature-based occupations addressing fine and gross motor skills, stability, endurance, cognitive function, task sequencing, visual perceptual functioning, and more.

Living in Laurel, MD since the start of my doctorate degree, I have been seeking out nature-based opportunities myself when not caregiving for my 89 year old grandfather. Sometimes these activities include driving my grandfather to Freetown Farm, which provides him comfort as he fled from Queens, NY city life to Laurel, MD over 60 years ago. He was the buyer of a similar sized, 6-acre plot where he hand-built a home and barn, raised a family, and stewearded the land in a sustainable and community-based manner. Grandpa planned, prepared, planted, harvested, and transformed home grown food through family and friend workdays. My mom to this day shares the different roles and jobs people completed; the number of family members and friends who were welcomed, educated, and incorporated into the process; and the many types of foods freshly prepared and shared at the end of the days. This intergenerationally-valued, sustainable lifestyle my grandfather led has significantly expanded the health, wellbeing, quality of life, knowledge, and life skills of numbers generations following him. As my family and I provide full-time care to him, enabling him to age in place, we value and integrate sensory input, nature-based engagements, and community oriented activities to assist in sustaining functional capacities and quality of life.

CEI's ability to provide the foundational skills I am so fortunate to have been raised by to the community at large is critical and positively impactful for the people lacking access to nature-based activity across the lifespan. Freetown Farm directly correlates to developing children's skills of imaginative play, sensory development, social skills, problem solving capacities, and so much more. Furthermore, it allows for high schoolers within the community to expand practical language, motor skills, and academic knowledge into a transferable environment strengthening the autonomy and job/college readiness. Adults are able to learn new skills and their impact on the earth and future generations. They are able to meet diverse peers and develop stronger community relationships, and they serve as active, engaged demonstrators of healthy living (physically, socially, emotionally, cognitively, leisurely, etc.). Lastly, aging citizens serve as beacons of information, sharing the valuable knowledge and experiences of their lifetime resulting in opportunities for our youth, adolescents, and adults. Aging residents benefit from this social, occupational, health oriented environment rather than being excluded from engagement opportunities limiting health and wellbeing. CEI's community programs and Freetown Farm's endeavors serve the entirety of our diverse community, bringing about unity, strength, and health in a sustainable fashion.

From my family, personal life, leisure priorities, professional studies and research, I recognize the pertinent and health-supporting work in the community for both our people and our planet. I joined CEI as a staff member in June 2021, as the Nourishing Gardens Program Director. As you know, CEI is perhaps best defined by our collaborative, community-based approach towards creating real-world advancements towards social, economic, and environmental health and wellbeing. We are making rapid strides towards fulfilling our mission to cultivate community-level change at the many intersections of environment, education, equity, and health.

In 2019, CEI purchased what once was Shaw Farms, an institution in organic community supported agriculture here in Columbia, MD. Protecting the property from development and conserving it as a place for environmental education and exploration, CEI has systemically transformed Freetown Farm into a place where community members can work collaboratively, design and offer educational programming that improves people's connection to nature and their local food systems, and practice the skills needed to transform our relationship between our daily lives and the environment in which we live.

Since then, the farm has become a gathering place. A place where artists, gardeners, environmental enthusiasts, children, retirees, and neighbors come together for a shared common goal to create healthy and reciprocal relationships among each other, and with the land we live and work on. They come to volunteer. They come to participate in experiential education workshops. They come to contribute to a vibrant, nutritious, locally-grown food system. They come to share in fellowship, to build relationships, and to repair them.

In 2021, CEI launched the Nourishing Gardens program. Its efforts are two-fold, to transform lawns, that provide little by way of benefit to our local ecology or food system, into gardens that nourish ourselves, our community, and the environment. In doing this, the program trains community members with the skills needed to design and install food and pollinator gardens. Trainees are then qualified to become a part of paid installation teams – expanding CEI's opportunity to provide green infrastructure jobs that support our local economy and contribute to economic mobility.

This program brings the experiences and benefits of Freetown Farm, directly to our neighbors' doorsteps, increasing the biodiversity of our communities, providing access to locally-grown nutritious fruits and vegetables, and providing very real opportunities for community members to connect, work together towards a common goal, and protect the environment.



In 2022, 2023, and beyond, we look forward to the grand opening of our indoor community engagement center. We are preparing to significantly expand our workshop offerings from gardening and climate action, to lost arts such as fabric dyeing, to cheesemaking, and printmaking. We are committed to expanding Nourishing Gardens to install at least 13 school gardens, continue to support nearly 10 community-based gardens, and begin providing essential garden installation services to individual community members.

Last year alone, we trained 15 team members through Nourishing Gardens, who by the end of the training reported improved personal health and wellbeing, a greater feeling of connection to our community, and significantly increased skills and knowledge about gardening, our local food systems, and protecting the environment. These 15 team members contributed more than 450 combined hours of service to the community caring for and installing gardens in open spaces in Columbia. This year, we look forward to welcoming a new cohort of 20 trainees, and seeing all they will accomplish during their time with us.

We see Freetown Farm as a catalyst for community members to envision a community in which we see ourselves as an integral part of our ecosystem, worth nourishing. This sustainable future requires investment both social and economic to ensure it has the foundation to define and support its growth. CEI's work in the community is one-of-akind and in direct alignment with the county's priorities of having thriving and healthy residents and a clean and sustainable environment. Throughout the COVID-19 pandemic the Howard County Recreation and Parks Department (HCRPD) was a shining light for organizations such as the Howard County Autism Society (HCAS) that serve the disability community. Their Therapeutic Recreation team called on every resource and all their creative mojo to deliver programming that kept our youth, young adults and families socially engaged during some very trying days with everything from DJ dance parties and summer clubs to trivia sessions and BINGO...you name it and they thought of it. With their partnership and support, we were able to offer programming that our organization alone could not have put forth, at an affordable price that worked for both us and our community.

At HCRPD, affordability and accessibility go hand-in-hand. A fully funded operating budget is absolutely essential so that they can maintain and expand programs and services to meet the needs of the community as we continue to recover form the pandemic and face the current inflation challenge.

Expanding operational funding would allow for the development of additional outdoor programming opportunities such as festivals in the park, movie nights, fitness and much more. The Autism in the Park event on April 2nd is a perfect example. HCAS is partnering with HCRPD on this amazing new event at Laura's Place Playground in Blandair Park to celebrate World Autism Acceptance Day featuring children's activities, music, ice cream and space to play together. This free public event will uplift the Autism community in Howard County while celebrating this amazing inclusive play space HCRPD has brought to our county, one that draws families from across the state to experience an accessible and inclusive play space. It is an example for every county and every state.

Expanded funding will also ensure that HCRPD can attract a high caliber of talent to work on their programs, facilities and parks. Fully funding the operation budget will help them attract and keep employees who can deliver the kind of quality programs and services Howard County is known for.

At the same time, we must ensure that HCRPD's capital budget must also be fully funded and, preferably, increased. The department has added many facilities that compete with funding for maintenance and replacements. Laura's Place Playground, mentioned previously, is a perfect example. Its popularity since opening in June 2021 means heavy use and maintenance requirements and the playground is already showing signs of wear. It is critical that HCRPD have the resource to fund these systematic repairs and maintenance.



The addition of adult changing tables in public facilities – now a law in Maryland – is so important to the disability community. It's about dignity, ensuring that individuals with personal care needs have a safe, clean area. Let's ensure these renovations happen in a timely manner.

Finally, HCAS was honored to be part of a movement to added augmented Communication Boards to playgrounds here in Howard County. These allow for individuals with low or limited communication to play inclusively with peers on the playground without having to carry a bulky device. Together with HCDRP, we added two of these boards to Laura's Place Playground, with pictures and braille characters that tear down barriers and make space for new friendships. Capital funding will ensure that more of these boards can live on playgrounds throughout Howard County, joining those found now on every elementary school playground, and three HCRPD inclusive play spaces.
