1	NOW, THEREFORE, BE IT RESOLVED by the County Council of Howard County.
2	Maryland this day of, 2022 that the fee-in-lieu for moderate income housing shall be
3	calculated according to the language originally proposed in Council Bill 35-2013 as follows:

5	(1) The fee-in-lieu shall be calculated as the difference between the prevailing market
6	price and the moderate income housing unit price of a three-bedroom single-family attached unit;
7	provided, however, the fee-in-lieu shall not be less than seven and one-half percent of the sale
8	price for the moderate income housing unit;
9	
10	(2) The prevailing market price shall be determined by a survey of sales prices of three-
11	bedroom single-family attached units sold county-wide within the previous 6 months as reported
12	by the Metropolitan Regional Information System (MRIS);
13	
14	(3) Sales of the following units shall be excluded from the survey:
15	
16	(i) Townhomes less than 1,200 square feet and more than 2,000 square feet;
17	
18	(ii) Units in poor condition or in need of significant repair or renovation; and
19	
20	(iii) The three highest and three lowest sales prices;
21	
22	(4) The Department shall conduct the survey as of June 1 and December 1 of each year.
23	The fee-in-lieu shall be reviewed and approved by the Housing and Community Development
24	Board and published on the County's website together with the base sales prices and rents for
25	moderate income housing units.

27	(5) If the calculation to determine the number of moderate income housing units required
28	by a development under the Zoning Regulations results in a fraction of a unit, the fee-in-lieu
