Testimony Before the Howard County Council CR102 – A Resolution Requesting Governor Hogan to Immediately Release Specified Funds for The Abortion Care Clinical Training Program Established Under Maryland Law June 21, 2022 Support

Planned Parenthood of Maryland strongly supports CR 102 because it is needed to ensure that Maryland is prepared for the imminent overturing of *Roe v. Wade*. In the next few weeks, the Supreme Court is will release a decision in *Dobbs v. Jackson Women's Health Organization*, which is expected to result in 26 state's banning or severely restricting abortion care. This will lead to Maryland experiencing a significant influx of patients from other states coming to Maryland for care.

The implementation of SB 8 in Texas, give us a sobering preview on abortion access after the Dobbs decision. A month after SB 8 went into effect, the number of abortions in Texas dropped by 50%. Individuals who were able to go out-of-state traveled hundreds of miles for services, sometimes even thousands as we have seen individuals from Texas at Planned Parenthood of Maryland. The states that surround Texas were overwhelmed by requests for abortion care appointments – increasing waiting times for both in-state and out-of-state patients to as long as 19 days in Louisiana, 20 days in New Mexico, and 23 days in Oklahoma.[†]

Maryland is already the worst state for abortion access geographically, when we are compared to other East Coast states with similar abortion rights protections. Maine, the most rural state on the East Coast, has providers in 69% of its counties which is the exact opposite of Maryland where 71% of counties do <u>not</u> have a single abortion provider. ii

As we know from the Texas experience, when one state bans abortion, the impact is felt in the surrounding states and throughout the region. With 26 states poised to ban or severely limit access, the scale of the abortion access crisis could be immense, particularly in states, like Maryland, already facing access issues. When Marylanders live outside of the Baltimore-Washington corridor, they usually have to travel to obtain abortion care. This situation can be immensely challenging for those facing limited resources as they have to arrange for transportation, time off of work, and child care. After the Dobbs decision, they could very likely face the additional barrier of waiting times for services.

Maryland does have many healthcare providers who would be able to provide care if they had access to training options. Opportunities for abortion training are shrinking, especially for practitioners educated in states like Texas where abortion is banned or severely restricted. In order to ensure that Maryland has enough providers to address increased need for care, the General Assembly set aside \$3.5 million for an Abortion Clinical Training Program. However, the Governor has not yet released these important funds. This resolution will help highlight the urgency of the need for increased provider training.

The Maryland Affiliate of American College of Nurse-Midwives (ACNM) supports CR 102, which calls on Governor Hogan to release the \$3.5 million the General Assembly set aside to train Maryland abortion providers. Howard County is one of the 71% of Maryland counties that do not have an abortion provider. The release of the training fund is essential to ensuring Howard County residents have access to abortion care following the Supreme Court's decision in *Dobbs v. Jackson Women's Health Organization*.

The recent leaked draft of the *Dobbs* opinion has made it clear that the Supreme Court is preparing to imminently overturn *Roe v. Wade*, which is expected to result in 26 state's banning or severely restricting abortion care. This will result in an unprecedented number of out-of-state patients coming to Maryland for abortion care. Because of our current provider shortage, we are not going to be able to provide timely care to these out-of-state patients, nor are we going to be able to ensure that Maryland patients are able to access care without significant delay. However, we have physicians, nurse practitioners, nurse midwives, and certified midwives who are capable to provide abortion care, but due to lack of training options are not currently able to provide this care. Releasing the abortion training funds would allow Maryland to begin to close our provider gap and prepare for the overturning of *Roe*.
