I do want to go beyond my very brief thank you for introducing this bill. And I do want to clarify that I will not personally benefit from this change.

My wife and I moved to Howard County in 1977. Since that time we have always lived in owned houses and have been paying real estate taxes for 45 years. However, during that period we have lived in three different houses. Each time we moved the qualification period for this tax credit re-set to zero.

We moved into our current home 17 years ago so under even the revised legislation we will not be eligible for the Aging In Place Tax Credit for another 18 years. At that time, if I am still abound and still able to live in my home, I will be 93. So I think the odds of my ever getting relief under this tax credit are rather slim.

But I do believe it is important for the change you propose eliminating the five year duration of the credit. Over time, more will need to be done.

Thank you for taking the lead in this important early step.
