I fully support the provisions of CB52-2022 and compliment Councilperson Deb Jung for introducing this legislation. It's "common sense" and a meaningful enhancement of value to Older Adults, their families and the County as well.

My understanding is that it is limited to those fortunate (and maybe sensible) enough to have lived in the same residence for 35 years. While more of us will meet the 35 year residency requirement, this will be as the song goes "a long time coming". I've been a County homeowner since 1981, but won't meet the 35 year residency in my current home until 2039 at age 89. And since I intend to stay there, I will not reveal my spouses age at that time.

But I'm not suggesting delaying or amending CB 52, just that it has a limited impact-all the more reason to lift the 5 year cap to continue to receive the Credit. It is also worth noting the likelihood that many of those qualifying will be "Solo Agers" -most likely women with more limited resources. It may be that the 35 year rule should be modified further. Options should be studied in the County's Age Friendly initiative.

In the meantime, the County should begin a proactive outreach to seniors who have qualified for the Income based Senior Tax Credit (or the Aging in Place Property Tax Credit) so they will know the "ins and outs" of continuing to live where they are and can make modifications for the very real possibility of receiving long term care at home.

The County should provide in home evaluations for these residents . This should include:

- Conducting or Facilitating An Age Friendly Home Safety / Home Risk Assessment to assure that their homes are as safe as possible for daily living. This would include a Universal Design /Visitability Assessment based on the Universal Design Guidelines for Age Restricted Adult Housing in Howard County.
- Encouraging/Facilitating a documented "Aging in Place" Plan (Full Independence) and a Plan B (What When- Not If -Health/Mobility Changes). This should Estate Planning, POAs, and Advance Care Directive(s) developed with family and professional guidance.

- Conducting or Facilitating Technology Assessment and Assistance. Affordable internet and WIFI access county wide fosters communications, services and the use of Telehealth. Technology will help provide for long term care at home and lessen the burden on family caregivers .
- Conducting or Facilitating Energy Efficiency Assessments and Assistance. Homes occupied by older adults qualifying for the credit are decades old (at least 35 years), and many are energy inefficient and unhealthy –e.g., mold in the HVAC units and clogged ducts. This drives up utility costs and has adverse health consequences as many older adults keep home temperatures abnormally high or low.
- These assessments would bring a great return on the investment needed to maintain the safety, health and well-being of our older adults. It will also reduce the burden on caregivers, other County services and health providers . A "Win-Win".

Democracy requires participation. That's my take on CB 52-2022 and the opportunity it offers.

I am writing in support of CB52: Aging-in-Place Tax Credit Extension. I respectfully ask that you vote to pass CB52 as noted above.

My late husband and I moved to Howard County in 1977. We moved from our townhouse to a single family house in 1987 and raised our children here. I have continued to live in the house since his passing in 2003. The County is a great place to live and I hope to live out my years here.

I will be applying for the Aging-in-Place Tax Credit in FY2024. Needless to say I was very happy that the law changed the number of years living in the same house from 40 to 35 (as I do not qualify for other tax credits). The five-year limit on the tax credit (as it currently stands) will cause a financial burden to seniors once the five year cap is reached. Property taxes will continue to increase, but retirees fixed incomes will not be able to support these increases. Removing the five-year limit would certainly assist me to remain in Howard County, as well as other qualified seniors who have supported the County for many, many years.


