County Council Members:

The Howard County Sierra Club supports CB54 as this important legislation will increase conservation of trees in a fragile and vital watershed.

This legislation is a follow up to CB80-2016, an emergency bill that passed with these same provisions, that was sponsored by Councilman Jon Weinstein and our current County Executive Calvin Ball when he was on the county council. While this bill did pass, it did not get incorporated into the Forest Conservation Act. Passing CB54 would correct this oversight and make sure that these protections passed in 2016 go into the current Forest Conservation Plan.

The second main component of the bill is that forest mitigation will not be permitted to be done offsite. This is of critical importance to maintaining the watershed management in the Tiber Branch Watershed. Conserving established trees and replanting trees are of great value to watershed management, but for them to be of use to Old Ellicott City directly, they must be in that same watershed, and ideally on site.

Since the time of the first bill, which followed the first deadly flood in Ellicott City, we have seen an additional deadly flood happen in the same location. Maintaining the resiliency that is gained by conserving forest and trees in the Tiber Branch Watershed is ever more critically important than we first thought.

This bill will result in increased protections of forest and large trees that will in turn increase the resilience of the Tiber Branch Watershed, which will result in protection for Old Ellicott City. We urge you to pass this common sense and fiscally responsible bill.

County Council Testimony on CB 54

Group Testimony Support

Council Member Walsh is again trying so hard to protect the flood-prone areas of the County so deeply in need of stricter attention. Time and again she has brought out the need to plan in a more strategic and regional fashion, and yet, rarely does the majority of the Council participate in this deeply needed environmental and safety protection issue of the overly excessive deforestation in the Tiber Branch Watershed.

As you all know, for a long time, the Howard County Department of Planning and Zoning granted waivers regarding forest conservation that were not in compliance with State required definitions of "hardship" criterion for waivers to cut more trees and larger trees. When things are done inappropriately in an extreme direction, it makes sense to push to protect what we have left, more vigorously. Will you all please do the right thing and assist the much needed protection of a watershed that has been allowed to be deforested far more than was even legally supposed to occur in the past?

We all know that these long-term intense clear-cutting projects have not been done with no ill effect. The Army Corps of Engineers noted in their hydrology report after the 2016 flood that deforestation does decrease the percentage of storm water retention on a parcel, even with mitigating efforts of new projects. This remains true even with updated standards. We need to start making our regulations more regionally-based to address differing needs of county areas. Not every area has the same topography nor flooding risks. The one size fits all waiver allowances criteria have to be revisited. This Bill is a good start.
