Dear Sir/ Madame,

Thank you for your acknowledgment of my previous letter in support of the above bill. However we simply need to do more. The CB54 2022 Bill has highlighted a fundamental need for our county and state to update our policies with a more comprehensive understanding of nature.

We need to build pressure to protect trees but we also need to raise the bar of future development. We simply cannot afford to ignore the nature assets we have in our area. We need to develop with our nature assets rather than demolishing them and only increasing the flood risk of our community. That just doesn't make sense.

A developer only speaks in monetary/numerical terms, so we need to quantify nature as such as well. Out of curiosity, the current developer fee seems very arbitrary and I wonder if it captures the full value reflective of the carbon sequestration, air purification, water absorption, heat reduction impacts, and bio habitation creation to name a few?? And what about the time it takes for the plantings to become comparable in their benefits to the established trees? Plus the cost of whatever else will need to be done to mitigate flooding now that the tree is gone?

My initial research showed that no one is doing the above, the forest conservation act of Maryland has some kind of formula, but there are no requirements for native trees, and developers only have to ensure success for only a year, which developers are able to work around.

Quantifying these benefits would provide a baseline to use and start by requiring that developers have to replace all these things plus additional (50%) rather than just a cash fee - they need to replenish what they are taking away. Something like this could also lead to developers getting rain water harvesting systems for non potable uses, or using green roofs and permeable surfaces to deal with storm water issues, or build in a flood resilient way. Obviously the best thing is that trees not be chopped down, but the next best thing is to get them to build features that they are taking away into the developments. This will certainly make it more expensive for developers - but in the long run it's going to be more sustainable, better for residents of said development, and good for all Howard county tax payers. Development will not stop but this kind of building will lead to a resilient Howard County.

I just heard from a neighbor in my community about this bill, CB54-2022. THIS IS IMPORTANT !!! New young trees can't replace big old trees -- that's common sense. And no amount of money can replace them. Money doesn't sequester carbon and hold soil in place -- that's what trees do. And trees in another part of the County don't do the job that trees do where they are located, protecting their own location from soil erosion and providing habitat for wildlife.

It makes no sense to give away trees (about 2000 of them), as Howard County just did, and then turn around and let developers cut down OLD trees that sequester much more carbon. This has been going on in Howard County, and it must stop. Developers: Build your houses AMONGST existing old trees. If you can't, our DPZ shouldn't be giving permission for you to build there.

Councilwoman Walsh has made an impassioned plea for this bill. I support her. I strongly urge the Council to pass CB54-2022. We need trees more than new developments in Howard County.

As an aside, when we bought our home in Dorsey Hall in Columbia in 1980, we chose the lot because it was wooded in front and had a cornfield in back. The trees (most of them) were saved, and we kept that small woods just as it had been when we bought it -- no messing around with it except for naturalizing some daffodils. The trees grew over the last 42 years. They're beautiful. I wake up in the morning looking out at those trees and watching the birds that fly by and land on them; I watch the squirrels chasing each other from tree to tree. Sadly, some of those 100+ year old trees died and had to be removed because they posed a danger to our house. We had the tree removal company leave 15 foot "snags" to provide habitat and to allow them to decompose naturally into compost. The arborist who looked at our dead trees thought they may have been killed by a 6 week summer drought in 2019 -- victims of a changing climate. I miss those three trees (a huge white oak and two maples). A couple more very tall, no doubt very old trees have died since. And the cornfield that had been in our backyard? It's now grass and trees and a rain garden and a pollinator garden and a VEGETABLE garden. We've got the best of both worlds, because the developer left the woods that has become our front yard.

Meagan Braganca CB54-2022 Written Testimony IN FAVOR October 17, 2022

The Forest Conservation rewrite of Howard County was celebrated and splashed across press releases when it was passed in 2019. It was a nice first step, but it's not nearly where we should be. It did not go far enough. If it did, it wouldn't have allowed for the continued deforestation throughout the county that has led to the necessity of this (and other) tree-protecting bills. When the constituents and county leadership understand that, the urgency of passing this bill becomes clear.

CB-54 specifies "No Waivers of Floodplain, Wetland, Stream, FOREST CONSERVATION, or Steep Slope Regulations in the Tiber Branch Watershed" unless certain conditions are present. The fact that waivers have continued to be allowed in the watershed after **three people** drowned in flash floods downtown is beyond comprehension.

It is a dishonor to the memory of the victims - Jessica Watsula, Joseph Anthony Blevins, and Sgt. Eddison Hermond - to continue to allow dangerous land use decisions that leads to further flooding. Trees and their root systems are the best tools we have to mitigate rainwater. The US Environmental Protection Agency, the Center for Watershed Protection and the Alliance for the Chesapeake Bay all say that in order to mitigate rainwater- plant trees and reduce impervious surfaces. We can read the thousands of pages of material out there on how development and the increase of impervious surfaces cause more runoff. But use your mind, your common sense: Development in a flood-prone watershed will worsen runoff problems, and no amount of gray infrastructure or retention ponds can make up for the vast portion of impervious space these developments produce.

I, and many environmentalists in this county, have been extremely disappointed at the dereliction of tree protection that has taken place not just the past few decades, but also the past few years. Vetoing a bill protecting large-diameter trees. I mean honestly, what are our priorities anyway?

I want to thank Councilmembers Liz Walsh and Deb Jung for seeing the forest through the trees, or in this case, seeing the stabilizing trees through the landmine forest of the current muck and corroded "leadership" that has led to a continued tradition of disastrous environmental decisions as they have pertained to forestation and its lackluster protection.

Please pass CB-54. If it fails to pass, the legacy of this council term will be one of failure in environmental protections.
