Thus, I stand in strong support of The CB72-2022 act which will provide many benefits toward the Asian American and Pacific Islander community, such as allowing more people such as myself to learn about their culture.

By establishing a Commission for Asian Americans and Pacific Islanders, we are able to increase education and spread awareness about AAPI culture. Spreading awareness about culture is important because it allows students and families of different ethnicities to be heard and have their backgrounds appreciated. This can allow people to feel more at home here in Howard County, and live in a place where their ideas and culture are represented.

Another important reason as to why a Commision for AAPI would be beneficial is to reduce hate crime and hate speech. In Maryland from 2019-2020 only, the percentage of hate crime based upon race and ethnicity increased by 30.7%. By setting up a commission, Howard County is able to promote culture and educate people about the community. When education and awareness are spread about a certain group of people, their culture becomes more known to others, and people are less fearful. Most racially motivated hate crimes are based upon fear or the unknown, and by spreading awareness, we are able to prevent or lessen the amount of hate crimes directed against people of AAPI origin.

A commission is able to successfully show representation in the AAPI community. Statistics from 2021 says that more than 20% of the population in Howard County is either of Asian or Pacific Islander origin. That is 20% of the population that is being represented by an AAPI Commision. This commision will, again, allow the voices of the AAPI people to be heard.

Ultimately, an Asian American Pacific Islander Commision will prove to be a great asset in spreading awareness about culture, representing the AAPI people, and reducing hate crime and hate speech. Thank you for your time, and I hope you strongly consider establishing the CB72-2022 act.

By chance, a beast finds Ren sleeping on the street and takes him under his wing. Thanks to the beasts who raised him, Ren is able to grow up into someone warm and full-hearted, with his once empty heart filled by his newfound community.

In stark contrast, another little boy, who we will call Ian, is also a human raised by a beast. However, Ian turns out a little differently from Ren. Without a community to support him, a visible hole in his heart grows until one day, he lashes out. Why did this happen? Why did Ian act so differently from Ren?

Ian never knew why he looked different from his father and the people around him confused why his brother had tusks and a long boar nose, and he didnt. He never felt like he fit in. Ian had a large hole in his heart, one carved out by a lack of community.
