I have no objections to the immediate projects that will be sent to the IAC. The long-term Capital Improvement Program is atrocious and unfair.


In case any members of the council have forgotten, there is no high school in the Elkridge Planning Region, which contains slightly less than 1/6 of the county population. I've attached a helpful diagram to illustrate this.

The CIP proposes building additions to Oakland Mills High School, and to Centennial High School. It is wrong to add capacity to parts of the county that already have high schools, while we have no high school in Elkridge. If we were to build HS 14 in Elkridge, it would meet the need of these two expansions, and result in a much more equitable distribution of high school capacity in the county.

The CIP also proposes a renovation to Oakland Mills High School that costs over \$130M, which is nearly as much as the cost of HS 14. I will not argue that there is a problem at Oakland Mills, in that the school is dilapidated and increasingly unhealthy for students. But the best solution to this problem is not to renovate OMHS, it is to build HS 14 to replace Oakland Mills.

I ask that the county government do a tradeoff analysis between OMHS and HS 14 to determine which alternative provides the best value to Howard County residents, using HCPSS Policy 6000 School Site Selection as guidance. If we are going to spend over \$130M, we have an obligation to ensure money is wisely spent for maximum benefit to the county as a whole.
