Dear Members of the Howard County Council,

I am writing on behalf of the Howard County Autism Society to express our support for Council Resolution (CR) 185. CR 185 support authorizing a Payment-in-Lieu-of-Taxes (PILOT) and a request for gap financing for Ranleagh Court affordable housing redevelopment project.

The PILOT and gap financing are necessary for Enterprise Community Homes Housing (ECHH) to proceed with the redevelopment of Ranleagh Court, which is one of five affordable Columbia properties that the ECHH is preserving and redeveloping. The PILOT, which the County has established as a tool specifically to enable affordable housing development in high-cost Howard County, and financing assistance are the only way that this project can proceed. Without the County's approval of CR 185, the ECHH will need to find approximately \$1.9M in additional funding.

The need for affordable housing opportunities is great, and even greater for those in the disability community. Ranleagh Court presents an opportunity to create new units that will allow the property to add workforce and market-rate housing units while preserving affordability for its existing low-income families. The redevelopment of this property will create an amenity-rice, ADA-accessible community. And all residents who live there today will continue to have an opportunity to return to their affordable residence in the new development should they wish.


# **Howard County Housing Affordability Coalition**

Howard County Council Public Hearing Testimony in Support of Continuing Resolution 185-2022 October 17, 2022

Good evening Council Chair Jones and Council members. I am Paul Revelle and am pleased to offer this testimony on behalf of the Howard County Housing Affordability Coalition. The Coalition supports Council approval of CR 185-2022 that will enable a Payment-in-Lieu-of-Taxes (PILOT) agreement and gap financing necessary to move forward the re-development of Enterprise Community Homes Housing's (ECHH) Ranleagh Court project.

This project will preserve 41 units of critically needed affordable County housing and add another 41 units, 29 of which will be deeply subsidized for low and very low income families. These new, modern, safe, mixed-income units will transform the 50-year old property into an ADA-accessible and amenity rich community that will exponentially increase the quality of the current substandard living conditions and in turn the quality of residents' lives. The redeveloped property will include larger units, in-unit washer/dryers, a diversity of outdoor spaces, an afterschool homework space, club room, and fitness and business centers.

Sixty (60) percent of area median income is \$62,700 for a family of 3. According to the Howard County 2022 Rental Survey, there are 11,670 available rental units for people earning \$60,000 or less, but there remains a shortage of 6,473 units for this same income group. This is the shortage for people already living in the County and we are providing only a relatively few new such homes each year. If Ranleagh Court is not preserved, it will add another 41 units to the housing gap and won't create the 29 new units, which will at least shorten the list a bit.



Source: 2022 Howard County Rental Survey It is our understanding that with the doubling of units in the newly comprised Ranlaegh Court community, the County will benefit financially from the PILOT as the property will generate as much as \$75,000 in additional local use and impact fees in the first year and those payments will increase as ECHH pays off its gap debts to the state and other lenders.

The Coalition strongly urges County Council members to vote in favor of CR 185. Vote to improve the living conditions of Ranleagh Court's current residents, preserve and create new County affordable housing units and keep advancing the redevelopment of the 300 affordable units across five properties to which ECHH has committed.
