Good evening. My name is Leslie Bauer and I am President of the Howard County Farm Bureau. I am here this evening on behalf of Farm Bureau to offer testimony in support of CB1-2023, that will allow for the automatic renewal of the property tax credit for properties held within the Agricultural Land Preservation Program.

As has been previously shared by the Department of Planning and Zoning, there are currently 282 agricultural preservation parcels within Howard County, either in the county ALPP or the state MALPF program, which are eligible for an annual credit to their property tax. This bill would assist farm owners by eliminating the requirement to reapply each year.

Howard County Farm Bureau sees several benefits to this bill:

- Overall, it will streamline the process and make it more efficient for both the County and for farm owners.
- It will reduce County staff time required to implement the credit.
 - While the County will still need to monitor properties for eligibility, they will no longer need to facilitate the annual application process.
 - \circ $\;$ The County will not need to send reminders out to farm owners annually.
 - The County will not need to field numerous questions from farm owners as they work to complete the annual form.
- It makes the process less burdensome for farm owners. Currently farm owners must reapply for the credit on an annual basis. Paperwork must usually be completed during the spring/early summer when many farm owners are busy doing field work. Finding time to do extra paperwork during this busy season can sometimes be a challenge. It also seems the paperwork changes from one year to the next, so it is not always as simple as copying the information that was submitted last year into a new form. It usually also involves trying to locate additional property information to complete an updated/revised form.
- There is a percentage of farm owners who miss out on the credit each year because they forget to reapply annually. CB1-2023 ensures that all farm owners receive the credit they are rightfully due. While this may create an increased cost to the county via property tax credits, I believe the consistency in being able to fully budget the annual credit cost, as well as the savings in staff time and resources will offset this cost.

Howard County Council,

We support CB-1-2023, a bill that provides for automatic renewal of the tax credit for Agricultural Land, if the property owner remains eligible. We understand that the bill provides a date, April 1 preceding the new tax year, as the date when a property owner shall initially apply; and that this provision relates to the tax credit for Agricultural Land.

This bill is a smart step for three reasons: it is consistent with all provisions regarding agricultural land, its consistent with the permanent assignment of land into preservation by the county and state, and it increases business efficiency for both the farmer and the county. Farmers in Howard County – from small to large- are busy with farming. Anything we collectively can do to keep us focused on growing food, feed and fiber is a step-in support of Agriculture.

Agriculture is the largest commercial industry in Maryland, employing some 350,000 people, including nearly 6,000 full-time farmers, and contributing some \$8.25 billion annually to the economy. Agriculture also remains the largest single land use in the State, with 2 million acres, or roughly 32 percent of total land area used for farming in 2021. While the majority of Maryland's farmland lies in the north central part of the State and the upper Eastern Shore, more than 20 urban farms thrive in Baltimore City. In 2021, some 12,400 Maryland farms averaged 161 acres each. According to the 2017 Census, 96% of farms are family owned
