Dear County Executive Ball and members of the County Council and Board of Education,

The Howard County Board of Education has proposed cutting the full-time Environmental Educator position at the Howard County Conservancy after 16 years of groundbreaking environmental education programs that serve the students and teachers of HCPSS. The signature programming developed through this partnership is absolutely essential to the county's ability to meet the state mandated environmental literacy graduation requirement. Ann Strozyk, the award winning educator in this role, has been with the school system for 23 years with 13 of those years onsite at the Conservancy delivering programs to all middle and high school students in the county.

Howard County is one of the few counties in Maryland that does not have a school system funded environmental education center. Most school systems spend millions of dollars every year to own and operate their own centers. The cost effective partnership with the Howard County Conservancy (a private nonprofit) not only provides 20,000 county students with hands-on environmental and outdoor education each year, but has also led to the development of award winning and groundbreaking programs. These programs include the 9 & 10th grade Watershed Report Card - about to celebrate its 10th anniversary - Climate Knowledge, a first of its kind 6th grade climate curriculum supported by a federal grant from NOAA, and the new and growing Youth Climate Institute. These programs not only provide critically important science education but also engage and empower future generations in environmental stewardship.

Environmental education is a necessity. Cutting this position will likely cost more in the long run than it saves. I understand that all of you have very difficult budget decisions to make, but please reconsider the proposed cuts and continue funding the environmental educator position at the Howard County Conservancy.
