I am available to discuss further, and I hope you had the chance to read my letter - as I am sure you have received many on this controversial and divided issue. I feel the letter I wrote summarizes a larger meaning behind passing a cease fire resolution. I and many citizens appreciate you do not feel it necessary to make a public statement and pass a resolution that would publicly divide the community further or make Jewish and Israeli individuals feel marginalized or isolated - as times have been challenging enough. Our college students, especially, are suffering severely - which is heartbreaking to witness. Thank you again.

Dear Councilwoman Walsh and Members of the Howard County Council,

As an attorney, mother, daughter, sister, and Jewish citizen in Maryland – I am disappointed and ashamed that you would propose and support in any way Resolution CR22-2024 - demanding for an immediate cease fire in Gaza. You point to the millions of innocent lives being jeopardized in Gaza. Yet Council President Liz Walsh's resolution fails to take into account its antisemitic intent and impact:

- 1) A cease fire will ONLY benefit Hamas AND proxy groups aimed at annihilating and eradicating all Jews and the state of Israel. This is not just conjecture – this is an absolute fact, which Hamas and every proxy group aiming to kill Israelis has made clear and unequivocal. Calls of “From the River to the Sea” symbolize the elimination of Israel from its west to east border – and that intent of Hamas and Iranian proxies is no secret.
- 2) Israel is fighting to survive – fighting to exist. Many point to the despicable, violent, inhumane and evil actions by Hamas on October 7, 2023, as proof that Hamas has killed Israeli innocent civilians as well. However – I would be remiss if I didn't clarify that there is much more at stake here. THERE IS MUCH MORE TO CONSIDER WHEN YOU REQUEST THE END OF THE KILLING OF INNOCENT CIVILIANS VIA A CEASEFIRE. Israel happens to be fortunate to have the Iron Dome – to protect its people from the missiles and rockets aimed every day at innocent Jewish civilians to kill them and destroy them. Without that self protection – do you really think the number of innocent civilians on the Israeli side would not exist? Palestinian violent proxy groups are aiming rockets and bombs at Israel all day and for many years – tens of thousands of Israelis have been killed deliberately by Hamas and Iranian proxy groups whose only goal is to destroy Israel and kill Israelis. Even today that is the only goal of Hamas, Houthis, Hezbollah and other proxy groups. Israel just has fewer innocent civilians dying because

the Iron Dome has intercepted the rockets aimed to kill Israelis. DO NOT BE FOOLED. There are innocent civilian lives at stake in both directions. But a cease fire CERTAINLY will not stop the firing from terror groups toward Israel because their sole goal, which they are very open and transparent about, is to destroy every ounce of Israel and everyone in it.

3) If there is a cease fire – Hamas and other proxy groups of Iran have made very clear that they will continue to fight to destroy Israel, regardless of when or where. So, what exactly are you attempting to accomplish with Resolution CR22-2024? Do you really expect a cease fire to solve the problem that Hamas started with violence in the first place? Hamas has made very clear, as have other groups, that they plan to continue until all violence, killings, stabbings, and bombings of Israelis until Israel and Jews are gone.

4) Who will be the parties to this “cease fire” being proposed? Is Hamas negotiating and agreeing to it? Are Houthis negotiating it? Is Hezbollah negotiating with Israel? Is Iran compromising and negotiating with Israel on behalf of its proxies? Because a cease fire must go both ways. So, who exactly will sit down at the table to negotiate and implement your cease fire? Or are you only requesting Israel to “cease fire?”

5) Israel is not the party killing and punishing innocent civilians in Gaza and the West Bank. In fact, it has been more than one decade since Israel withdrew from Gaza, as well as REMOVED EVERY ISRAELI LIVING ON GAZAN LAND, even though many Israelis were upset about the unilateral Israeli withdrawal from Gaza and the northern West Bank. In August 2005, under Prime Minister Ariel Sharon, Israel unilaterally evacuated all Israelis from the Gaza Strip and the northern West Bank. In fact, Palestinians in Gaza chose Hamas to become their governing leader – a leader that should have been responsible for creating infrastructure, schools, hospitals, educational systems, and a sound economic system. When Israel withdrew from Gaza, Israel even left behind in perfect operating condition its agricultural lands and properties to help Hamas create sustainable life off of the land and ways for people in Gaza to support themselves. Do you know what happened next? Hamas went and DESTROYED all of the agricultural property provided by Israel – Hamas didn’t care about its people and taking care of them. In fact, in response to Israel’s withdrawal, Gaza immediately launched missiles and rockets into Israel at innocent civilians for years – as far as to Tel Aviv.

6) There have been multiple efforts, even since October 7, 2023, to implement a cease fire and/or peace. EVERY SINGLE TIME Hamas has chosen not to enforce the cease fire agreement or to maintain peace – Israel has complied EVERY SINGLE TIME. Even more, historically – every single time Israel has come to the table and either agreed to provide land or independence to Palestinians – Palestinians have rejected all peaceful initiatives with Israel (even when prior agreements had been made). In November 1947, Mufti Hajj Amin Husseini refused to agree to the terms of the UN Partition Plan to establish two states (a Jewish and Arab state) – which by the way would have given Palestinians much more land. The Mufti made clear no Jews would be allowed in a Palestinian state and that he would not agree to any plans that included a Jewish state. Yasser Arafat succeeded the Mufti, refusing to accept the state of Israel. In fact, he mounted, via the PLO, terrorist attacks on Israel. When Anwar Sadat signed a peace treaty with Israel, Arafat and the PLO joined with other Arab League countries from 1977 to 1989 to punish Egypt and reject Egypt as a member. The Oslo Accords resulted in immediate suicide bombings all over the streets of Israel that targeted innocent civilians – all in an effort to destroy any existence of an Israeli state. In July 2000, at the Camp David Summit, Israel Prime

Minister Ehud Barak aimed to create a strong peace agreement with Arafat to introduce peace to all people in the Middle East by offering many concessions to Arafat in return for Arafat to recognize the state of Israel's right to exist. Despite numerous concessions, and the chance to truly create lasting peace, Arafat refused. Instead, the Palestinian Authority immediately declared a war of terror ("al-Aqsa Antifada") on Israel – once again attacking innocent civilians despite Israeli concessions and attempts to make peace. More than 1,100 Israelis were murdered. Next, in August 2005, Prime Minister Ariel Sharon of Israel aimed for peace again - unilaterally evacuating all of the Gaza Strip and the northern West Bank, including forcefully removing every Israeli person from that land, as a way to make peace. Israel left in place all of the agricultural land it had worked hard to create and preserve for the people of Gaza. In response, the Palestinians launched missiles and rockets at Israel from the Gaza Strip. In June 2007, Hamas took over the Gaza Strip (Israel was not in the Gaza Strip at all). Since then, there have been tens of thousands of nonstop missiles, bombs and rockets fired at Israel from Gaza. In 2008, Israeli Prime Minister Ehud Olmert offered PLO Chairman and PA President Mahmoud Abbas a huge peace proposal. Abbas wouldn't even listen – he rejected it immediately. Abbas either wanted the boundaries of Palestine from 1967 or nothing. One year ago, Abbas rejected the United States more recent proposal – which Abbas refused to even hear. ***In case it is not yet clear – the ultimate purpose of a cease fire would be to negotiate a peaceful solution in the Middle East and end the violence. But calls to destroy all of Israel and to eliminate its right to exist by Hamas and other proxy groups will never cease – that has been made clear through history.

7) The road to peace is easy. As soon as Hamas releases Israeli hostages – problem solved. Yet Hamas has made very clear that it is not going to happen. So, you are calling for a cease fire in the name of peace, but Hamas wants no part of peace.

8) No other Arab countries are taking in Palestinians. What about the dozens of other countries who could be helping in this situation? Israel is trying to defend itself and the lives of its citizens after a horrifically brutal attack, **while also** providing protection to innocent Palestinians. While Hamas is hiding underground, in tunnels and beneath holes created in civilian buildings – innocent Palestinians are being left aboveground with no protection. Hamas is the governing body in Gaza – yet where is Hamas to protect its people? Hamas doesn't want what is in the best interest of Gazans – Hamas is hurting its own. Perhaps your resolution should call for Hamas to stop ignoring the best interests of and stop hurting its own Palestinian innocent civilians, as well as innocent Israeli civilians!!!!

9) Israel drops millions of leaflets in Gaza to warn civilians to move out of harms way. What other nation does that? NONE. Israel makes public announcements to warn innocent civilians to move to places of safety. What other nation does that? NONE. Yet many innocent civilians have died in Palestine because Hamas refused to let them move despite warnings from Israel. So how would a call for a cease fire protect innocent civilians from Hamas – their own leader who is hurting them? Israel is trying to save them while still fighting for the lives and existence of Israelis.

THE SQUEAKY WHEEL SHOULDN'T ALWAYS WIN. Just because people are loudly calling for a cease fire - that doesn't make it right, moral, or even effective. In fact, the only impact will be more ammunition to kill, annihilate and destroy Israeli Jews and the 2 million Palestinians who live in Israel. That is the only effect your cease fire will have. You will be choosing essentially to dehumanize, eradicate, and kill Israelis (mostly Jews) – shame on

you. Your job is to reflect and represent the identities and well being of all of your constituents. This resolution is discriminatory, antisemitic, and ineffective. You can do better. You should do better.

I am Dr. Zoobia Chaudhry. I live in old Ellicott City in Council District 1, and I'm represented by Councilmember Liz Walsh. I am with the group Baltimore health care workers for Palestine. I would like you to support **CR22** Ceasefire resolution as we witness 100+ days of genocide in Gaza, it's crucial for us as concerned Maryland residents and taxpayers to take a stand. As a physician I have been esp. concerned about the attack on hospital and healthcare workers. I have been in touch with a few physicians on the ground in Gaza. Among them is Dr. Ebrahim Matar who works as an internist working in ICU and cardiology in the Gaza Hospital. He was living in the hospital for the last 4 months not only to help with patients but also to take refuge. He has not only been posting the dire situation in the hospital but also the emotional and physical toll this conflict has taken on him. Few weeks ago, his hospital was raided by Israeli forces and he was forced to leave. Now he is a refugee on the streets and still not able to see

his family because of the limited movement between north and south Gaza. He writes beautiful prose poetry and I will read a line from it:

I have seen all of this, oh God. I have seen people rushing to the hospital after the shelling, covered in blood, sand, and ashes. I have seen their faces, filled with shock, as if they had no idea what had just happened, as if they couldn't comprehend the magnitude of the event.

I sat with someone who talked to himself, wondering, 'All these wounded and martyrs were like us an hour ago. They were with us just a while ago in life. When will it be our turn?'"

I have wondered why this situation has such an impact on a lot of us. It may be because of what we identify to be. Part of our identity is who we are born as, and who we grow up to be. As a Muslim most of us here testifying have carried the pain of suffering of fellow Palestinians for as long as I was able to read or listen to the news. As a physician it hurts me to see my fellow health care worker suffer. Now part of my identity is being an American and the pain is compounded as the US is backing Israeli military operations with our taxpayer money. And if you do not identify as any of the above then I implore you to call on your humanity to further this resolution to call for a ceasefire and allow us to act like, well like human beings, and help us call an end to this senseless violence. Hello to Members of the Howard County Council:

I am writing to ask you to vote against the motion, CR22-2024, that calls for an imposed immediate unilateral ceasefire in the Hamas-Israel war. Such an imposed ceasefire would only benefit the terrorist organization Hamas.

It pains me greatly to see the suffering of the Gazan population. It is not what Israel wants. But **Hamas** has **created** this situation. They have long openly declared their goal to rid Israel of Jews, in fact to go after Jews everywhere. One example was on October 13, less than a week after the original slaughter in Israel, when Hamas leaders called for an assault on Jews all over the world.

When Hamas perpetrated the massacre on Israeli men, women, children and babies on October 7th, they demonstrated the reality of their stated goals in the most inhumanly grotesque way. They multiplied the misery they inflicted by kidnapping hundreds including women, old people, children and infants. Since that October day, Hamas has made it explicitly clear that they will do this type of horrific attack **again** and **again**.

Faced with this reality, Israel had a choice. They could lie down and surrender with the sure knowledge that their babies, children and adults would again and again be savaged. Or Israel could go after the terrorist organization that is a threat not only Israel but to the United States and other countries around the world. Hamas needs to be destroyed for Israel's safety, indeed for their very continued existence, and for the safety of other nations. Who has the courage to tackle this near impossible task? Only Israel.

A friend recently asked me **why** did Hamas attack in such a devastating way? The only explanation that made sense was that Hamas wanted to provoke a huge military response from Israel.

Why would Hamas want to basically force Israel to go into Gaza to root out Hamas? Because Hamas knew that they had **created** the scenario in which they could not be reached and eliminated without many, many **of their own people** being killed. Israel has an ethical Code of Military Conduct guiding them. Such an ethical code has been immensely tested because Hamas has spent years building an infrastructure that uses their civilians and their people's homes, hospitals, schools and mosques as shields behind which Hamas could hide and fight, attack, and fight again. It was their goal to cause suffering of their own people so they can parade that suffering in front of the world. They had been setting the stage for this tragedy for years.

Under other "normal" circumstances of war, a call for a ceasefire sounds like a caring idea. But in this case it is a call to control and stop only one side. The ceasefire called for would only force Israel into letting Hamas continue to survive and strike again and again. It would leave the hostages in dire abandonment, and it would force Israel to back off from completing the mission of destroying Hamas.

Those who participate in war, tell us that “war is hell.” Nothing can change that. Not even for a country such as Israel who has tried to minimize the casualties as much as it can. Hamas must be destroyed. The agonizing job has been handed to the Israelis.

If the war comes to an end because of an imposed ceasefire, all of Hamas’ evil intents would be licensed. Dear Howard County Council Members:

It is with heavy hearts that we write this letter following the Council's vote Monday night to reject resolution CR 22-2024. Although we believe the council made the correct decision, we are troubled because of the negative impact that the resolution itself had on our community. For many years, Jews and Muslims lived together in Howard County without incident. CR 22-2024 caused tremendous anxiety to both Jews and Muslims alike. No matter which way you as Council Members voted, one group was going to feel disenfranchised, defeated and angry.

We thank the Council members who voted "No," and in particular, Chair Jung and Council Member Jones, for their well-reasoned explanations of their votes. We are hopeful that a county-established Interfaith Advisory Council will have the collective wisdom, in whatever it chooses to accomplish, to do so, in Chair Jung's words, considering "shared values of civility and inclusion."

While the result of the vote was positive and fully justified, we must call attention to Council Member Walsh's hypocrisy and cynicism. It was unfathomable to listen to her claim a lack of understanding of how the resolution could have been viewed as controversial, and that, in her words Monday night, "this bill is not divisive." She must have been aware of the chants of "from the river to the sea" or "genocide supporters" from backers of the bill just outside the George Howard building Monday night. She is certainly aware of the social media vitriol being spewed in the weeks leading to the vote. No matter how she feels about the situation in the Middle East, it is disingenuous and cowardly to claim ignorance of the controversy.

But in the initial hope that it had been ignorance alone, there were attempts to educate. Indeed, following an early-November meeting with leaders from the Jewish Federation of Howard County, Council Member Walsh admitted in a Facebook post on her own page that "By my own language...I have caused many of you pain and fear and disappointment...I have added to our own suffering right here at home." She started that post by calling it an "apology." At the time, we were willing to consider it sincere. Now, we realize it was a cynical attempt to pacify.

Council Member Walsh also demonstrated her true colors by not acceding to multiple requests, including from Jewish clergy, to amend her resolution to even out its message. For example, an acknowledgement of Hamas as a terrorist organization, or even a simple recognition that a ceasefire must be accompanied by return of all hostages held by Hamas and other Islamic jihadist groups, would have gone a long way to balancing the controversial issues in the resolution, thereby tamping down the associated emotions in our community. In the end, her rejection of such entreaties, when juxtaposed with her statement Monday night that "this should be about human lives and the sanctity of all human lives," demonstrates the ultimate hypocrisy. Howard County, which prides itself on civility, inclusion and mutual understanding, deserves better quality leadership than the extreme, uncivil actions and words of Council Member Walsh. We hope that Council Member Walsh can now see how dangerous her words are and that she is hurting all of Howard County. Stated somewhat differently, Council Member Walsh has brought out the worst in us – which should weigh heavily on her given her supposed concern for humanity.

Finally, consistent with Chair Jung's statement Monday night, we additionally respectfully request that she consider the matter of a Council resolution on this topic closed permanently, and that she reject any future attempts to resubmit such a resolution for Council vote. Given the rancor and division that CR 22-2024 caused, any future similar resolutions would serve only one purpose: to exacerbate those conditions in the Howard County community. Certainly, that cannot be what our elected officials hope to achieve.

Hopefully, we can now start the healing process that our community needs and deserves.
