Hello,

I am writing to you as a Howard County resident and employee whom is concerned about the lack of empathy shown for human life.

I live in Ellicott City right on the border of Columbia. Proudly serving my community, proudly working for this county, and being a volunteer firefighter/EMT within the state, I deeply regard Howard County as my "home".

But as of late, it has become difficult to say that I feel welcomed in my own home.

The war all Gaza is an absolute atrocity, where there has been constant disregard for the innocent lives of many men, women, and especially children leading to several thousands of murders of the Palestinian people.

And this has lead to a growing culture here in our own county and country where it is becoming acceptable to side with moral corruption and hatred of a group of people.

Muslims are facing an enormous amount of hate, Islamophobia has significantly increased in the County and within our schools, and I myself have felt alienated while working for the county.

Right after October 7th, our beloved County Executive, Dr. Calvin Ball, strongly condemned the acts of Hamas. And no Muslim advocates for violence or hatred of others. But there was not a strong condemnation of the Israeli government (which clearly operates against its own population of Jews and against the teachings of Judaism) and its relentless slaughter of innocent civilians in Palestine. This left a void that other residents within the county filled with hatred and segregation towards me. All this despite me continuing to support and serve the country community wholeheartedly within my role here in the County.

And yes, County Administration later came back to state that Islamophobia, Antisemitism (which the root word means hatred against Jews AND Arabs), and xenophobia are not tolerated. And yes, County Administration loosely tried to extend their hand at meeting with leaders of the Muslim community (my community), which served more lip service than actually fielding concern. But I have not seen any concrete action on behalf of the County to assure me that I am welcome in my own home (here in the county). And this has set the tone that harassment and even killing of Muslims is acceptable.

As my child, whom is currently within a pre-K program in Howard County Public Schools, grows older, I do not know if I can support his continuation of attending a public system that disenfranchises him and doesn't guarantee his safety based on his religious beliefs.

By supporting and adopting resolution CR22-2024, the County is sending a message to it's residents and employees, to the state, and to our dear country of the United States of America (along with the entire world) that hate will not be tolerated for anyone, that it is unacceptable and illegal to kill and take the lives of the innocent (which as of this date of writing has been mainly of women and children in Gaza by the Israeli government [which, again, does NOT represent the Jewish people]), and that it is unacceptable and illegal to take away the basic humans rights for individuals (whom in Gaza have lost the access to clean water and food because of the Israeli government).

This is why I call Howard County home and hopefully wish to continue to do so. Because the County has stood on the principles outlined above - that religious freedom and respect for all is required to live in the county, that there should be no hatred within the county, that it is NOT acceptable to devalue one life over another.

Yes, adopting a ceasefire is highly symbolic as policies at the federal level and global level have more significant impact.

However, standing, even symbolically and for humanitarian causes, on the morally correct side signifies and emphasizes the County's stance that every human deserves to live, grow, and thrive in a safe, respectable, and humane environment.

And never can stating that a ceasefire is necessary in Gaza state that one is antisemitic - based on the very definition, one is stating that the lives of innocent men, women, and children, particularly those currently in Gaza - of Arabs (which again are ALSO Semitic people) - irregardless of ethnicity, religion, heritage, lineage, or socioeconomic background are sacred and to be protected.

I ask the Council, do you stand with the principles of Howard County? And can you stand on the side of humanity?

If so, no matter what a person says, standing on the morally correct position is vital regardless of how difficult the process may be.

If you cannot support such a resolution, then no matter what your excuse, you have made it clear that Howard County does not value the lives of Muslims.

I thank you dearly for giving me this opportunity to express my concerns. And I will continue to serve happily in my role in Howard County government, where I help ALL to live, grow, and thrive with dignity and civility.

Hello,

My name is Amal Sinnokrot. I am a Palestinian American and have lived in Howard county since 2018. I was born and raised in Montgomery County, Md. I always felt like I didn't matter in their public school system. My faith and background was never mentioned as we learned about Christmas, Hanukkah and Kwanza. I remember when Ramadan actually fell in December with the other major holidays but it was just brushed away. I bring this up because I would never move back there and have my children go through their school system. I faced so much discrimination living there. I have been called a terrorist countless time and even had someone try to run me over in front of my house.

Since moving to Howard County, I haven't faced any discrimination. I feel very welcome here and part of the community. I feel comfortable raising children here. I remember seeing all the "Choose Civility" bumper stickers when I first moved. That really stood out to me.

Despite feeling comfortable here, I am at a loss as to why Howard County hasn't passed a resolution for a ceasefire in Gaza. The deaths of over 30,000 people (70% being women and children) is affecting so many of your residents. How can this be ignored? Especially when you passed a unanimous resolution in solidarity with the government of Ukraine.

Israel is a colonizer state, they have ignored so many international laws. This isn't the first time Gaza has been bombed, although the worst. The West Bank is broken into pieces by settler settlements. Ukraine was the victim in the conflict with Russia and deserved to have a resolution and so do the Palestinians. If you took a moment to do your own research instead of listening to the propaganda from the Israeli government, you would see this. If you won't listen to Palestinians firsthand accounts such as eye on Palestine, please look up Jesse Mechanic and Daniel Mate.

I have gone through so many traumatic moments when visiting Palestine. I remember being stripped searched as a child, guns pointed at me. I remember being woken up at 3 am by tanks as they announced they will be kicking everyone out of their homes to ransack everything. I have cousins and uncles who have been put in jail without a trial for no reason. My own grandmother was locked in her house and threatened to be blown up. These are just a few examples of the constant humiliation Palestinians go through on a daily basis.

I am a single issue voter when it comes to Palestine and I will vote for only those who support a resolution. Almost 50 cities in the US have called for a ceasefire including huge cities like Chicago. I don't understand why a place that has bumper stickers that say "choose civility" wouldn't be one of those that call for a ceasefire.

**Please support the resolution for a ceasefire, this is affecting so many Howard county residents including your students. Please choose civility.**

Dear Deb,

I previously wrote to all council members about my concerns with CR22-2024 but I wanted to write to you separately as my district council member. The current language of CR22 does not call for the release of hostages and does not call for a cessation of violence on both sides of the conflict in the middle east. As a Jewish person, I have been so afraid to show my Judaism since Oct. 7. I don't wear Judaica jewelry anymore, I don't attend rallies for fear of violence, I don't allow my children to talk openly about their Judaism with certain peer groups and I get nervous when people come to my home (delivery people, contractors, etc) and can see the mezuzah on my door frame. As I'm sure you are well aware, Jews represent 2% of the U.S. population but are the victims of 50% of hate crimes in this country. Isn't that astounding? I certainly think it is. And those crimes have gone up tremendously since Oct. 7.

I don't know why Liz Walsh has taken to demonizing Jewish people in her community. I follow her social media and I just never expected the rhetoric she has put forth to come from her. It's shocking.

This legislation needs to be voted down and I am writing today to ask you to take a stand against Liz Walsh and antisemitism in this county and vote CR22 down.

Could I support this legislation in the future? Absolutely. But it must include a call for the unconditional release of all hostages and a permanent cessation of violence on all sides.

Ceasefires have been enacted before between Israel and Gaza. And 100% of the time those ceasefires have been broken by Gaza. Israel wants peace. Jews want peace. The real call for action needs to include a commitment by the Palestinians towards long lasting peace and a recognition of Israel's right to exist. The Palestinians have never agreed to the latter.

Please do the right thing and vote CR22 down.

I am writing to express my dismay, disappointment, and disbelief that the Howard County Council would even consider such a flawed, irresponsible, narrow minded, morally simplistic and divisive resolution. It does not even mention the calculated atrocities committed by Hamas on 10/7/24. Their long-standing genocidal aim is to kill all Jews and reject any compromise or negotiation toward peace with Israel. Hamas is not now and never has been interested in a two-state solution, only a Palestinian one and the complete annihilation of Israel and all Jews (see 1988 Hamas charter and article 7 and 13 below with link to full text below). I doubt the council is an expert on history, warfare, or international law yet it simplistically sites the "targeting" of civilians as a war crime, without describing that Hamas uses its civilians as human shields. Hamas has used billions in international aid, to build a system of underground concrete tunnels larger than London's underground - under hospitals, mosques, schools and in densely populated areas. It is Hamas that is targeted by Israel. Genocide is abhorrent and is obviously not the intent of the Israeli government as they could have achieved that in days, if that was their intent. The Israeli response to target Hamas, with the resultant immense suffering and unavoidable loss of life, was a known given to Hamas when they planned the 10/7/24 attack. They are responsible for the loss of life in Gaza and could end it easily with surrender and release of the hostages. Our Rabbi, Craig Axler, is a spiritually uplifting and wise person with a loving heart for all people of all religions so I have included his thoughts below:

"To the members of the Howard County Council and County Executive Calvin Ball, I am writing to you today to express my deep concern and strong opposition to the Resolution (CR 22-2024) introduced by Councilmember Walsh which I believe is going to be first considered at the County Council meeting on February 5th.

I will acknowledge that I have had the opportunity to speak with Councilmember Walsh today to express my concerns today, and I believe we had a productive and civil discussion, but I would like to be able to be on the record with the full council for the reasons of my strong opposition. I also want to note that I express this concern and opposition as an individual, but also as the Senior Rabbi of Temple Isaiah, on behalf of the 700 family member units of this congregation, the vast majority of which are Howard County Residents; a congregation that has been a proud member of the interfaith community of Howard County for more than fifty years and which treasures its associations with our elected officials and the role that we are able to serve as a partner faith organization towards the betterment of our greater community. Finally, I take up this opposition as an individual who was recently honored to be appointed by County Executive Ball to the new Interfaith Council for Howard County – and I believe it is my responsibility to be among those who represent the Jewish community in that important bridge between the faith communities and civil society.

Finally, I will share that I base this opposition to CR 22-2024 also in 40 years of Israel engagement that has been focused on peace-building, on the strengthening of Arab-Israeli and Muslim-Jewish relations, and as someone who has worked tirelessly as an advocate of a Two State Solution throughout the entirety of that time. I also spent much of the first week of January returning once again to Israel, but this time on a solidarity mission to witness the effects of the Hamas terror attacks of October 7th, the ongoing devastation, grief, anxiety and suffering caused by the attacks that Hamas initiated on that day and the resultant war that has raged since then. What I saw during this visit will likely haunt me throughout my life, and I continue to process it and to share about the carnage, the devastation and the impact of that single deadliest day in the history of the State of Israel. I shared in great detail with Councilmember Walsh and am willing to make time to talk to any of you individually about the things that I witnessed and the first-hand testimony that I received.

The crux of my opposition to CR 22-2024 is that the resolution calls for a ceasefire, but does not explicitly call for the release of all of the 130+ hostages (or remains of hostages) still being held in Gaza by Hamas, Palestinian Islamic Jihad and other associated terror groups. The ceasefire resolution also appears to be a one-sided ceasefire, which pins the blame for the devastating loss of innocent civilian life in Gaza and Israel solely on the actions of the State of Israel and the Israel Defense Forces. Further, the resolution makes no mention of the brutal events of the unprovoked attacks of October 7th, which claimed the lives of more than 1200 civilians – brutally murdered in their homes, in the fields, at a dance festival, on the road and in any place where the terrorists found them. Again, the details of these attacks have been chronicled by those who witnessed and survived, but also by the explicit body-cam images captured and disseminated by the Hamas terrorists. As someone who has seen some of the most graphic imagery that was deliberately and joyfully distributed by Hamas, I can tell you that when the deniers will come to say that these things did not take place, the very perpetrators of these actions will have provided the incontrovertible evidence.

I also shared with Councilmember Walsh my astonishment that she has referenced several leaders of the Democratic Party who have similarly called for ceasefire's in their resolutions. They specifically called for the immediate release of all 130-plus hostages. The decision to consciously omit this from the resolution submitted to the Howard County Council can be seen as nothing else than a deliberate decision to erase the existence and legitimacy of the lives of these hostages – civilians who range in age from one year old to mid-80s. This decision alone should make anyone who cares for all of humanity carefully consider what a vote for this resolution would say about their values, commitments and ethics.

I say all of this with the simultaneous deep concern for the untold amount of suffering being experienced by the civilian population of Gaza. The civilian casualty numbers are beyond comprehension, and I call on the Israel Defense Forces to do everything possible to avoid any and every civilian casualty, even as they legitimately proceed in this war against the Hamas terrorists who have repeatedly vowed to conduct attacks worse than October 7th again and again – witness repeated public statements by Hamas officials both in the Gaza strip and speaking from their relative safety of Qatar. I also pointed out to Councilmember Walsh that I believe any Ceasefire resolution must also acknowledge the deliberate and calculated tactics and actions of Hamas that make them culpable for substantial percentages of the civilian deaths that have occurred throughout the prosecution of Israel's war on Hamas. The employment of human shields, the placement of weapons depots, rocket launching stations and command centers deliberately inside of dense civilian areas, inside and beneath hospitals, schools, UNHCR facilities and other places which are sure to result in civilian loss of life have been a hallmark of Hamas' tactics for years, but in this specific war have resulted in the most devastating of consequences. My heart breaks for the civilian population of Gaza who are unsupportive of Hamas. I pray for their liberation from this brutal terror group.

Finally, I will share that in conversations with many members of Temple Isaiah, a constant refrain that I hear is "why was/is this the work of the Howard County Council?" I happen to agree with this sentiment. As someone who (like you) cares deeply for the strength and success of our community, I know that the County Council has real work to do in assuring that justice, equity, right and blessing are the shared bounty of all in our community. Advancing this legislation does nothing to forward that mission – and I will say it has already done great harm towards the relationships within our community, causing deeper divisions between people who genuinely care for one another, and who may have deeply divergent assessments of the Israel-Hamas war. No good comes from the introduction of this deeply flawed resolution.

I urge all members with my full voice to reject this resolution and to work towards actions that will help heal the divisions that this resolution has already caused. I pledge my support and assistance in doing just that. Submitted with great respect.

## **Hamas Charter of 1988 (two articles-link to full text below)**

### **Article Seven:**

As a result of the fact that those Moslems who adhere to the ways of the Islamic Resistance Movement spread all over the world, rally support for it and its stands, strive towards enhancing its struggle, the Movement is a universal one. It is well-equipped for that because of the clarity of its ideology, the nobility of its aim and the loftiness of its objectives.

On this basis, the Movement should be viewed and evaluated, and its role be recognised. He who denies its right, evades supporting it and turns a blind eye to facts, whether intentionally or unintentionally, would awaken to see that events have overtaken him and with no logic to justify his attitude. One should certainly learn from past examples. The injustice of next-of-kin is harder to bear than the smite of the Indian sword.

"We have also sent down unto thee the book of the Koran with truth, confirming that scripture which was revealed before it; and preserving the same safe from corruption. Judge therefore between them according to that which Allah hath revealed; and follow not their desires, by swerving from the truth which hath come unto thee. Unto every of you have we given a law, and an open path; and if Allah had pleased, he had surely made you one people; but he hath thought it fit to give you different laws, that he might try you in that which he hath given you respectively. Therefore strive to excel each other in good works; unto Allah shall ye all return, and then will he declare unto you that concerning which ye have disagreed." (The Table, verse 48).

The Islamic Resistance Movement is one of the links in the chain of the struggle against the Zionist invaders. It goes back to 1939, to the emergence of the martyr Izz al-Din al Kissam and his brethren the fighters, members of Moslem Brotherhood. It goes on to reach out and become one with another chain that includes the struggle of the Palestinians and Moslem Brotherhood in the 1948 war and the Jihad operations of the Moslem Brotherhood in 1968 and after.

With the news last night that Howard County Council Member Liz Walsh's Ceasefire resolution to the Howard County council will be fast-tracked to a vote on Monday rather than go through the public comment that was scheduled for February 20th, I wanted to express my deep concern and strong opposition to the Resolution (CR 22-2024) introduced by Councilmember Walsh.

I will acknowledge that I have had the opportunity to speak with Councilmember Walsh today to express my concerns today, and I believe we had a productive and civil discussion, but I would like to be able to be on the record with the full council for the reasons of my strong opposition. I also want to note that I express this concern and opposition as an individual, but also as the Senior Rabbi of Temple Isaiah, on behalf of the 700 family member units of this congregation, the vast majority of which are Howard County Residents; a congregation that has been a proud member of the interfaith community of Howard County for more than fifty years and which treasures its associations with our elected officials and the role that we are able to serve as a partner faith organization towards the betterment of our greater community. Finally, I take up this opposition as an individual who was recently honored to be appointed by County Executive Ball to the new Interfaith Council for Howard County – and I believe it is my responsibility to be among those who represent the Jewish community in that important bridge between the faith communities and civil society.

The crux of my opposition to CR 22-2024 is that the resolution calls for a ceasefire, but does not explicitly call for the release of all of the 130+ hostages (or remains of hostages) still being held in Gaza by Hamas, Palestinian Islamic Jihad and other associated terror groups. The ceasefire resolution also appears to be a one-sided ceasefire, which pins the blame for the devastating loss of innocent civilian life in Gaza and Israel solely on the actions of the State of Israel and the Israel Defense Forces. Further, the resolution makes no mention of the brutal events of the unprovoked attacks of October 7th, which claimed the lives of more than 1200 civilians – brutally murdered in their homes, in the fields, at a dance festival, on the road and in any place where the terrorists found them. Again, the details of these attacks have been chronicled by those who witnessed and survived, but also by the explicit body-cam images captured and disseminated by the Hamas terrorists. As someone who has seen some of the most graphic imagery that was deliberately and joyfully distributed by Hamas, I can tell you that when the deniers will come to say that these things did not take place, the very perpetrators of these actions will have provided the incontrovertible evidence.

If the International Court of Justice itself recently called for the return of all hostages and did not ultimately call for a ceasefire, why would our county council? It literally does not make logical sense.

Councilmember Walsh referenced several leaders of the Democratic Party who have similarly called for ceasefire's in their resolutions. This decision alone should make anyone who cares for all of humanity carefully consider what a vote for this resolution would say about their values, commitments and ethics.

I say all of this with the simultaneous deep concern for the untold amount of suffering being experienced by the civilian population of Gaza. The civilian casualty numbers are beyond comprehension, and I call on the Israel Defense Forces to



do everything possible to avoid any and every civilian casualty, even as they legitimately proceed in this war against the Hamas terrorists who have repeatedly vowed to conduct attacks worse than October 7th again and again – witness repeated public statements by Hamas officials both in the Gaza strip and speaking from their relative safety of Qatar.

Any Ceasefire resolution must also acknowledge the deliberate and calculated tactics and actions of Hamas that make them culpable for substantial percentages of the civilian deaths that have occurred throughout the prosecution of Israel's war on Hamas. I wanted to explain to you how it felt for me to hear of CR22. Let me start by saying it, especially broke my heart, because I had previously felt seen and heard and cared for in Howard County. I considered myself on the progressive side. This resolution and related posts shook me to the core. Only a few weeks after the barbaric attack I was already reading posts from a Howard county official saying that Israel was committing a genocide without any outrage at the Hamas attack, a attack which actually was attempted genocide! I was incredulous! In fact, in the United States war on terror after 9/11, 12 civilians were killed for every one terrorist. In Israel's war against the terrorist group, Hamas, it is less than 2.5 civilians for every terrorists kill. Fighting a war against terrorists is a whole different ball game. Israel has gone above and beyond to minimize civilian casualties at their own expense.

I am Jewish. My mom was born the same year as Anne Frank. She was born in Czechoslovakia. We saw her preschool class in Prague at a museum exhibit in DC. I remember my mother saying that she was the only child still alive from her preschool class. The United States wasn't letting Jews in but thankfully my grandfather was able to get a graduate degree in Canada and bring his family to safety. We lost a lot of family in the Holocaust. The other side of my family escaped from Egypt when Egypt kicked them out because they were Jewish. All over the Middle East they kicked out anyone who was Jewish and took all their property. They came to this country with nothing selling chickens in the trains. I went to Eastern Europe this past year and saw for myself concentration camps, and also went to the holocaust museum a few weeks ago. This is all to say that I know I am especially sensitive to the rhetoric that is out there. And I am well aware how lies and propaganda begin to create a society that feels like killing Jews is OK, or at the very least, wants them to roll over and let themselves be killed by Hamas.

I also was old enough during 9/11 to understand terrorism. All of a sudden, the world didn't feel like a good place. My older daughter was born a month after 9/11. I was so scared for the world that she was born into... I was questioning my decision to bring a child into this world...and am even more scared now! I think if you weren't old enough to really feel September 11th, it might be a lot easier to believe that it was just a lie or wasn't so scary. It is hard for good people to comprehend and accept true evil.

Hamas is Isis to me. I can't imagine living so close to terrorists that vowed to commit these attacks again, and again, and again. Hamas is the government in Gaza. Their educational materials tell them to hate Jews at an early age. They sacrifice their kids because it makes them look good in the eyes of the progressive west. They actually have suicide vests for little kids. Their math problems at a very early age count number of dead Jews. The families actually put their kids in danger way so that they can be martyrs and so it will look bad for Israel. Hamas complains that Israelis care about life, but the Hamas ideology there is that it is better to be a martyr and die killing Jews and other infidels than to live.

I know there are a lot of lies and propaganda out there. None of the colonial, apartheid accusations are true of Israel. Jewish people have lived in Israel long before any Palestinians did. So much of the land in Israel is even

documented in the Old Testament. Most Israelis are people who were kicked out of the Middle East such as my family. 20% of Israelis are Arabs. Israeli Arabs also support this war. Israeli Arabs are doctors, lawyers, qualify for assistance, and even have a political party and are represented in the Israeli government. Israel has been out of Gaza since 2005. They are not occupied by Israel. Maybe if they were, they would've been prepared for this attack and known about the miles and miles of tunnels underground. There are also not readily allowed into Israel, because they have the history of killing Israelis. Suicide bombers are the norm. Egypt is just as afraid of letting Gaza civilians in to their country. If you think Israel occupies Gaza, then Egypt definitely does as well. That is why no other country wanted to let the Gaza civilians in to keep them safe. It would endanger their countries as well. Hamas is dangerous to all. There is no land issue. Palestinians just don't want Israel to exist! Before Netanyahu, the land was offered to them many times.

I believe that rape is never resistance. It especially broke my heart because Hamas gang raped girls that are my daughter's' ages...kids who were just hanging out at a music festival. I have to say I've been crying every day since October 7. I've been astounded at the world. I am fearful for my life and I'm beginning to realize that anti-Semitism is very real and is rampant in Howard County. I just can't believe the lies that people are willing to believe and the anti-Semitism that is inherent in them that allows them to believe the lies and propaganda.

At the Howard County vigil after October 7, a Muslim group of Howard county was absolutely wonderful in helping out with the vigil for the Jewish Community. I naively had hope that maybe we could all work together to get rid of Hamas. I know we are not all reading the same articles, or watching the same news programs. And I do believe TikTok is responsible for so much of the misinformation. And I do believe that a lot of the information coming out of the terrorist group Hamas is not to be trusted. As a society, we all need to work together to find the truth. I believe the more you look into the conflict, the more you will agree that Hamas should no longer be in power and Israel is fighting a justified war. CR 22 does not build bridges, but rips our community apart. I believe we all have the same enemy - terrorism and fake news! Islamophobia is a real thing and it is not fair that peaceful loving Muslims are judged because of these terrorists.

Is it absolutely horrible that any innocent Gazan civilian died? Absolutely. I hate it. Especially the innocent children. Israel accepted Egypt's proposal to ceasefire and end the war. Hamas didn't. Hamas broke the cease-fire of October 6th. Hamas also broke the last cease-fire because it did not want to return the young women hostages that were being raped. It is very difficult to bargain with terrorists that want you dead. I absolutely want a cease-fire too... but I also want the poor innocent Israeli hostages returned and I do not want anyone to have to suffer again at the hands of Hamas. This includes Gaza civilians. Why is this former student important to my story? He and I are close friends and have stayed in touch. He cares deeply, and passionately for both Palestinians and Israelis. He understands, like I do, that there is suffering across the board. We agree that a two-state solution is needed. We agree that Hamas is a terrorist organization that only seeks to destroy the state of Israel and kill ALL Jewish people. We have been residents of Howard County for more than 50 years and have been close observers and contributors to Council issues over that period. We both have been involved in a variety of community organizations and activities designed to assist those in need and Ms. Greenfeld retired after many years of serving students at the Community College.

The above-noted proposed Council resolution represents a major departure for the Council in terms of expressing a particular point of view on both foreign policy and international relations. For this reason and others we are opposed to this Resolution. The Resolution fails to mention the hostages being held by Hamas and the need to release all hostages. There is no acknowledgement in the Resolution of the continuing firing of missiles from Gaza into Israeli cities, which has been going on for many years predating 10/7. There is no recognition of Iran's role in fueling this war with armaments and logistical support for Hamas acts of terrorism against Israeli citizens. There is no fact statement on the source for the numbers of deceased Gazans, most of whom are likely to have been Hamas terrorists or civilians placed in jeopardy by Hamas.

Israel has a population of about 10 million. About 25% of the population is composed of Muslims, Christians, and Druze. Among the Muslim population, 12% are Bedouin who are strong supporters of Israel's response to Hamas terrorism and serve in the Israeli military. Among Arab citizens of Israel, more than 70%, in the most recent poll following the October 7 terrorist attack, said they identify as Israelis, the highest such finding ever reported (Reuters, November 10, 2023).

The Resolution essentially legitimizes an organization identified by the U.S. as a foreign terrorist organization since 1997(U.S. Department of State, Designated Foreign Terrorist Organizations). With many diverse views on the Resolution in Howard County, we think it inappropriate to consider before extensive research, analysis, historical context, opinion, and appropriateness for a resolution are incorporated into any proposal on this subject.

Greetings. Like many in the county, I have been alerted to Councilmember Walsh's proposed resolution calling on Israel to instigate an immediate and unconditional cease-fire in Gaza, CR22-2024, which will be coming to a vote on Monday night, February 5th.

I am confused that the resolution was put forth, and I am shocked that it is coming to a vote this Monday night!

Thank you for considering my views on the Resolution No. 22-2024, now pending for consideration by Howard County's Council. I urge you not to pass the resolution.

I. Resolution 22-2024 is incomplete and thus inaccurate as to positions held by federal officials; it fails to demand hostage's release and elimination of Hamas. 22-2024 makes an assertion that "Congressmen Mfume and Raskin, and Senator Van Hollen have called for an immediate ceasefire." But, that is untrue in context. Here is what else they said, and which Resolution 22-2024 fails to say:

Note, 22-2024 does not call for return of the hostages or the removal of the Hamas terrorists from operational control of Gaza ...

Van Hollen's office sent a statement to 11 News, saying: "Like many across our state, I was horrified by Hamas' despicable attacks and kidnappings that took place Oct. 7. Mfume, <https://twitter.com/RepKweisiMfume/status/1722370744397492557>: "Like many, I am not a cosponsor of H.Res. 786 because it fails to call out by name the Hamas terrorist organization for the death and destruction they initiated on October 7." 22-2024 also does not call out Hamas for its atrocities, does not call for dismantling of Hamas, and does not call for release of hostages. Please note, 3 out of 4 first paragraphs of 22-2024 are exact copies of HR 786. Significantly, the US House buried HR786, by sending it to a Committee, nearly four months ago. We expect similar fate for the copycat Resolution 22-2024.

## II Actions by the US and Israel are justified.

There are good reasons why U.S. is supportive of Israel's fight for its existence. U.S. and Israel have been close allies since Israel's inception. US sees in Israel a democratic nation, pulling itself by its bootstraps, despite relentless attack. Arab Palestinians murdered Jews in repeated pogroms, since at least 1920. Leading Palestinian Arabs had supported the Nazis, seeing an opportunity to cleanse Arab lands of Jews. This continues today, and Hamas' actions are a leading example. US actions re Gaza war are proper, moral and in US' self-interest.

Hamas is acting with bestiality. On October 7, 2023, Israeli and civilians of other countries, including USA citizens, were raped, kidnapped and killed. Hamas killed and kidnapped babies and old people. Hamas planned and indulged in bestiality of inhumane proportions, committing atrocities at close range, person to person. Hamas embedded itself in Gaza's civilian infrastructure and continues to use both Israeli hostages and Palestinian civilians as a shield. Hamas has fired rockets into Israel before and after October 7. It largely is not targeting military assets, but targeting to kill Jews. My 5 years old granddaughter had to dive into ditches 3 times, to escape missile attacks. Hamas showed its determination to eliminate Israel and to kill Jews since year 2005, and it asserts it will continue to see the killing of Jews as its mission.

Israel is fighting back. It must do so, it must protect itself. War is always horrendous and there are always unintended casualties. However, there is no evidence of planned targeting of civilians by the Israel Defense Forces. Hamas is sheltering in tunnels. Taking these tunnels out causes destruction. But there are no better choices, if Hamas is to go.

Resolution No. 22-2024 would do harm if approved. Resolution 22-2024 is not asking anyone with influence to release the Israeli and Western hostages. Why? A cease-fire would allow Hamas to recover and resume its bullying rule over Palestinians in Gaza and to target civilians in Israel. A ceasefire would not dissuade Iran from promoting anti-Western actions.

The Gaza war is tearing at our American society. Neo-Nazis are allying themselves with pro-Palestinian factions, an opportunity to develop an ally for Neo-Nazis' anti-Semitism. From the perspective of those who support Israel's need to destroy Hamas' underground network of military tunnels and the need to retrieve the remaining hostages, calling for an immediate and unconditional cease fire is emphatically unfair to the families whose loved ones were brutally and gleefully murdered and kidnapped on October 7th, and to those who feel their loss and pain; it represents the worst pogrom since the Holocaust. It also ignores the many efforts made by Israel to create lasting peace with Gaza and to expand Gaza's freedom. It's vitally important to understand the many truths of the complicated history and relationship between Israel and Gaza and Palestinians and the rest of the Middle East when examining these issues and proposing resolutions.

I urge you to reject this poorly thought-out resolution. The county would be better served by efforts to strengthen our community, rather than divide it, which is exactly what the proposition of this resolution is doing.

We need to do better than that.

With the news last night that Howard County Council Member Liz Walsh's Ceasefire resolution to the Howard County council will be fast-tracked to a vote on Monday rather than go through the public comment that was scheduled for February 20th, I wanted to express my deep concern and strong opposition to the Resolution (CR 22-2024) introduced by Councilmember Walsh.

The crux of my opposition to CR 22-2024 is that the resolution calls for a ceasefire, but does not explicitly call for the release of all of the 130+ hostages (or remains of hostages) still being held in Gaza by Hamas, Palestinian Islamic Jihad and other associated terror groups. The ceasefire resolution also appears to be a one-sided ceasefire, which pins the blame for the devastating loss of innocent civilian life in Gaza and Israel solely on the actions of the State of Israel and the Israel Defense Forces. Further, the resolution makes no mention of the brutal events of the unprovoked attacks of October 7th, which claimed the lives of more than 1200 civilians – brutally murdered in their homes, in the fields, at a dance festival, on the road and in any place where the terrorists found them. Again, the details of these attacks have been chronicled by those who witnessed and survived, but also by the explicit body-cam images captured and disseminated by the Hamas terrorists. As someone who has seen some of the most graphic imagery that was deliberately and joyfully distributed by Hamas, I can tell you that when the deniers will come to say that these things did not take place, the very perpetrators of these actions will have provided the incontrovertible evidence.

If the International Court of Justice itself recently called for the return of all hostages and did not ultimately call for a ceasefire, why would our county council? It literally does not make logical sense.

Councilmember Walsh referenced several leaders of the Democratic Party who have similarly called for ceasefire's in their resolutions. They specifically called for the immediate release of all 130-plus hostages. The decision to consciously omit this from the resolution submitted to the Howard County Council can be seen as nothing else than a deliberate decision to erase the existence and legitimacy of the lives of these hostages – civilians who range in age from one year old to mid-80s. This decision alone should make anyone who cares for all of humanity carefully consider what a vote for this resolution would say about their values, commitments and ethics.

I say all of this with the simultaneous deep concern for the untold amount of suffering being experienced by the civilian population of Gaza. The civilian casualty numbers are beyond comprehension, and I call on the Israel Defense Forces to do everything possible to avoid any and every civilian casualty, even as they legitimately proceed in this war against the Hamas terrorists who have repeatedly vowed to conduct attacks worse than October 7th again and again – witness repeated public statements by Hamas officials both in the Gaza strip and speaking from their relative safety of Qatar.

Any Ceasefire resolution must also acknowledge the deliberate and calculated tactics and actions of Hamas that make them culpable for substantial percentages of the civilian deaths that have occurred throughout the prosecution of Israel's war on Hamas. As a resident of Howard County, I am writing in regard to proposed resolution CR 22-2024 on which the County Council has scheduled a vote on February 5, 2024. While the situation in Gaza, Israel, and the surrounding areas are horrifically tragic, I am writing to request that Council members do not vote for this resolution as written.

On October 7<sup>th</sup>, 2023, Hamas entered from Gaza into Israel, killed an estimated 1200 people and took an estimated 250 hostages, of which an estimated 150 may remain. Since that time Israel has entered Gaza, with the stated goals of removing Hamas from power and to obtain the return of the hostages. Many have spoken out about the displacement of Palestinians and the loss of life in this period. Estimates have put the loss of life in Gaza at over 25,000 individuals. I share in the concerns as to the degree of response, akin to some of the recent considerations regarding the United States use of atomic weaponry in Japan in the wake of the attack on Pearl Harbor in World War II. I note that the use of the atomic bomb on Hiroshima and Nagasaki at that time is estimated to have resulted in the loss of between 150,000 and 250,000 lives over a two to four month period, half occurring on the first days after the bombings. This is clearly not to diminish the lives lost in Gaza, but to try to give each of you a different context or reference point outside of the current situation as to whether a cease-fire resolution is a proper action this Council should be taking at this time.

A call for a complete cease-fire is a call saying that terrorist organizations, and in this case one that is essentially a de-facto government, should be able to seize and hold innocent people hostage at its own leisure. Even if one views the actions of Israel as disproportionate, it should not result in a resolution that in effect says Hamas is entitled to hold hostage the innocent people it took on October 7, 2023. Additionally a resolution that only calls for a cease-fire in Gaza is implicitly condoning the continued or future use of violence by elsewhere within Israel – given that the current events stemmed from the actions of Hamas on October 7, 2023.

I also am deeply troubled by an implication at the outset of the proposed legislation that the current actions in Gaza involve the “targeting of civilians”. (First whereas sentence of CR 22-2024.) Again, while we can be deeply affected by the loss of life that has taken place, extreme caution should be taken with regard to the imposition of intent at this time – which is what the word “targeting” certainly does do. I note in particular the comments of United States House of Representatives minority leader Hakeem Jeffries who on October 31, 2023 stated “Israel is not conducting an ethnic cleansing campaign. Israel is not engaged in genocide. Israel was brutally attacked in the most horrific way on October 7th. It has resulted in the largest loss of Jewish life since the Holocaust. And Israel is in a position where it is responding and going after Hamas. That is a necessary and urgent project for it to complete.” (<https://democraticleader.house.gov/media/press-releases/leader-jeffries-extreme-maga-republicans-want-irresponsibly-condition-aid>)

For these reasons, whether this matter is one suited for this Council as opposed to other government bodies, as well as many other reasons unstated, I ask that you not support this resolution as currently drafted.

I write you as a long-time (45+ years) resident of Howard County and your District. Over the years I have served as a Transition Team member for all Howard County executives since Liz Bobo (except Alan Kittelman); a former multi-term member and Chair of the County Council/County Executive Compensation Committee; former Chair of the Howard County Economic Development Commission (predecessor to the current EDAC) and more. I point this out to remind you that I am well aware of the responsibilities and limitations of appropriate behavior and actions by our County Government. I fear that the proposed Resolution goes well outside of the limits of appropriate actions by the County Council.

I am very distressed to hear of the proposed Howard County Council resolution (CR22-2024). While I believe most residents of our County support the goal of an immediate ceasefire in Gaza - it MUST be coupled with an immediate release of all hostages taken by Hamas and their proxies in the October 7th raid on Israel, destruction of all tunnels used during and after the invasion, and multi-lateral guarantees against the ability of Hamas to ever invade Israel again. Failure to couple those several components and more suggests that the County Council and by extension, the residents of Howard County, are unconcerned about the Israeli hostages and ignores the unprecedented terrorist attack to which Israel was subjected.
