## County schools to cut environmental education programs

The Howard County Public School System (HCPSS) has proposed cutting the last remaining environmental educator in the school system after 18 years of groundbreaking programs. Ann Strozyk, the award-winning educator in this role, delivers hands-on programs to 15,000 students every year through a cost-effective partnership with the Howard County Conservancy.

## What will happen if this position is cut?

Without school system support of environmental education, the Conservancy will be unable to offer schools hands-on field experiences for students. At an absolutely *critical time for our environment*, these incredibly important programs that provide science education, inspire future stewards and build green careers will be decimated.

Hands-on learning is critical. While students can learn about the environment in textbooks, getting outside to identify stream life, discover biodiversity and collect and analyze data is priceless. Research is clear that when students spend time outside, depression and anxiety decrease and academic performance improves.

The Conservancy has leveraged the existing HCPSS partnership to secure an additional \$1.2 million+ in grants to support Howard County students over the last five years. This includes money for science equipment, teacher training and bus transportation. With no environmental education program at HCPSS, this funding will cease.

Howard County - we can do better than this proposal to gut environmental education in our county.

# How does Howard compare to other counties?

The HCPSS investment in environmental education is currently one teacher, dramatically less than other counties, despite being one of the most well-resourced counties in the state and country. This proposed cut is for one teacher, *the only school system environmental educator*, so an entire – critically important – program area will be cut.

Nearly all nearby school systems own and operate (**see map**) environmental education centers – fully staffed with school system funding for dedicated environmental education teachers, paraeducators and facility staff. In fact, Prince George's County Public Schools just provided \$15 million to EXPAND their environmental education center, on top of the \$2.6 million school system dollars they already spend each year on environmental education.

The first budget hearing is January 25th at the Board of Education meeting. Board members want to hear from the community about budget priorities.

My name is Katie White; I am a 6th grade science teacher at Elkridge Landing Middle School. I am writing to advocate the continued funding of HCPSS's Environmental Educator, as this position serves a critically important role for our students and community.

I joined HCPSS two years ago after teaching science for ten years in New York State. When searching for positions in Maryland, your district stood out to me because of its support for an embedded educator who serves as a liaison between the Howard County Conservancy and the district. Through this fruitful partnership, our students have benefitted from robust environmental education programs that have garnered state and national attention, such as the Watershed Report Card and Climate Knowledge Curriculum.

As a 6th grade science teacher, I have worked extensively with our Environmental Educator, Ann Strozyk, on the district's Climate Knowledge curriculum. This curriculum is the first of its kind in the region and one of the few cohesive middle school climate change curricula in our country. Frankly, this effort would not have been possible without Ms. Strozyk. She has been instrumental in providing ongoing teacher professional development, forging partnerships with community stakeholders, and organizing the herculean logistics of student trips and schoolyard field experiences. This curriculum is in the process of scaling up to be taught by all 6th grade science teachers in the district this year; at a time when we would need the most support, you are proposing to remove it by cutting this position.

Additionally, Ms. Strozyk manages our district's Watershed Report Card program, an authentic field science experience for 9th and 10th grade students. Celebrating its 10-year anniversary last year, this program has coordinated the efforts of thousands of students across the county in their collection of data about the health of our watershed. This information has been used to shape policy decisions and has empowered our students to be change agents in their communities.

By continuing to fund the Environmental Educator position, you would demonstrate your commitment to fulfilling Maryland's Environmental Literacy Instructional Standards, which call for meaningful environmental literacy education for all our state's students. You would also demonstrate your commitment to leading the way in cultivating the next generation of environmental stewards. Perhaps most importantly, you would be aligning us with the vast majority of Maryland school districts in their

commitment to environmental education. All but two Maryland districts (Howard and Baltimore County) fund their own environmental education centers with yearly budgets of \$1 million or more; we are merely asking for you to extend your funding of a single educator *position*.

In a time when our collective inaction has led us into uncharted climate disaster and environmental degradation, would you truly propose removing the supports that would help our community secure a better future? I implore you to reconsider.

As a volunteer naturalist at the Conservancy for almost 10 years, I watched Howard County students, including my granddaughter, participate in several hands-on programs and field experiences. Such as:

- -- Learning and doing biological assessment of macroinvertebrates by wading in the streams using sampling techniques to identify minuscule aquatic bugs.
- -- Conduct physical stream corridor and habitat assessment.
- -- Nature hikes, where students identify invasive species and the harm they can do to the environment, climate knowledge, CO2 impact.
- --Other activities include assessing the level of nitrate, nitrite, pH level and oxygen found in stream waters.

I'm writing to strongly urge you to retain Ann Strozyk's position as the only full-time environmental educator in HCPSS.

Today's students spend hours each day on screens of one sort or another and most spend little time outdoors. We all know that this is bad for both their mental and physical health.

But what's the solution? Just sending students outside isn't enough. The key is to teach them more about the natural world and get them interested. When students know more about nature and the environment, they see more when they are outdoors. This progressively reinforces their interest and understanding.

Engaging teachers like Ann Strozyk get students interested in what goes on in watersheds and what key problems like climate change are all about. Through her instruction, students learn about critical environmental issues and begin to see themselves as people who can contribute to the solutions.

I find it shocking that in one of the wealthiest counties in the US, HCPSS has only one teacher dedicated to teaching our students about the environment. Ann Strozyk has developed programs that teach 15,000 students each year about key environmental issues. She takes students outside to teach them about watershed health and she has pioneered an excellent program for high-school students about climate change impacts and solutions. Ann Strozyk is an exemplary teacher and a tremendous resource for the County. How can you even consider letting her go?

I have worked with Ann for four years as a lecturer in the Youth Climate Institute (YCI). I could not be more impressed by her leadership.

Ann has built YCI from the ground up into an experience that prepares students to deal with the impacts that climate change will have on their lives. First, students in the program learn the key science behind climate change and what it will take to turn this crisis around. Then they take on a specific aspect of the problem in an action project with a local expert as a mentor. These experiences build their confidence and help them to see themselves as people who can make a difference. I'm very proud to be associated with this excellent program.

Ecoanxiety in young people is rampant, and many are seriously depressed about their future as the impacts of climate change grow each year. Programs like the Youth Climate Institute are essential to countering this debilitating ecoanxiety because they teach students tangible, science-based ways to take meaningful action. YCI gives students the confidence that solutions to climate change can be found and provides the tools they need to make a difference. The fact that high schools all over Maryland (and beyond) are starting YCI chapters is a testament to the importance and appeal of this program. Cancelling YCI by firing Ann Strozyk would be a huge step backward for HCPSS and a tragedy for our students.

I cannot recommend more highly that you retain Ann Strozyk as a valued teacher in HCPSS. We need her enthusiasm and compassion as she engages our young people in environmental issues and helps them to become effective stewards of the natural world as adults.



Dear HCPSS Board of Education, Howard County Executive, and Howard County Council,

I advocate for saving the environmental education teaching position.

I am a former HCPSS teacher who left the system because I couldn't keep up with the time demands of the position. It makes my head spin to think that teachers will be forced to "do even more with less" if these budget cuts occur.

My children are long graduated from HCPSS. And as already mentioned, I don't currently work for the school system. But I will be directly affected by what happens as a result of these hearings—as will all of you.

We live in an increasingly artificial world—one where it is common for our young people to spend much of their free time indoors scanning social media or watching screens in other ways. Spending time outdoors might only mean participating in a sport. Our society is also increasingly urban. Prime real estate is gobbled up by developers to become shopping centers, parking lots, and new housing.

I was lucky growing up. I came from a small town and my dad immersed me in the natural world. We dug our own worms in our backyard garden for fishing bait. We camped often and spent time in the woods learning to identify trees and played in streams. I cared about the environment because it was my playground. I wear a "tree of life" pendant and my email address is "gardenheidi" and I still go camping and fishing.

Last spring, I volunteered at the school where I used to teach. The fourth and fifth grade students were building a pollinator garden. I know that not every kid is comfortable cuddling up to worms, but I was shocked at just how foreign the concept of "dirt" was for most of the kids. I spent much of my time calming down shrieking kids and explaining that the bugs and worms actually belonged in the dirt.

It was clear these kids hadn't enjoyed the same upbringing that I had. They were certainly benefiting through the exposure of this garden project, but in my opinion, they needed a lot more dirt in their lives.

Unless our young people learn about the environment—how to see it, how to feel comfortable in it, how to understand it, how to enjoy it, how can we expect them to care about it?

And for ALL our sakes, we need them to care! We need them to care and become involved--now more than ever!

Climate Change is real. Just turn on the TV and on any given day you'll see super storms, rising sea level flooding, or other extreme weather. Environmentally-irresponsible development is also real. I live in Ellicott City. I invite you--today--to take a stroll down Main Street and watch workmen dismantling our historic buildings and begin digging the giant mega-million dollar tunnel to mitigate future flooding and loss of life.

The impacts of climate change will affect every one of us. We may not experience a wildfire in Howard County, but we will experience rising costs for food and housing. Insurance costs will skyrocket. Scarcity of resources and increased pollution will also occur to levels that will impact our world—maybe not today. Maybe not in our lifetimes. But our children and grandchildren will certainly bear the brunt of life-changing climate change if individuals aren't concerned and involved in seeking solutions.

The environmental education position provides students exposure, and teaches students how to interpret our environment--how we can make a positive impact. It is a program building understanding of our surroundings and teaching students to care.

And we need our students to care. We need our students to CARE!

Our students are our future. I don't know about you, but I want to know they care about the environment and know that we are providing opportunities that can ignite sparks revealing a path toward finding solutions.

I propose that of all school positions, the environmental education position is the MOST important. Through the environmental education program, 15,000 students annually experience the outdoors in a meaningful way—in a way that can't be captured on a YouTube video or in a book.

Math scores, reading scores, the arts, programs, etc., are all important. But none of that matters if we don't have an environment and planet where we have the luxury to prioritize such things. If we don't teach our children to care about our environment, nothing else will matter.

All of us, but especially our children and grandchildren, deserve a future in a healthy environment. It won't happen by accident. Please help our young people of today learn to care about the environment, to protect it, to preserve it, and to learn to do their part.

Please continue the environmental education position in the HCPSS.

People don't learn to care in a vacuum. People care and get involved because they understand.

# Written Testimony for the Superintendent's Proposed FY 2025 Operating Budget Public Hearing, Thursday, January 25, 2024 – 7 p.m.

Honorable Chair and Members of the Board,

I write in opposition to the proposed elimination of the Environmental Educator position. For the last 18 years, the County's investment in this single FTE in combination with resources from the Howard County Conservancy has produced a program in environmental education that is recognized as "cutting edge" not only in Maryland but across the Nation. Over one million dollars of grant support have been garnered to support the many projects that our County's Environmental Educator, Ms. Ann Strozyk, has nurtured. I am a retired researcher who has written, reviewed, and administered grants and can attest to the importance of this FTE to obtain outside funding. This commitment highlights the local support of any new proposal and boosts the reviewers' assessment in turn.

Ms. Strozyk has spear-headed hands-on and field-based opportunities for more than 15,000 students in Howard County. I volunteer for both the Watershed Report Card and the Climate kNOWledge programs and can't begin to outline all of their positives, so I will describe only two here: 1) When I lead hikes of sixth graders, not only are the students enthusiastic but the parents who chaperone are impressed with how much they learn; and 2) Ms. Strozyk has recruited and ably trained so many outstanding volunteers that each of us can work with a small group of about ten students for most exercises. Each volunteer has a unique background to offer, and many have supplemented their knowledge with Master Naturalist and other advanced training. Thus, the County's small investment supporting Ms. Strozyk's effort provides unique small-group experiences that would be otherwise unavailable in the HCPSS curriculum.

In my view, the question is not whether this position should be cut, but why is our commitment so small? Throughout Central Maryland, only Howard and Baltimore counties lack an Environmental Education Center. In our County, there is only one Environmental Educator per 57,000 students compared to a more robust ratio of 1:11,432 throughout the region. HCPSS is getting a lot of "bang for the buck", and I strongly support the retention of this critical position.
