I am writing today as a concerned parent of a future OMHS student. It's been known for a while now that the conditions of this school are deteriorating, and now- to a point where school is cancelled due to HVAC issues and a water leak.

"When originally deferred, this was a major HVAC renovation project; however it has been nine years since the project was deferred. Current conditions at the school now require a full renovation. It's not practical and cost effective to maintain the system any longer. Due to the fact that the system is old, obsolete and continues to be problematic we are unable to provide a conducive learning environment to both the students and staff."

Although you would think that this is a quote from the past 2 years, it's actually a quote from the **2017-2018 school year**. To keep everyone informed on the condition of the Oakland Mills High School facility, I would like to make you aware that OMHS was closed today.

While I do not have all the information, I know that at least 25 classrooms have flooded due to a leak associated with the HVAC as of 7:00 am.

This is simply distressing. For years, we have testified on the same issues of an obsolete HVAC system and aging infrastructure. First, it was small leaks in the weights room where soggy ceiling panels crashed to the ground. Now, our ceilings are completely falling apart and it is only by luck that none of this happened while students were in the building. All elected officials are liable for my school's facility.

While we do not yet know the cause of the leak and if it could have been prevented, the sentiment of my community remains.

I am currently obtaining additional information and will continue to send it your way.

Dear Acting Superintendent Barnes, Members of the Howard County Board of Education, County Executive Ball, Members of the Howard County Council, and the Maryland District 13 Delegation:

The Oakland Mills Community Association (OMCA) is extremely concerned that for the second time this school year, instruction at Oakland Mills High School has been interrupted because of the condition of a building that has been deferred for major maintenance and renovations since 2009.

Yesterday, OMHS was closed because of an HVAC failure and a flood. Earlier this school year, the Media Center closed for several days due to mold from an insufficient HVAC system. OMHS students deserve the same educational opportunities as their colleagues from throughout the county, and yesterday they received no formal education at all.

OMCA requests immediate responses to the following questions:

- Given OMHS has already been plagued by mold in multiple areas this year, what independent assessments will be performed on the building to ensure that yesterday's incident has been fully repaired and remediated with appropriate humidity levels throughout the building and no growth of mold or other airborne irritants? How frequently will the building be assessed to ensure nothing was missed?
  - How will these assessments be shared with the community so parents, teachers, and students know it is safe to return to the building?
- Given a 2017-2018 assessment of OMHS noted the deferrals since 2009 and concluded the HVAC system could no longer provide a conducive learning environment and recommended a full renovation, what assurances will you make that OMHS will no longer be deferred in future capital planning cycles?
- Will each of you spend at least a full day at OMHS touring the facility and meeting with students and teachers who have bravely spoken up about the

condition of their building and the physical and psychological tolls they have paid as they watched their hOMe get deferred year after year, and now decade after decade?

It is unacceptable that this is happening as it could have been avoided. The blatant disregard for the emotional and endless pleas of students and parents for years is inexcusable. An immediate response to all of the questions posed is warranted.

#### Good Afternoon,

We are the Oakland Mills Student Body Executive Board in Howard County, Maryland. For the past 2 school years, the Howard County Board Of Education has consecutively pushed back our renovations. From the proposed budget plan last year, the renovations that we were in dire need of were pushed back from the years 2029 to 2038. However, a group of passionate students and staff testified and spoke out against the unfair treatment and lack of prioritization of our school. We were somewhat successful when the Board of Education decided to bring our renovations down to 2026. Our HVAC system has not been renovated since 1973, resulting in many students and staff suffering from conditions that no one should ever undergo.

Along with the lack of standard air quality, mold, unregulated temperatures, ceiling tires falling out and the other numerous safety hazards, yesterday our HVAC system exploded and pipes burst resulting in 26 classrooms flooded. The Oakland Mills administration staff were immediately notified and took action, closing school for all students and staff. Our custodial staff of 8 members were hard at work to ensure students would be able to return safely to school the following day.

These conditions are unacceptable, prioritization for the Oakland Mills community is crucial under these circumstances. Unsafe school conditions have continuously been affecting our students and staff members to the point where our school is the only school in Howard County being closed. Our education as well as futures matter.
