My name is Fernando Dominguez, I am a parent at Longfellow Elementary; my wife and I moved to Columbia in 2022 from Miami, Florida because we learned amazing things about the public schools here (especially compared to what Florida's have turned into). So far, we have been blissfully impressed with our experience in the Howard County Public School System!

I am writing you today because we understand that due to budget cuts our school is facing the possibility of losing our orchestra teacher as a full-time employee. I completely respect that people with much more information than me have deemed it necessary to make these cuts, but I would like reconsideration of where the cuts are being made.

Firstly, it saddens me that the first place cuts seem to usually target is the arts, we all agree that core skills like math, science, reading, etc. are of utmost important, but art programs are also critical for a person's development at any age (See: <u>Study backs link between music and cognitive ability</u> and <u>Playing a musical instrument good for brain health in later life - study</u>). Speaking from our own personal experience, the feeling of seeing our 3rd grade daughter on stage for the first time at Wilde Lake Highschool, playing her cello with her school orchestra, was an unforgettable moment in our lives. It gave her an unrivaled confidence boost, and it motivated her to continue playing the cello instead of quitting and moving on like she's done before with other instruments.

The thought of our younger daughter (Kindergarten) not having this same opportunity due to these budget cuts and the risk of losing Mrs. Williams, genuinely breaks my heart. Even if we got her private lessons, she wouldn't have the opportunity to play with her classmates on a big, beautiful venue; or simply the chance of sharing the experience with her school friends.

Lastly, on that last point, not everyone is fortunate enough to be able to afford private lessons. Longfellow's population skews all over the socioeconomic spectrum, our demographics are mostly black and Hispanic; I have been serving as the Hispanic liaison for the PTA for about a year now and gotten to know the Hispanic families at our school. Unfortunately, they are not wealthy, far from it, it's mostly working-class families for whom a private music tutor is a stretch if not completely out of the question. What I mean is, Mrs. Williams' orchestra class (and the benefit of renting an instrument for very little money through it) are in all likelihood the only opportunity a lot of our kids will have to touch an instrument at this important early stage in their lives.

In closing, please, I implore you all to reconsider these budget cuts and really think about the effect they have on our children. Cutting the music budget is not just dismissing an employee, it's disrupting the cognitive development of our children, it's potentially removing the chance to learn an instrument from someone's life altogether.





However, I am still a taxpayer and voter who has lived in Columbia since 1992.

I implore you not to start gutting the excellent music programs of Howard County.

I write this even as a STEM researcher, who believes a broad education, including opportunities for all Howard County children to learn music and arts - and not just those privileged to afford supplementing with music and arts separately - is key to providing a well-rounded education for all of our county's children.

My children both benefited from the strings and band music education offered starting in elementary school.

While my son did not necessarily feel "forever" love for viola, he learned many things during his elementary exposure to strings. Among other things, he was very proud to read that strange viola clef that no one else in the family can read! My daughter is a child that thrives on community. When she joined the third grade orchestra, she found that community. Her map test scores in reading went from the 71st percentile at the end of 2<sup>nd</sup> grade to the 92<sup>nd</sup> percentile at the beginning of 4<sup>th</sup> grade. Her math test scores have also rose from the 55<sup>th</sup> percentile to the 70<sup>th</sup> percentile.

There are many factors that led to that improvement, but her involvement in the orchestra program surrounded her with a group of high-achieving students that lifted her as they worked to make music together. And because anecdotal evidence is never enough, it is important to note that research consistently highlights the positive impact of music education on academic performance. Students engaged in music often show improved cognitive skills, better concentration, and enhanced problem-solving abilities. These benefits extend beyond the music room and positively influence their academic achievements.

I started my career with HCPSS as an orchestra teacher in 1998, so I have seen the county grow and change over the past quarter century. Most of the changes have been positive as I have seen huge improvements to the quality of education that the county has provided our community. But I would like to share a historical comparison. For the first few years of my career, I was split between 3 schools yet I was able to offer my students a daily class as well as 1 small group lesson per week. With the current number of students I am assigned to teach, providing that level of instruction would require 45 class periods per week, 20 classes larger than the 25 classes that I should be teaching with my contract. I currently teach 32 classes a week (5 during my assigned planning time and 2 before school). Because these students are incredible, my time has become the single greatest limiting factor to their improvement. My students consume knowledge faster than the rate that I am able to provide instruction. Limiting staffing limits student achievement. It is that simple.

Slower growth in our community and inflation provide enormous challenges to public funding, but limiting education funding will exacerbate problems in our community. Keeping class sizes as low as possible is incredibly important. Keeping programs like 3<sup>rd</sup> grade strings is extremely important. We decided to start instruction for our strings programs in 3<sup>rd</sup> grade because of the issue of equity. Wealthier families are able to seek out music instruction from private sources and commonly start providing violin and cello lessons at age 5. By providing string instruction in 3<sup>rd</sup> grade instead of 4<sup>th</sup> grade, we have worked to reduce the gap between families with disparate incomes. Our music programs contribute to building a sense of community within our schools. The collaborative nature of musical ensembles teaches students the value of teamwork, discipline, and perseverance. These qualities are essential not only in their academic journey but also in their future careers.

I hope this letter finds you well. Here in Howard County we are once again facing cuts to education. This is frustrating to hear as an HCPSS educator and graduate of HCPSS. I am writing to express my sincere concern regarding the potential program and staffing cuts in the Howard County Public School System. While I was glad to see that some of the proposed cuts were reversed at the most recent work session, I am shocked that the BOE voted not to reinstate funding for the 3rd Grade Strings and Elementary GT programs. These two programs have profound effects on many students.

I attended several of the public hearings in the past month, and I have one important point that I want to bring up that I have not heard shared previously. These two programs - 3rd grade strings and GT - are two of the only curricular choices our elementary students get to make. While any good teacher provides options for student choice within their lessons, our youngest students get very little choice regarding what courses they take. Every elementary school student will take ELA and math, and they will experience science, social studies, and health through content. However, students CHOOSE to enroll in instrumental music. They decide whether or not to participate in GT instructional seminars. As someone who teaches elementary instrumental music in the county, I can tell you that these students are excited to come to instrumental music class. They look forward to learning new songs and skills. As one of my students recently remarked, they are genuinely excited to just come and play their instruments and learn in a different way than they do anywhere else in the school building.

3rd grade strings is the foundation of our HCPSS instrumental music community, and one of the first choices our students get to make about their education. 3rd grade strings and GT also promote equitable access to instruction for all students, as well as a sense of belonging. We ensure that our students who need instruments and other materials to access music instruction have them - even if it means scouring yard sales and repairing instruments ourselves to acquire them. No student is turned away from the instrumental music program.

The 3rd grade strings program also helps to promote a sense of belonging for students. Not every student is an athlete, and not every student can access extracurricular activities due to time and finances. Yet every student can be a musician, and participate in instrumental music courses during the school day. As I like to remind my students, they are not just someone who plays their instrument - they are musicians. Each and every one of them makes up the ensemble that we call our school band and orchestra, and without their important contribution our ensemble would never be the same. It's amazing to see how that simple idea builds

confidence and self-efficacy for so many of our youngest learners.

## Dear Sir or Madam,

I am writing this email to you in support of the Music and Arts programming in Howard County Public Schools. I respectfully request that you share this with those who are shaping the fate of these programs.

We find ourselves, yet again, at the precipice of potential budget cuts throughout the school system. It's becoming a tired story: the county and/or school administrators propose detrimental cuts to Music and Arts, parents find themselves rallying behind the programs, and the school system realizes it's playing the short game rather than thinking strategically about the health, welfare, and educational needs of our students. It's time to cut out this insane process, and stop putting Music and Arts on the chopping block.

A school would never propose cutting math, science, languages, or history, because they see them as somehow different from what Music and Arts provides. A school would never consider cutting its football, baseball, or soccer programs since they put physical prowess on display and are thought of as team sports. Music and Arts provides, not only incredible educational value, but also the glue that binds the entirety of those programs together, physical and emotional rigor, and perhaps MORE teamwork and collaboration than the traditional sports.

Study after study has shown that Music and Arts are critical for the success of students throughout the educational spectrum. Hallam (2010, Oxford University Press) discusses the role of music in mood management, interpersonal relationship growth, and its benefits on physiology, behavior, and concentration. Petress (Education 126(1), 2005) shows how such programs result in individuals who are more successful in society, school, in developing intelligence, and overall in life. I can easily reference dozens more articles on the topic, but I believe that this information is already well known within the higher ranks in HCPSS.

Music is, in itself, a structured language which requires the practitioner to learn to communicate using emotion and expression, through a variety of media — whether lyrically/vocally, or through the use of well-known instrumentation (such as strings, brass, woodwinds, percussion), or even using the environment (like tables, chairs, hands, feet). Music also enriches knowledge of other languages, as is seen in the Choir program's use of foreign language literature, or when reading a band chart with Italian-language cues.

Music relies on and fosters a strong knowledge of mathematics. Ask anyone who has ever played a chart in an odd-time signature, replete with syncopated rhythms or the aggressive use of 32nd and 64th notes. It's about more than the joke about musicians knowing how to count to four.

The very existence of musical notes is the result of physics. Favorable melodies and harmonies rely on aesthetically-pleasing combinations of vibrations at various frequencies — a term that both music and physics share for the exact same concept, harmonics.

Music's impacts on history, as well as history's impacts on music, cannot be underscored enough. While so many examples can be given on this topic, the most immediate that comes to mind relates to the 1960s in America and beyond. World events shaped the course of music forever, and music left an indelible mark on world history — not just culturally, but even how politicians responded to musical protest over the Civil Rights Movement and the Vietnam conflict.

This goes beyond just music, of course. The Arts includes performance on stage, whether through acting or dancing, as well as those arts which find themselves on display in other media — graphic arts, material arts, and more. In fact, the very existence of nearly everything one interacts with in life is the result of an artist:

- Taylor Swift is a billionaire and a cultural icon, not because music is <u>un</u>important, but because of its criticality on life. Same too of Kanye West, Dr. Dre, and even smaller-scale performers like Billy Joel, Elton John, Rush, Genesis, and more.
- The highest grossing films of 2023 included Oppenheimer (a biopic) and Barbie (a cultural phenomenon, coupled with feminine rights); clearly, film represents the arts.
- Art museums throughout the world are filled with priceless works, not because nobody cares, but because they do. Works of art fetch millions of dollars at auction and are the stuff of news think of Banksy's self-destructing painting, the Mona Lisa, and Starry Night.
- Photography appears everywhere to help clearly communicate world events to people. The New York Times, Washington Post, Baltimore Sun, and all other outlets, are reliant on photographs to engage their readers, whether in paper or online.
- The clothing you're wearing right now came from a fashion designer who expressed his or her art in a manner appealing enough to garner sales and potentially a following. Michael Kors, Louis Vuitton, and other such brands don't exist because of the mere presence of leather as a material.
- The car you drive, the toothbrush you use each day, the plates in your kitchen, the house you live in everything is the result of an artist.

All of these things will cease to innovate with cuts to the music and arts. That would be appalling. Sure, we can continue to use that which exists now for eternity, but we don't still use rotary dial phones anymore for a reason — a confluence of engineering and art, and as

evidenced by the many iPhones and Android devices, laptops, smart phones, headphones, tablets, e-readers, personal home assistants (Alexa, Google Home, etc) that have not escaped a single person in our society, even in the relatively short lifetimes of our children.

Moving to a more personal perspective, I am the product of New York City public schools. I was fortunate that my parents were able to invest in my personal musical journey, since the school programming in the 1980s came nowhere close to the incredible wealth of opportunity within Howard County. There was no marching program in our high schools, there were no strings or brass programs in our elementary schools (only recorder a couple of times a YEAR), elementary choir was an after-school program that was weakly attended, and only a small number of high schools had funding for stage performances of any note. In high school, I participated fully in all aspects of the music programming available to me, affording me the opportunity to learn numerous instruments at varying levels of success.

I've instilled an importance of music in my two daughters within HCPSS. My older daughter, Addison, has been fully engaged since the third grade at Worthington Elementary School, where Mr. Brandon Henley started her on her musical journey. She continued through Ellicott Mills Middle School where Mr. Robert Burns, Ms. Nicole Sobel, and Mr. Ben Denne continued to help her refine her craft. Now, under the direction of Mr. Joseph Fischer, Addison has gained so much in the way of confidence and leadership, with inschool band participation, honors band programs throughout the East coast, membership in a university ensemble each week, and of course, as the lead drum major at Mt. Hebron HS in her junior year. Also, Addison is so enamored with music and her experiences that her intent is to become a music and special educator herself, and has already started offering tuba lessons to younger community members.

Our younger daughter, Rebecca, also learned from Mr. Henley, Ms. Sobel, Mr. Burns, and Mr. Denne, and tried her hand at a number of instruments before finding her intrigue in percussion. In fact, it was Ms. Laura Shum from Patapsco Middle School who provided the foundation for Rebecca's percussion education. In closing, the criticality of music and arts programming is all too often unappreciated and misunderstood as auxiliary education. It is not. For the sake of our students, I implore the county to reconsider any cuts to these programs.

We urge all of our elected officials to work together with HCPSS to help during this crisis and continue to solve the funding issues that seem to plague the system every year.

I also want to remind our elected officials that music education, in all of its forms, plays a pivotal role in shaping well-rounded individuals, fostering creativity, discipline, and teamwork. My child's involvement in music in Howard County schools has not only enriched her academic experience, but also has contributed to her confidence as a learner and as a growing community member. It has allowed her to find the place where she belongs and feels included, thanks to her involvement in HCPSS music programs.

My daughter was a third grade student in the first full year of COVID learning (fall of 2020). She chose to begin learning to play the cello as a third grade strings student in a year that was full of anxiety and uncertainty. Her overall educational experience during virtual learning was nothing short of challenging, and she was highly unmotivated to give her effort to virtual classes. She didn't feel a sense of connection to her class or to her overall education, and her morale was low, when in the past, she loved school.

Orchestra lessons were the one bright spot in her third grade school year. Thanks to her third grade orchestra teacher's excitement and dedication to her students, my daughter was motivated to engage in a creative arts opportunity when few other class activities offered an authentic connection to educational content. She grew as a responsible learner and looked forward to school thanks to her beginning strings lessons and her teacher's love for music and for her young students.

In a world with ever-increasing rigor and demands for increased pressure to perform and succeed academically, third grade is a highly pivotal year for children, developmentally and socially. The responsibility and commitment that is fostered through the third grade instrumental music program instills essential skills in our children that are most effectively learned at this age and at this point in their curricular learning. Statistics support the fact that while third grade is such a pivotal developmental year for children, participation in the arts at this time is incredibly supportive of this skill development.

By cutting the third grade strings program in HCPSS schools, the message is being sent to our community that the development of those skills is not truly important to our children's learning and

growth. The chance to experience responsibility and a sense of belonging at this critical age, bridging primary and intermediate years in elementary learning, is inherently part of our third grade strings curriculum and is the very nature of this type of instruction and learning. By significantly decreasing our children's exposure to this type of brain development at such a critical age, this decision will have deep impacts on not only the future of our instrumental music programs in the county, but more importantly, on our children's personal growth. It is highly disappointing to think of the future of our children in an already-challenging world, with so many negative aspects, with yet another opportunity removed from their future.

Furthermore, the concerns surrounding the equity of this situation for our community are shocking to consider. While some families in Howard County are able to choose to enroll their children in private instrumental lesson instruction, many others are financially unable to do so. Third grade strings provides an equitable opportunity for all interested families to access quality instrumental instruction at a pivotal age, without financial and socioeconomic barriers. If these programs are indeed cut, then countless families across Howard County, especially those in Title I settings, will no longer have access to these opportunities. This is not at all an equitable and accessible option for our children, if we truly value the concept of equity, inclusion, and access for all.
