Thank you for writing to continue your advocacy for supports for LGBTQIA+ students. As Mr. Barnes explained when he presented the Superintendent's Proposed FY 2025 Operating Budget on Thursday, the school system finds itself caught between rising costs and essentially flat funding. This is not a unique situation and is playing out elsewhere in Maryland and across the country. Because HCPSS does not have the ability to increase revenues, we must make some cuts to services to maintain a balanced budget, as is required by law. The current budget proposal increases class sizes and implements staff reductions at both the school- and central-office level in order to offset increases in areas such as staff costs, transportation, and insurance.

We are happy to report, however, that under the current proposal, the LGBTQIA+ Initiatives Specialist position is not being cut. Additionally, we are leveraging grant funding to continue the quarterly rainbow rep meetings. We will also be seeking additional grant opportunities to fund the continued expansion of supports to our LGBTQIA+ students. Barring the receipt of additional grant funds, however, we do not have the funds to significantly expand costs under the FY25 budget. We understand that this will limit our ability to grow supports in this area. However, other similar systemwide student supports will also remain at current levels or be curtailed due to the fiscal situation.

Please continue to speak highly of the work the office has been able to accomplish and the ongoing need to ensure safe and welcoming learning environments for all students.

We look forward to continued collaboration in support of our LGBTQIA+ youth.

Dear Board of Education Members, Mr. Barnes, Dr. Ball, and County Council Members,

This year's HCPSS budget situation is obviously very challenging and disheartening; I wish there was a simple positive solution, and I do not envy the challenges with which you are faced. I appreciate Mr. Barnes' approach regarding providing general information and rationales, though I lack intimate knowledge of many relevant issues. I would like to briefly mention a few thoughts, though; please contact me if you would like more elaboration.

As a retired HCPSS band director who taught in the school system from 1981-2015, I witnessed the building of an extraordinary music program that has had a positive effect in a multitude of ways on many thousands of lives year after year (please let me know if you would like elucidation). It is an example of a program that has been carefully built with the tremendous dedication and support of staff members, parents, students, and the community, and is now the gold standard in the state. I grew up in Prince George's County when it was the gold standard, but due to poor decision-making and a lack of support, it was severely damaged in the late 1970's and has yet to recover. I mention this as an example of the importance of considering the long-term effects of your decisions, so programs built with tremendous effort and funding will not be harmed in a significant way.

I realize that resources are limited, the proposed cuts are painful, and that the Board is not self-funding. I think that we, as a county, need to decide if we are going to do what it takes to maintain a high-quality school system going forward. Though raising taxes is not generally a popular idea, perhaps doing so in a progressive way could be a consideration, especially as those who own high-value property will benefit financially the most from being in a highly-regarded school district.

Additional thoughts:

Though I am generally supportive of later high school start times, I am not sure that the way it has been implemented is worth the result. From what I see, it is costing a lot of money, yet many students still cannot sleep later due to longer walk times, bus issues, or accommodations that have been made to the original plan. Especially given the financial challenges of FY25, I would encourage consideration of the initiative to determine if the cost/benefit is close enough to what was intended, and if it should remain a priority given the circumstances.

Chromebooks are now low enough in price that, over a four-year period, the per-year cost would be similar to many binders. Maybe they should be considered school supplies to be provided by parents, except for those with financial challenges. This would reduce HCPSS technology-related costs (again, please contact me if you would like elucidation).

Thank you very much for your consideration of my comments, and for your efforts as you try to do what is in the best interest of HCPSS students. Please be in touch if I can be of assistance. Best wishes as you pursue the best possible outcome to the budget situation.

I hope this email finds you well. As a parent of an enthusiastic elementary school student, I am writing to express my profound concern regarding the potential programmatic and staffing cuts in the Howard County Public School System (HCPSS).

Growing up in the Deep South, I yearned for a quality education and witnessed the stark differences between the haves and the have nots when it came to resources. Upon moving to Howard County, I was particularly impressed by not only the values of the county itself, but the reputation of the public school system. Despite friends and neighbors encouraging us to choose private or parochial, we made the decision as a family to proudly enroll our son into public schools as we believed in the system. Unfortunately, upon reading the report in the Baltimore Sun regarding the many budget cuts in the Howard County Public School System (HCPSS), that pride began to quickly diminish. Eliminating the BSAP Summer Institute and G/T Summer Institute directly impacts children of color, children who wish to hone in on certain skill sets, as well as those who may not have the financial resources that other camps require. These camps are not only beneficial, but also more affordable for families in general. By eliminating these programs, we leave some of our most vulnerable without positive outlets during summer.

Additionally, reduction of Behavioral Supports, School Counseling, and Psychological Services seem unethical in nature, as these cuts would directly impact students with social/emotional needs, special needs, and those receiving IEP and 504 Plan Services. As a Licensed Mental Health Professional who works at a school in a neighboring county, I have seen first hand how difficult it can be to manage the needs of young people trying to navigate the world with limited resources. As the schools are already overcrowded and understaffed, many of the students end up getting suspended/expelled instead of receiving the much needed mental health services they require as there simply are not enough staff to address their needs. Although I work extremely hard in my position to lesson this trend, as a parent of a child with a 504 Plan, it is heartbreaking to know that such a proposal could one day place my own child in a similar position. It is not fair, and our children deserve so much more. They cannot advocate for themselves, but as parents, voters, and community members, we can. This is not what I would have ever expected to see in Howard County, particularly in a school system that prides itself on excellence.

The proposal also lays out the potential for class size increases. Class sizes are already large, and increasing the class sizes all while reducing the amount of aide in the classroom seems counter intuitive. Our teachers deserve better. Our children deserve better. We will not continue to be a shining star educationally if we begin to do things that no longer set us apart. I understand that sometimes hard decisions have to be made, but please do not make them at the cost of our children, our future.

In closing, I sincerely ask you all to work together to ensure that the Howard County Public School standard continues to be something that we can all be proud of.

Re: Save our Critical Services and Teacher Jobs

Dear Board Members:

My name is Daljit Kaur Soni and I am the mother of two kindergarteners and a 2nd grader at Pointers Run Elementary School.

I am writing to express my serious concern regarding the proposed cuts to 348 teachers jobs in areas deemed as "critical services" by an internally leaked memo.

Students and teachers have already endured increased class sizes over the last few years. This news is devastating to our entire county. I have personally been approached by 8 parents of special needs students who shared with me horrendous experiences of neglect, denial of services and reduction of existing services even before these proposed budget cuts.

We had to hire a private speech therapist out of our own pocketbook because the County removed the speech pathologist. HCPSS is now providing ONLY virtual speech therapy. A virtual professional, no matter how talented, cannot facilitate muscoskeletal exercises and strength building via a computer screen. You can't offer competitive salaries to keep good teachers when you cut this many jobs. They will go elsewhere and will not return.

We are accepting the cuts of services from every direction. From 3,000 families losing their bus service altogether to now telling us that our students will no longer receive technology education, or alternative education which is critical for students with special needs and behavioral issues.

We are in this \$100 million budget deficit because of years and years of HCPSS and the Board failing to ask the County Executive for what is needed by our school communities. Make your demands to the County executive clear and complete instead of protecting a flawed budgeting process.

Even if the enrollment numbers are stable or stagnant, this does not override the years and years of increasing student numbers without a simultaneous increase in levels of service or maintenance. School services in this county were in a steady decline even before Covid hit.

For people listening, you should know that a State run audit of HCPSS in April 2023 revealed that the budget deficit was primarily the result of decisions by the Board here to underfund projected actuarial benefit costs.

This audit also revealed that HCPSS engages in illegal contract procurement, with nearly \$40 million spent without following MD state laws to publish the contract bids before they are awarded. Evidence showed 15 contracts totaling \$12.6 million were awarded by senior management as the sole source on these contracts without any justficiation.

Evidence also showed that construction management firms have been awarded contracts without a competitive bidding process. Sounds similar to the Zum Bus debacle.

Speaking of which, what are the terms of the separation agreement with Supervisor martirano, is he also receiving a \$1.6 million payout like the Superintendent who resigned before him in 2017?

Nonetheless, the Board and HCPSS must revamp internal controls and accountability. in certain areas, including the processing of payments for

Please do the right thing, instead of cutting out teachers who provide critical services to our special needs communities, who support reading and math specialists, please seriously take a look at those on the top. I hope that the proposed cuts to the central office are given the same due analysis as cuts to the teachers that directly enrich the academic experience.

Dear Howard County and Maryland State Leaders,

I am writing to urge immediate cooperation and resolution of devastating cuts to Howard County Public Schools (HCPSS). The budget squeeze facing our high-quality local schools due to the unfunded, state-mandated pre-kindergarten program which is presenting an existential crisis we must address immediately through advocacy and intergovernmental cooperation.

Specifically, the state recently implemented expanded pre-K access without appropriating sufficient long-term funding. While praiseworthy in intent, this creates massive financial strain for counties now expected to foot the bill for a state priority. HCPSS, in particular, faces eliminating successful programs that have produced tremendous student outcomes.

Furthermore, the windfall of casino and lottery gambling expansion never materialized into promised budgetary relief for Maryland schools. Moreover, I urge you to collaborate closely and establish cooperative solutions that share the burden of proposed education reforms. - 2. Delay "new priorities" until you can sort out "existing priorities". The last 3-4 years has impacted many companies financially with COVID-19 pandemic and inflation. Take time to assess how budget cuts will impact current student and staff outcomes.

I am a parent of a first grader at Bellow Springs Elementary and though the classrooms are overcrowded, their resources seem limited, and the teachers are stretched thin. She absolutely loves school. She's most excited when she gets to check out a book in her Media class and thoroughly enjoyed GT summer program and has been looking forward to attending again this year. After reviewing the budget and researching Maryland's Blueprint for the Future, the proposed budget cuts are clearly in opposition of the direction the state of Maryland is going as outlined in the states' blueprint. In 3 of the 5 pillars, the proposed budget is clearly moving in the wrong direction, for example:

- **High quality & diverse teachers and leaders.** How can you expect to "create and sustain a teaching faculty that reflects diversity", when the current staff is being cut, class sizes are increasing which further taxes our teachers? Aside, the teachers are taxed which could impact their personal health further contributing to the cost of healthcare.
- **College and career Readiness.** How can you say you're driving towards CCR, when you are cutting funding for programs that were created to better prepare students for college and careers like Black Student Achievement Program, G/T seminars and summer programs, music, media and other programs?
- **Resources to ensure all students are successful.** You're proposing cuts to behavioral supports, while the blueprint is moving towards services such as additional behavioral supports.

None of these line items can be considered as standalone cuts. You have to take time to assess how cutting behavioral supports impacts children with special needs, the teachers responsible for these kids during the day and their classmates. My daughter is currently in a class with a mix of special needs students, students operating at grade-level and students operating above grade level. Just this year one of the students had an outburst and injured the teacher. This is apparently an ongoing issue in class. The teacher has minimal support for these students, and she's still expected to accommodate students at varying levels. How is this fair? How does having teaching environments like these attract the best

teachers? Making further cuts will most certainly exacerbate the situation.

Please consider:

- 1. Using the community to advocate for the funding and concessions we need. Please don't decide in a vacuum that there's only one course of action.
- **2.** Delaying "new" initiatives. Allow time to assess impact and outcomes of budget cuts. We're sacrificing the education of the kids that are already enrolled for programs that haven't begun.
- **3.** Thinking outside of the box. What school systems are innovative and managing well? Can we learn from them? Consider administrative restructuring. Are there roles that are outdated that can transition into new roles or provide support to schools and staff in new ways.

I recognize making cuts isn't easy. I also know that Howard County is full of passionate, bright and innovative people and organizations that can help the school system get back to the school system I heard about when I was considering moving to Maryland.

Please fully fund Howard County Public Schools 2025 operating budget. I'm confident that if you take the time, you can identify opportunities to improve school operations without impacting our students/faculty and staff.

Dear Howard County and Maryland State Leaders,

I am writing to urge immediate cooperation and resolution of devastating cuts to Howard County Public Schools (HCPSS). In 2021, my family moved from Northern Virginia, and Howard County's incredible public school system was a large part of that decision. I have three young children in 4th, 1st, and pre-K age, so we are severely impacted by these potentially devastating cuts.

The budget squeeze facing our high-quality local schools due to the unfunded, state-mandated prekindergarten program which is presenting an existential crisis we must address immediately through advocacy and intergovernmental cooperation.

Specifically, the state recently implemented expanded pre-K access without appropriating sufficient long-term funding. While praiseworthy in intent, this creates massive financial strain for counties now expected to foot the bill for a state priority. HCPSS, in particular, faces eliminating successful programs that have produced tremendous student outcomes.

Furthermore, the windfall of casino and lottery gambling expansion never materialized into promised budgetary relief for Maryland schools. A 2016 analysis concluded that over \$2 billion less has reached public education than initial projections stated (Baltimore Sun). Now, this is likely billions more.

I implore you as our leaders to redirect funding towards the structural integrity of our existing school infrastructure first and foremost. Moreover, I urge you to collaborate closely and establish cooperative solutions that share the burden of proposed education reforms. No matter how admirable the motivations, we cannot implement progressive social initiatives on the backs of counties already delivering academic excellence on strained budgets.

I am writing to express my strongest opposition to the proposed budget cuts to the Howard County Public School System (HCPSS) operating budget. These cuts will have a detrimental impact on our students, educators, and the entire Howard County community.

The mission statement of the HCPSS states that "HCPSS ensures academic success and social-emotional well-being for each student in an inclusive and nurturing environment that closes opportunity gaps." These budget cuts will directly impede the HCPSS's ability to achieve this mission, by failing our students and staff not only on an academic level, but on a social-emotional well-being level as well.

For too long, our students have borne the brunt of the consequences of poor management decisions made at the administrative level, and this round of cuts is no different. The students are the ones we are charged with serving and protecting, but they are the ones being harmed the most, and those making the decisions justify this by saying "kids are resilient". This is what was said when HCPSS stayed fully virtual during COVID, and what was said when the insane redistricting was pushed through in 2020. How much more resilient are we expecting them to be after this round of cuts takes away their teachers, takes away the programs they love and takes away so many of the supports that were put in place to deal with the other poor decisions that they were forced to cope with?

Cuts should be made elsewhere, namely from the central office and administration, and the county and state must be petitioned to address these shortfalls and imbalanced priorities.

The Harm of Budget Cuts:

• Reduced educational quality: The proposed cuts will lead to larger class sizes, fewer elective courses, particularly in the fine arts and G/T areas that so many of our students benefit from (and which set our county above the rest), and diminished access to essential support services like counselors and mental health professionals. This will compromise the quality of education our students receive, hindering their academic progress and development. How can we expect our teachers to nurture and include all students when we are squeezing more and more students into their classes? And "squeezing" in the literal sense, many of the

classrooms in our schools will not accommodate another desk. THIS FAILS TO MEET THE ACADEMIC AND SOCIAL-EMOTIONAL MISSION.

- Notable aside: the percentage of students received special services related to Special Education and Limited English Proficiency has increased steadily since the 2020-2021 school year (as included in the budget proposal); the proposed cuts will remove educators working with these students, therefore requiring fewer staff to work with the ever-growing number of students in need.
- Negative impact on educators: The proposed budget cuts include significant teacher layoffs, which will lead to larger classroom sizes, decreased teacher morale and lower test scores and success rates for our students, who we claim to support. This disrupts our school communities and weakens the foundation of our education system. How will teachers nurture students when they have nothing left in their cup to give? Impact noted in the budget document include:
 - o "Decrease in instructional mentoring...and intervention support"
 - "Less support to schools for supplies and materials that allow for student participation."
 - "Less support in the front office for students, staff, and the community"

• <u>Harm to community vibrancy</u>: Strong schools are the bedrock of vibrant communities. Weakening HCPSS will jeopardize property values, employer attraction, and overall well-being. Cutting education investment sends a clear message: Howard County no longer prioritizes its children's education and future, prompting families to seek opportunities elsewhere. While HCPSS was once the pride of the county, attracting residents both domestically and internationally, our reputation is faltering, and these cuts will only aid the dismantling of our once great education system.

Alternative Cuts:

Understanding that cuts will have to be made, particularly in light of the underfunded mandated implementation of the Blueprint passed by the State Legislature, I suggest you look into cutting other areas of the operating budget.:

- Redirect the capital budget for the Lakefront Library to a new school. A fancy new library is nice, but new schools are necessary and will achieve the same goals. I understand this is a capital budget issue, rather than operating budget, but this will alleviate some of the overcrowding issues being created and amplified by the impacts of the operating budget.
- Eliminate unnecessary, costly, bus routes by having students eligible to walk to neighborhood schools back to those schools. The transportation contracts put in place result in a nearly \$9 million dollar increase year over year.

- Cut costs on consultants who constantly recommend costly implementations of new curricula (which, in the case of elementary school reading, last about 2 years), new redistricting plans, new school start times, etc.
- Evaluate the need for, and efficiency of, the robust central office and administrative staff. The impact statements for the reductions in those areas are "increased workload"; this is what teachers already being made to do, before considering the increased class sizes. And the teachers aren't paid as much. True cuts don't appear to have been made here, rather positions were shifted around and reclassified.
- Review benefits plans and ensure that the best deals are being achieved for all. there is approximately a \$16 million dollar increase year over year in this area.

Alternatives to Cuts:

Instead of sacrificing the future of our children, I urge you to consider alternative solutions:

- Prioritize education: Explore reallocation of resources within the broader budget to
 prioritize education funding. I understand that much of this occurs and the County
 Executive or County Council level, and encourage you to work with them to work
 towards more amenable solutions.
- Seek innovative solutions: Collaborate with stakeholders to identify creative ways to optimize efficiency and generate additional revenue while minimizing cuts to core educational programs.
- Engage the community: Openly discuss the budget challenges and work transparently with the community to find solutions that everyone can support.

This year millions of dollars in cuts have been proposed that will greatly impact our school system. Howard County Public Schools have long been considered one of the country's best school systems and we need to make providing our children with a safe, world-class education a priority. I care deeply about the environment in which my child is learning, and I hope you feel and will act in the same way.

It is important that class size ratios are not increased. This would be detrimental to all students and staff. Larger classrooms result in less individualized attention from the teachers, lend themselves to a more disruptive environment because there are more students to manage, and mean less participation by students in group discussions. In schools with rooms that are already space-limited with even 18-20 children, adding in two more children and possibly more aides along with them, is too big a burden to bear. My name is Dr. Torie Grant and I am a board-certified pediatrician. I am also the mother of three children in Howard County. I am reaching out to you in response to the millions of dollars in budget cuts proposed to the Howard County Public School System (HCPSS) FY25 Operating Budget. https://www.hcpss.org/about-us/budgets/fy25/

The proposed budget cuts are sweeping and include, but are not limited to, an increase in class sizes at all grade levels, cuts to elementary music programs, cuts to STEM programs at all grade levels, and a reduction in services for children receiving special education support. Increasing class sizes, reducing special education support, and cutting many of the programs (particularly 3rd grade strings, elementary GT CEUs and seminars, BSAP and GT summer programs, and MESA) disproportionately affects low-income students and students from minoritized communities. Low-income families do not have the same resources to provide additional support for students with special needs, early or private music lessons, or STEM enrichment/exposure outside of school. It is our responsibility to ensure all of these enrichment programs are provided to every student in our public schools.

Howard County needs to continue to be a place that helps families with young children rise out of poverty. If allowed to pass in its current form, HCPSS FY25 Operating Budget would increase the already high educational achievement gap between low-income and high-income households.

My spouse and I both grew up in public school systems and moved to Howard County so our children could attend public schools which offer a world-class education to *all* children. Strong schools are the foundation of a strong community. Allowing these budget cuts to pass would be detrimental to our diverse and vibrant community and may cause families to leave HCPSS and Howard County in search of better resources for their children.

I urge you, our elected Howard County Council Members, to urgently provide more funding to the HCPSS BOE and to request more funding from the County Executive and State of Maryland Senate and House of Delegates so that the Blueprint goals can be implemented without causing harm to our current students and world-class school system.

I know you are all advocates for education and the underserved. We need to discuss how we can avoid these changes.

Dear Mr. Barnes, BOE, and State Officials,

Similar to so many other parents, grandparents, teachers, and community members, I strongly oppose the plan to increase class size by 2 students and make significant cuts to staffing. While the number 2 does not seem like much, it will certainly bust the balloon (which honestly has already burst). Physically, adding 2 more students to already overcrowded classrooms is not safely possible. My 4th grade daughter's class is tight. They have just enough room to provide some level of personal space (although I wish it were more). My daughter was recently hit in the nose by a kid swinging his water bottle due to the lack a space. Dunloggin Middle is so overcrowded you can't even get down the hallway during class change and children are being injured (as was my neighbor's son). Moreso, adding 2 more kids to already overcrowded younger grades is unfathomable and simply destructive. I have walked into my 1st grader's classroom and to say it was chaos is an understatement. The teacher was struggling to manage the numerous kids she had which is so hard at this grade level. I can't imagine adding 2 more. Further, the adjoining proposal to simultaneously cut staff further exacerbates these problems.

Mr. Barnes, you have not considered the cumulative impact of your plan when assessing the impact of both proposals nor considered the baseline status in either or both of these proposals. This proposal is antiquated in its approach and could be considered Draconian in nature when one considers the devastating impacts on the students and teachers.

I appreciate the budget struggle you are under but your proposal is not the answer. I strongly urge HCPSS to stop proposing these outdated means by which to address budget issues and start thinking outside the box. Find other means by which to save money that are not targeted at the teachers and students. Evaluate where money could be saved by improving the efficiency and reducing waste of contracts and programs already in place. Lobby for more funding from all those that you can, especially in light of the state level requirements you are facing. Be a leader of novel, inventive school improvement initiatives, not a contributor to downfall of Howard County schools. We moved to Howard County for the school system but are now seriously considering private education. Spending money on private education was not planned and we will suffer; however, we are being forced to consider this due to the middle school conditions we are facing and now proposals such as this.

Finally, Dunloggin needs to be demolished and rebuilt, now. I am seriously concerned for my child's safety and educational experience- she will be in 6th grade in fall 2025. Recently paint chips, likely lead-based given the school's age, have fallen from the ceiling and excessive, unsanitary rodent droppings have been found throughout the school. The school is already over capacity. Physically it is unsafe. The school has few windows, approx 54 kids (including girls starting menstruation) per toilet, and is falling apart in so many ways. I know you know this yet action has not only not been taken, a vote to rebuild the school was rescinded based on irresponsible misinformation. Please begin planning for the new school now using the funds available (I was present at a recent board meeting where they said there is some pot of money that can be used for architectural plans) so that when approved officially, ground can be broken immediately.

Again, I appreciate your job is difficult and you are facing many challenges. But the solution to those challenges can not be what you have proposed. The solutions must be innovative and most importantly, non-detrimental to the teachers and students.

Good Morning,

I am writing in regards to new budget cuts that may result in our children's school classrooms overcapacity. I recently spent the afternoon in my daughters 4th & 2nd Grade classes at Northfield Elementary School. I am a room parent for each of my children. I was helping to host Valentine's Celebrations. As for the 2nd grade class with 24 Students, it was a struggle for both volunteers and her teacher to coordinate an activity with this class size. This class also has 3 special needs children with 2 helpers for those students. I can not imagine fitting one more desk inside but more so I can not imagine the strain on the teacher by adding just 1 more student into this classroom. We have to think of the impact on the teachers, student, special needs helpers, and on the school staff by adding more students. This would absolutely limit the ability to properly educate our children. I also think if the room was any fuller we have to think of safety as it limits the ability to move within the space both for teachers, helpers, and students. I witnessed a lot of struggle when one of the special needs children needed their interpreter and they could not get to them fast enough because of the space. I can't imagine if we had to implement a safety drill for real life because logistically it would be a nightmare to protect that many children in a live shooter situation. We have to think of these serious concerns in today's society.

Later that afternoon, I was in the 4th grade classroom with 27 students. With just the additional 3, the space felt squeezed and I was overwhelmed with the amount of children. I had a hard time remembering names and being able to assit 1 child without 3 more asking for help. We are doing a disservice to these children by stockpiling them into a classroom and expecting one teacher to be able to get to each individual child. Every child deserves an education and to be heard in the classroom. When you put 27 children into a classroom, voices get lost and teachers become overwhelmed. The schools in Howard County are already under strain with the enrollment numbers rising each year.

Those like myself who live in this county continue to see the rising in buildings and housing contracts but have yet to see new schools being built to help with the capacity issues that are widely straining all of the Howard County Schools at all levels. The board of education moves these children like pawns on a chess board with no regard to their personal, emotional, and learning ability under this strain of changing their neighborhood school and having to move into a new and unknown school. The board of education calls this redistricting and we parents call this our worst nightmare. We buy our homes taking into consideration that we will be with our neighbors and attending schools within walking distance of our homes and yet are forced to be moved and bussed out of our neighborhood into a more distant school. This adds stain to the child and parent resulting in unnecessary safety concerns of putting walkers on busses, adding more busses on the roads which also increases the risk of accidents. There have been 2 accidents, that I know of, in Howard County already this year not to mention the complete mess of bussing in the beginning of the school year. Adding more children to the school only increases the bus capacity and increases safety risk.

We need to protect our children's rights to attend schools that can properly support them with their education and keep them safe. They need to feel valued and not treated like cattle in the classrooms by adding more children to fill to capacity. These children and their families deserve to be given a fair voice in these decisions which have recently destroyed neighborhoods including my own, Dorsey Hall. We have spilt up Dorsey cutting our community in half by the

last redistricting. We are on completely different schedules which affects our children's ability to play with their own neighborhood friends. This also impacts the ability of the community to provide support of one another with different schools meaning different schedules. The strain that The Board of Education has put onto our teachers and parents to maintain capacity just to pass another development to be built like the one on 108 is beyond comprehension. 108 and Columbia Rd is currently under construction which was originally planned for 50+ living but after the last redistricting the capacity numbers fell low enough that now we are seeing an approval for more family townhomes. How convenient this is for builders and contractors but at what cost to the schools who will now be pushed over capacity again. This cycle needs to stop! We can't keep shuffling children and their families to lower capacity numbers because the ones who pay the biggest cost are our next generation who are being slighted an education so as to fill some contractors pockets. Please help to keep the capacity numbers where they are because they are already to high, we can only do so much as parents as you have the power in your hands to make the change.

As the mother of a 4th grade elementary student, I know well that class size matters. Teachers cannot effectively teach when class sizes are too large. Small group instruction becomes impossible and students, whether performing below, at, or above grade level lose out on education.

GT teachers cannot be lost. At a large school such as Fulton Elementary, at least 2 GE teachers are needed to teach 2 GT math classes at the same time (both 4th and 5th grades have two FULL GT math classes that need to be taught at the same time). In addition, the CEU's are important additions to the curriculum. My daughter complains that social studies or science in her regular homeroom are boring; the CEUs help for at least part of the year.

Students in special ed or IEPs need their support systems. Every student loses out on education when these services are cut.

Please do not make these budget cuts that will certainly reduce the quality of education in HCPSS.

Dear HCPSS Board of Education;

It is with very mixed emotions – disappointment, frustration, and even anger – that I write today. Disappointment that HCPSS has decided to ask Howard County Council not for what it NEEDS to make our schools successful, but for what it thinks it can get from the County to keep the lights on and the doors open in our schools. Frustration, because you are once again considering cutting important programs like GT courses for elementary schools, music programs like 3rd grade strings, academic supports for math and reading, paraeducators, and, worst of all, considering increasing class sizes above the already high 30 students per classroom. Anger, because all of these cuts will harm, not help our students, and make Howard County a less desirable place to raise a family.

Our society likes to treat so many things like pie. Education should not be treated like pie, though you are going to be told by the Acting Superintendent and the Central Office staff that any cut not made HAS to be offset somewhere else, pitting school communities against each other as they try to save and justify funding their own programs. As another parent said in a conversation, it's very Dickensian and definitely NOT a good way to run a school system. Making the cuts I highlight below – or other cuts not noted here – are really just short term band-aids and will only make our school system, and our county, poorer in both the short-term and the long-term.

(1) Increasing class sizes is detrimental to student learning. Disappointment that HCPSS has decided to ask Howard County Council not for what it NEEDS to make our schools successful, but for what it thinks it can get from the County to keep the lights on and the doors open in our schools. Frustration, because you are once again considering cutting important programs like GT courses for elementary schools, music programs like 3rd grade strings, academic supports for math and reading, paraeducators, and, worst of all, considering increasing class sizes above the already high 30 students per classroom. Anger, because all of these cuts will harm, not help our students, and make Howard County a less desirable place to raise a family.

Our society likes to treat so many things like pie. Education should not be treated like pie, though you are going to be told by the Acting Superintendent and the Central Office staff that any cut not made HAS to be offset somewhere else, pitting school communities against each other as they try to save and justify funding their own programs. As another parent said in a conversation, it's very Dickensian and definitely NOT a good way to run a school system. Making the cuts I highlight below – or other cuts not noted here – are really just short term band-aids and will only make our school system, and our county, poorer in both the short-term and the long-term.

This year millions of dollars in cuts have been proposed that will greatly impact our school system. Howard County Public Schools have long been considered one of the country's best school systems and we need to make providing our children with a safe, world-class education a priority. It is important that class size ratios are not increased. This would be detrimental to all students and staff. I'm writing you this email as a parent of a child that want through this school system from K-12 and is now a teacher in the school system and also as an employee of HCPSS myself. This budget that is being proposed is very devastating to myself and all HCPSS staff.

On January 11, 2024, Interim Superintendent Bill Barnes announced that the school system had approached its FY25 budget development process in a very different way than previous years. Mr. Barnes mentioned the importance of asking for a "reasonable" budget as opposed to an "aspirational" one. Unfortunately, the proposed budget that was shared on January 18 is anything but reasonable. On top of the elimination of almost 350 staff positions, the proposed budget also includes an increase in class size of 1-2 students. The amount of money earmarked for staff compensation would barely cover a step and 1% cost of living adjustment for HCPSS certificated and ESP staff members.

We can barely afford to live on our salary now with the cost of living happening in the last couple of years.

For years we have been told that HCPSS cares about the mental health of its staff. How are these budget cuts showing us that they care about their employees.

The cuts just put more work load on our plates, which mean less time for our family. This also doesn't help the mental health of our students because how can teachers give their attention to each student.

These cuts don't just impact staff members - they impact our schools, our programs, and, ultimately, our students and communities.

Mr. Barnes also argued that it would be unreasonable for HCPSS to ask the county for more money than the school system received from the county last year. Why would the Board of Education do that instead of asking for the money we need to adequately fund our school system?

It's not "aspirational" or unreasonable to ask for the funding our students and staff deserve.

I'm pleading with all of you as our elected officials to work with HCPSS for a budget that actually meets the needs of our students, staff and the community to have the best school system in Maryland. The G.T. teachers do not only teach above grade level math at all elementary schools, but also provide student-interest based seminars, allowing opportunities for students to receive advanced-level instruction in research, both critical and creative thinking, engineering, and other STEAM areas.

G.T programs offer extension units, or CEUs. These units provide extensions of grade level topics for more in depth rigorous instruction of curricula, with group projects to showcase learning. This year millions of dollars in cuts have been proposed that will greatly impact our school system. I understand the county has not allocated enough money to the schools to cover the new Blueprint Mandates. It is the county's responsibility to adequately fund the schools to meet required mandates and maintain the current levels of staffing. Our county's schools need to meet the demands of the development of the county. If we want to continue to have one of the country's best school systems we need to make it a priority. I am also writing to implore you to ensure there is adequate funding. Please make sure the following cuts do not happen:

- 1. Change class size ratios. My son's kindergarten math class already has 24 5-year olds with no aides. My son got stuck on a problem and started crying. The teacher did her best, but a lot can happen with 23 other kids when she is focusing on one student. Class sizes are already too large and cannot be made any larger. This is how students get left behind.
- 2. Cut Elementary Gifted and Talented seminars and Curriculum Extension Units. A huge portion of our county population is identified as gifted and talented as soon as they start elementary school. If we don't encourage and facilitate their growth from the start, these kids will not live up to their potential. Howard county will be no different than any other county/state if we leave our gifted and talented program behind and all of the students along with it.
- 3. Cut Curricular Field Trips. My son is in kindergarten and is so excited for his trip to the library on March 20th. The library is such a great resource we want to advertise to all of our residents. We need to encourage kids to read and see what is available to all county residents. The same is true for the Robinson Nature Center. It is important our students see all of the great resources in our state. School is not only about sitting at a desk learning to read, write and do arithmetic.
- 4. Cut special education positions. Our elementary school (Triadelphia Ridge) is the home of a regional program for students with emotional disabilities. Students run around the halls and hit people on a daily basis. It is awful what these children go through and all of the other children witness daily. It is essential that there are enough special education staff members to assist these students in distress and minimize the disruptions to the entire school and maintain the safety of all students. This is a matter of student safety and ensuring students are able to learn. My son has been hit in the face by a special education student and there are reports of the entire cafeteria being evacuated due to other students. You can't take resources away from this program or there will be significant injuries regularly. Please don't put my kids at risk to get more seriously injured from these children that cannot be controlled without special education aides.
- 5. Cut the Transportation analyst There have been a lot of bus issues and I believe there are

more plans to change school start times for next year. There better be enough resources to make that process as smooth as possible for every student in the entire county. Every kid deserves public transportation to school unless they live right next door to the school.

6. Cut building and ground maintenance positions. My understanding is there is already a large backlog of work to be done on the schools. In order to maintain safe facilities, these positions must be adequately staffed to fulfill the responsibilities of all school buildings in the county again or people will be injured.

My kids are little and love school. It is your responsibility to ensure the school board has the resources necessary to ensure a safe and adequate learning environment to allow my kids to grow and learn. The teachers already do so much more than we could ever imagine. Please do not continue to ask them to do unreasonable jobs or we will lose our best assets, the loving teachers and administrators.
