I wanted to share exciting news about the North Laurel Community Pool! In the [Fiscal Year 2025 Executive Proposed Capital Budget](#), County Executive Ball included the full funding for the indoor North Laurel Community Pool at the North Laurel Community Center. The current plans include a main, 25-yard long indoor pool with eight lap lanes and ADA access, and a second, warm-water leisure pool. These funds would allow construction to start in FY25 with a completion date during FY26. This project is identified in Howard County's 2005, 2012, 2017, and 2022 Land Preservation, Parks and Recreation Plans, and is supported by many community members and organizations. However, due to budgetary constraints and other priorities, funding for the North Laurel Pool has been delayed - until now.

The County Council has begun reviewing the budget and we need your help signing and sharing this petition in support of the project: change.org/NorthLaurelPool. We would like to have **250 signatures** on the petition before the Council votes on the budget on May 22nd. If you

could help us by sharing this information out with the SCA Board and Savage residents, that would be greatly appreciated!
