To the members of the Howard County Council,

I just learned of the proposal for an indoor track in Howard County at Troy Park. Such a facility is badly needed. As both a coach and a parent, I have seen how students' opportunities to compete are limited by the lack of indoor track facilities in the state of Maryland. Right now, the indoor track at PG Sports and Learning Complex is really the only facility available to most schools. Over the last several years, the facility has been repeatedly closed for long stretches due to be used repeatedly as a Covid-vaccination site during different waves of the pandemic, and also for asbestos removal this past winter. Many teams and athletes have been forced to travel to meets in Virginia and Pennsylvania to find venues where they can compete. Many more have simply had to deal with much more limited schedules. As an example, my son is currently a junior with aspirations to get recruited for track for college. The times he runs this year will be the times college coaches will look at when considering him. He, like most other track athletes in the state, had much more limited competition schedules this year due to PG Complex being closed for the first half of the season and overbooked for the second half. The thin competition schedule meant that a whole group of runners from Maryland will be at a disadvantage in college recruiting compared to athletes in states with more venues.

I can promise you that if an indoor track facility is built, it will be used constantly. I'm not sure what the rental fee is for the PG Sports and Learning Complex and what it generates in annual revenue, but I would guess that there would be a significant return on investment for any track that is built. Another benefit is that it would provide more opportunities to younger athletes who are often squeezed out by the heavy demand for college and high school meets at the current facility. All of the area coaches talk every year about the need for additional indoor track facilities in the area. I strongly encourage you to move forward with exploring this project.

Dear Howard County Councilmembers,

I understand that there is a proposal to *finally* build an indoor track facility in Howard County at the intersection of Route 100 and Route 95! I was so excited about this news until I heard that members of the County Council aren't sure it's needed, which greatly disappoints and concerns me. I assure you it IS needed. As a female runner, having an indoor track would provide me with much needed safety during the winter season when daylight is short. As the mother of a competitive high school runner, an indoor track would also provide a safe place for young runners to train, as well as provide them the experience they need to compete with runners from other Maryland counties. Our indoor track athletes are always "out run" by athletes from other areas who have available indoor track space to train.

The Meadowridge facility is not at all adequate for indoor racing or training and certainly rarely available for recreational running. It's a lovely facility, but not suitable for running, one of the most popular activities for recreation and community-building.

Bullseye Running, the largest youth running club in Maryland, is not able to have a proper indoor running program due to lack of facilities. This is such a shame because their fall, spring and summer programs are the best.

Please, please, believe that an indoor track facility is desperately needed in a family-friendly, healthy and active community like Howard County.

It has come to my attention that Howard County is considering building an indoor track and field facility. As a competitive runner and former coach, I am writing in support of this idea. An indoor track in Howard County will significantly improve health and opportunities for children and adults in the county and in our neighbors. It will also address a major equity disparity that currently affects students from different backgrounds.

There is only one viable indoor track capable of hosting large meets that is convenient to Maryland's major population centers. That is in Prince George's County and is severely oversubscribed. This in turn limits the competitive opportunities for student-athletes of all ages in Howard County and the rest of the state.

Howard County is ideally situated between Washington, DC and Baltimore, and as such will draw large numbers of teams from both population centers. This will be beneficial to local businesses and schools.

Most importantly, an indoor track in Howard County will greatly benefit the county's ability to educate the whole child, body and mind. The lack of an indoor track in Howard County currently limits the opportunities for children to compete during the winter season, and so it is harder to retain them in the sport from cross country in the fall to outdoor track in the spring. The right facility in the right place will change all of that. Students will stay in the sport and keep the associated health and community benefits.

As a former coach myself, I have seen that students who stay in their sport perform better in school and are more likely to graduate. Students who drifted away from my team tended to also drift away from their school work.

Finally, an indoor track would support diversity in the open and masters competitive running culture in Howard County. Currently Howard County is home to a large population of older competitive distance runners. But, we fail to provide competitive opportunities to sprinters, jumpers, and throwers. This is not just a cultural disparity but also a racial one. Distance runners tend to be predominantly white, and the other event groups tend to be predominantly of color. We are failing to provide an inclusive environment and we can do better.

This disparity also affects school-age children. We are effectively telling sprinters, jumpers, and throwers *that their sport only exists from April through June*. Yes, they can travel to Prince George's County for the occasional winter meet but those meets are overcrowded. The situation is even more difficult for Maryland student-athletes who live farther north. We can make school sports in Maryland more equitable just by making this one decision here in Howard County.

We can make a difference for thousands of children each year, and we are the best positioned

to do so. I will be very glad for my tax dollars to support an indoor track and field facility in Howard County.

Re: Indoor Track Proposal

I am writing in my capacity as a resident and parent in Howard County. It has come to my attention that council members may not fully support the proposal for an indoor track facility. This memorandum is meant to offer insight into why you should consider this proposal and endeavor to proceed on both economical and practical grounds.

First, the addition of an indoor track facility can offer the county a great source of income. The facility could draw events and elite athletes to our region, which currently does not exist for many institutions. When the indoor track season is not in session, the facility could be used for other athletic endeavors, like volleyball or wrestling or indoor soccer. Such a facility has the potential to bring in millions for local businesses to support attendees at events or other uses of the facility. Likewise, our school system would save on travel time and cost to the only indoor facility in the region (Prince George's Sports and Learning Complex).

Second, as residents we are made to understand that we have one of the best school systems in the country. However, we do not support our students equally. Our athletes have varied experiences. The indoor track experience is not one that is very supported. There are no training facilities, so our athletes run on roads in rain, snow, ice, and in every temperature imaginable. The field athletes also work outside unless there is mud or freezing conditions, then they are forced into the insufficient school gym with outdated equipment and limited space. Because the entire region relies upon ONE facility to accommodate indoor track events, our athletes travel great distances, missing class and any other opportunities for learning or work or enrichment to travel two counties away for meets. This past year, our season had been almost non-existent due to updates being made at Prince George's Sports and Learning Complex.¹ The result was an abysmal season, lost opportunities, and a lack of respect for a county that doesn't support its athletes. There is no community support for these athletes, little family involvement, and the athletes feel forgotten and left out while other teams, like basketball, volleyball, and wrestling, have large audiences, support, and home school advantages.

Personally, this is my track child's first year in high school. She already felt unsupported and disconnected to the community by participating in competitive swim, a sport not supported or offered in Howard County schools, even as it is a standard sport in surrounding communities. The cost, in time, effort, and money, had been a strain, and the feeling of being disconnected caused my daughter to drop swim after 10 years as a competitor. She took up running; this led to two months of running for training and one meet, then the season was over, all due to the aforementioned limitations on a facility. Though she felt a level of despondency due to the loss of an entire season, I am sorry for the athletes hoping to obtain any times or records useful for scholarships. As it is, our athletes already suffer from a general lack of support in other seasons

(rusty hurdles, outdated scoreboards breaking down, torn up track, no outdoor facilities, etc.). We rely heavily on parental support to raise money for many issues, but the disintegration of our facilities and equipment cannot be maintained by donations. Likewise, our children already attend an outdated, overcrowded school that gets overlooked for updates while they are pushed to continue academic excellence. All of the strain on our student athletes reflects the lack of support from the county. Our indoor track athletes experience the very worst lack of support as they are left by the wayside reliant upon another county's facility, with no community or school support, and some families unable to support their track athletes. My hope is that future indoor track athletes in Howard County are able to benefit from full support from the county.

As a county, we can support the effort to offer both a community resource for event hosting with monetary benefits and a student support for athletes often left out of their school and community support networks. Therefore, I urge you to support the proposal for an indoor track facility and allow Howard County to offer opportunities to our region. Thank you for your consideration.

I have known that talk of building a indoor track facility has been going on for a while. But it has been passed over for addition of more field space. I cannot tell you how important this could be to the country. This could not only serve our kids but be a beautiful facility that puts HoCo on the map.

Like I said above the indoor track program serves thousands of kids, with each high school usually having an initial roster of over 100 boys and girls. The problem is that sharing the PG complex with every other school in the tri state area limits entries and makes it so half of our student athletes never get a chance to compete. So, every year, I have to tell around 50 kids that they could not compete or justify my kids with better times why they wouldn't be running in the next meet. Either way, a group of kids, from our own county will be left out in the cold.

I have always said that our county is in a unique position where we could develop a facility and have the opportunity to make money, while serving the community it is in. First, we have an amazing location with 95, 70, and 29 being amazing highways that could handle all of the additional traffic. Second location of facilities could be a easy on and off from most of these locations. Third, if our county put in real money to create a real-world class facility, it could become multiuse and a hub for mid-Atlantic athletics. If we go cheap, then we can only support and lure in local meets and use after the track season. If we go big and make it a world class facility then we can generate income from all over the east coast, use the facility during summer/fall for camps etc., host other large tournaments for things like field hockey, LAX, etc. The biggest large, nice, facilities positioned where we are located are VA beach and NYC. HoCo would bring an intermediate top-notch facility.
